### <u>INTENT</u>

The County of Mercer is soliciting bids for the purchase and delivery of promotional items for various using agencies. The County of Mercer shall award multiple contracts to vendors who are deemed responsive and responsible as per N.J.S.A 40:11-1 and N.J.A.C 5:34.

The award will be based on the lowest unit cost for each item. Contract shall be awarded for a period of one (1) year with an option to extend one (1) year. Vendors are only required to provide pricing for line items they can be provide to the County within specifications. #### **SPECIFICATIONS**

All items shall be provided per the specifications listed on the proposal sheet attached to this bid. You shall input your cost in excel format or provide a hand-written total using the format shown in excel and upload to Bidnet. The County of Mercer shall not be bound to minimum or maximum quantities however vendor shall ensure items requested are ready and available.

Unit price provided must include all charges, including but not limited to imprints, pre-production proof, setup charges, and any shipping or freight charges. No additional charges will be allowed after award. All colors matching must be in accordance with the 2024 Pantone Colour Matching System <a href="https://www.pantone-colours.com/">https://www.pantone-colours.com/</a>. Awarded vendors will provide items in the shade as described per the corresponding number listed in specification or provided verbal or written per request.

All bid submissions MUST include a price list and/or catalog website for items available from vendor but not listed in the proposal page. Vendors shall provide a percentage discount in event additional promotional items are required that are not listed.

All bags listed in the specifications and provided to the County of Mercer material MUST be compliant with New Jersey's Plastic Bag Ban Law. P.L.2002,c.128.


