Chair Walter announced that Garry Disciondi Jarray Control Dayyor Pr

Chair Walter announced that Gerry Ricciardi, Jersey Central Power & Light (JCP &L) Area Manager, was in attendance to address the Freeholder Board. Mr. Ricciardi gave brief statistics on the impact of the winter storms in March.

Mr. Ricciardi mentioned that JCP&L would be holding a workshop at the Dempster Center in conjunction with Bob Hartman, County Office of Emergency Management Coordinator, to discuss JCP&L restoration priorities on May 8th at 10 AM.

Mr. Ricciardi stated that he would retire in July after thirty-one (31) years with JCP&L. Chair Walter expressed that she appreciated the increased communication and accessibility he provided to the Freeholder Board.

Chair Walter announced that Anthony P. Carabelli, Jr., Acting Director of Economic Development & Sustainability, was in attendance to address the Freeholder Boards questions on the proposed Resolution authorizing to execute a Memorandum of Understanding (MOU) between the County of Mercer and various Economic Development Partners to identify Downtown Trenton Redevelopment Sites. She expressed her concerns regarding whether the dated Resolution adopted by the City of Trenton was appropriate backup being that it appeared to be disconnected to the aforementioned MOU.

Mr. Carabelli admitted that there was a delay with the aforementioned Resolution due to difficulties obtaining original signed copies of the MOU. He explained that the proposed Resolution strictly focuses on the Trenton Redevelopment sites. He added that he was unable to speak on what was included in the City of Trenton Resolution.

Freeholder Koontz expressed his concern regarding the dated Resolutions from both the City of Trenton and Mercer County Improvement Authority (MCIA). He continued that both Resolutions arrived to the State under a prior administration and to the City of Trenton with a potential former Mayor. He stated that he was hesitant to act without more information and confidence that the MOU is currently agreeable to all parties.

Chair Walter indicated that discussions of future space requirements for the County should come to the Freeholder Board before the involvement of outside agencies.

Chair Walter suggested removing the proposed Resolution authorizing to execute a MOU between the County of Mercer and Various Economic Development Partners from the Agenda. She recommended revisiting the proposed Resolution at the next set of Freeholder Meetings until they can receive answers. The Freeholder Board concurred.

COMMUNICATIONS

Six (6) communications were discussed and approved for placement on the Agenda for the Formal Meeting of April 26, 2018.

Chair Walter made reference to the Communication from the County Executive Brian M. Hughes, regarding Appointments requiring Freeholder advise and consent. She recommended pulling the Resolution appointing Amber Forrester to serve as a member of the Mercer County Park Commission. She explained that Ms. Forrester was unable to attend the meeting for an interview due to a conflict in schedule. As a result, she suggested putting the Resolution on the Agenda for the next set of Freeholder Meetings.

RESOLUTIONS

Twenty-four (24) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of April 26, 2018.

Freeholder Koontz made reference to the proposed Resolution authorizing to execute a Shared Services Agreement with Princeton for the provision of Municipal Alliance Programming for Drug and Alcohol Prevention. He mentioned that he would usually abstain on the proposed Resolution because he sits on the Corner House Foundation Board, who provides the service. He added that he would vote on the proposed Resolution if there were not enough votes to approve the proposed Resolution at the Freeholder Meeting on Thursday.

Chair Walter made reference to the proposed Resolution authorizing to execute a Professional Services Agreement with C&S Engineers, Inc., to provide program management services for the Disadvantaged Business Enterprise (DBE) Program at the Trenton-Mercer Airport. She asked why the service was not being done in-house. David J. Miller, Chief Financial Officer/Treasurer, stated that he was unsure.

Chair Walter made reference to the proposed Resolution authorizing an Award of Bid to Multiple Vendors for the repair of pumping systems, electric motors and water well inspection, repair, and drilling for the County of Mercer. She asked why two vendors were being approved for the services. Mr. Miller replied that there are often multiple vendors for the convenience of the department. Freeholder Walter asked if she could receive a year-end report of how much the County has paid each vendor of aforementioned Award of Bid.

Chair Walter made reference to the proposed Resolutions authorizing appointments to Mercer County Boards and Commissions. She commented that she has continuously asked to acquire the list of the Mercer County Boards and Commissions that have vacancies.

She explained that the event would allow children with autism to experience the airport in a positive way.
Freeholder Colavita stated that Mercer County Chapter of the Sunshine Foundation would have their annual Mercer County Dreamlift.
PUBLIC SECTION
At this time, Chair Walter invited the members of the public to comment on any item listed on and off the agenda.
Robert Britton, Jr., of Mercer Quiet Skies expressed his concerns regarding airline safety at the Trenton-Mercer Airport.

Christian Amato, Chief Operating Officer of Creative Marketing Alliance (CMA), inquired about an update for the Request for Proposal (RFP) process to manage advertisement at the Trenton-Mercer Airport.

Mr. Miller explained that the contract was voted down and that there is no current process in place to re-advertise. Freeholder Koontz expressed his concerns with not having the aforementioned service provided at the Trenton-Mercer Airport.

Chair Walter inquired about bringing the Contract back to the table for a revote to have advertisement at the Trenton-Mercer Airport.






Sikh men in Port Angeles, WA 1908

A Brief History of Sikh Americans


Sikh settlers came to America in search of jobs and farmland. Between, 1899-1915, there were about 7,000 immigrants from Punjab in America; over 85 percent of them were Sikhs. The earliest record of Sikhs arriving in America is on April 6, 1899 at Angel Island, San Francisco, California.

Many Sikhs came through Vancouver and then travelled south along the West Coast, while working in the lumber industry, railroad construction, and on farms. In California, Sikhs settled in the Sacramento and San Joaquin Valleys, because of the fertile land. Some moved further south and settled in the Imperial Valley – El Centro Valley. Initially Sikhs worked as farm hands and laborers. Later they started to lease land and tried their hand at farming as self-employed owners.

The first and oldest Gurdwara, which was built by these new immigrants and is listed on the US historical register, was established in 1912 in Stockton, California. This became the central place for all organized Sikh religious activities in America. The Gurdwara was used for all kinds of occasions; birth, marriage, death including political and social activities.

The Sikh immigrants from colonial British-India were all turban wearing Sikhs. The vast majority were hardy farmers looking to make a better life just like the immigrants from

One of the methods used by the Sikhs to fight unjust laws was to fight the system through the courts. Dr. Bhagat Singh Thind, a great Sikh-American pioneer who came to the US in 1913, fought against the bullying and bias of the local communities, the restrictive and unjust laws passed against Asian immigrants by the then State and Federal governments, using every legal means available. His monumental effort eventually paved the way for all Asian American immigrants to acquire the right to own property and to secure US citizenship after an 18 year long struggle.
