At this time, Marygrace Billek, Director of Human Services appeared before the Board to discuss the Mercer County Campaign to End Stigma. The purpose is to launch a yearlong campaign to eliminate the stigma associated with mental illness and addiction. She stated that Mercer County seeks to promote a message of hope and the belief that healing and recovery are attainable.

At this time, Dr. Jianping Wang, President of Mercer County Community College, provided the Board with update on-going events at the college. She said the James Kerney Campus is in desperate need of parking, which effects the growth of enrollment. She suggested that the County speak to the City of Trenton to dedicate open land to build a parking garage.

Freeholder Frisby asked how close should parking be to the campus.

Dr. Wang answered that parking needed to be extremely close to the campus and that research was conducted. She added that various policy and technology changes are happening and that partnerships are paying off by Mercer County students being hired by great companies.



Chair Walter stated Jeffrey Barnhart, CEO of Creative Marketing Alliance (CMA) spoke at April's meeting, with the board deciding to renew the matter.

Freeholder Koontz stated that the Administration informed the Board that no action would be taken by the Administration to pursue another vendor. He expressed concern that without a vendor present, no revenue was being generated. He noted that currently, no advertisement was at the airport.

Freeholder Verrelli indicated that he was concerned that currently no revenue was being generated. He asked if the bid process starts over. He visited the airport and screens with the flight departure and arrival time were removed.

Chair Walter noted that Mr. Barnhart shared that contracts were led beyond the time the County had extended the contracts and that problems at the airport occurred. She stated that revenue was being paid to the vendors; however vendors had no agreements with the County creating confusion with the vendors.

Paul Adezio Deputy County Counsel added that the claims were representations made by the competitors. He said that he never seen any contracts that were being discussed.

Andrew Mair County Administrator said the County made a recommendation; however, the Freeholder Board decided not to approve the Resolution and that the County could not pursue the next highest bidder.

Freeholder Koontz explained that the Resolution would not expire until the end of the year and that the Freeholder Board could bring the Resolution back for approval.

Mr. Mair stated that the contract period would start on the date the Resolution was adopted.

NEW BUSINESS:

Freeholder Koontz made references to the on-going operational and infrastructural issues at Trenton Water Works. He referred to the letter that the Freeholder Board drafted to Mayor Eric Jackson, City of Trenton regarding customers potentially replacing their water pipelines and the cost associated with replacement. He recommended that a legislative body should demand answers from Trenton Water Works.

Chair Walter and the Board concurred that a letter should be sent to the Mayor relating to issue at Trenton Water Works.

PUBLIC SECTION:

At this time, Tracey Kiriluk from Mercer Quiet Sky's voiced her concerns regarding a letter sent to residents about the replacing of water lines. Ms. Kiriluk suggested that residents should receive a free or low-cost testing kit to test for lead in the water pipes. She added that this solution would be more suitable before customers spend significant money to replace pipes.

Freeholder Frisby indicated that homeowners should be responsible for replacing pipes from the house to the curb. He noted that he replaced his water lines in his home. Freeholder Frisby suggested waiting for the municipality to replace the lead pipes. He said testing kits could be purchased at Home Depot.
