



ORDINANCE NO. 2018-7

THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF MERCER, NEW JERSEY DOES ORDAIN AS FOLLOWS:

1. The annual salary of the County Executive, County Administrator, Deputy County Administrator/Finance Director, Deputy County Administrator/ Executive Director of Parks, Warden, Human Services Director, Planning Director, Personnel Director, Economic Development and Sustainability Director, Transportation and Infrastructure Director, Mercer County Clerk, Mercer County Sheriff and Mercer County Surrogate shall be established in accordance with the following schedule:
