MINUTES

Chair Walter called the Agenda Meeting to order at 6:23 PM on August 7, 2018 in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street, Trenton, New Jersey.

ROLL CALL:

The following members of the Board answered the Roll Call of the Clerk to the Board:

SUNSHINE LAW:

In accordance with the provisions for the New Jersey Open Public Meeting Law, Notice of this Formal Meeting has been mailed to the Trentonian, The Trenton Times, The Princeton Packet newspapers as well as having been posted in the both the County Administration Building and Courthouse at least forty-eight (48) hours in Advance of the meeting.

COMMUNICATIONS:

Eight (8) communications were discussed and approved for placement on the Agenda for the Formal Meeting of August 9, 2018.

Freeholder Koontz made reference to the communication regarding the letter from the State of New Jersey, Division of Mental Health Services, to increase current service rates, expand the services that billable, and implement rates which cover the cost of providing services for the fee-for-service model and redirect funding on an annual basis into community mental health services to ensure access and quality of care of behavioral health services for residents in need of treatment. Freeholder Koontz asked if the County would prepare a companion Resolution with Cape May.

RESOLUTIONS:

Freeholder Walter made reference to the Resolution rescinding Resolution No. 238, adopted June 27, 1967, to the Lease Agreement with Johnson & Johnson, Inc., (as amended) covering premises and facilities at the Trenton- Mercer Airport. Freeholder Walter indicated that throughout the years the Lease was amended and that the new contract would reflect all the amendments in the new contract.

Freeholder Koontz referred to the Resolution authorizing to execute an agreement for the exchange of land and deed of land transfer to Princeton for block 2901, lots 1, 2 and 3; block 3001 lot 7, known as Herrontown Woods Arboretum, Princeton, New Jersey County cost \$100,000.00. Freeholder Koontz asked the administration if funding was only used for demolition and could the funds be used for something else.

The Board concurred to prepare a revised Resolution removing "demolish" from the proposed Resolution.

Andrew Mair, County Administrator, indicated that Princeton's intention is not to demolish the building.

Freeholder Koontz asked why funds are appropriated if Princeton is not going to demolish the building.

Freeholder Frisby noted that the property was gifted to the County.

Michael Herbert, Board Counsel, indicated that demolition would be necessary for the future and that Green Acres is strict with approving projects.

Mr. Mair noted that he would make the necessary changes to the Resolution before Thursday's meeting.

ORDINANCE INTRODUCTION:

AN ORDINANCE ESTABLISHING THE SALARY FOR 2018 SALARY **ORDINANCE** FOR THE COUNTY EXECUTIVE. COUNTY ADMINISTRATOR, DEPUTY COUNTY ADMINISTRATOR/ FINANCE DIRECTOR. DEPUTY COUNTY ADMINISTRATOR / **EXECUTIVE** DIRECTOR OF PARKS WARDEN, HUMAN SERVICES DIRECTOR, PLANNING **PERSONNEL** DIRECTOR, DIRECTOR. **ECONOMIC** DEVELOPMENT AND SUSTAINABILITY DIRECTOR, TRANSPORTATION AND INFRASTRUCTURE DIRECTOR, MERCER COUNTY CLERK, MERCER COUNTY SHERIFF AND MERCER COUNTY SURROGATE

Freeholder Frisby felt it was inappropriate to include the Freeholders to receive a salary increase and that he was uncomfortable with adding the Freeholders to the ordinance.

Freeholder Koontz stated that the salary ordinance should not include the Freeholders.

Freeholder Cannon said she would follow the majority of the Board; however, Freeholders in other Counties have cars, phones, and accounts and that Mercer County Freeholders are not provided with the amenities.

Freeholder Colavita said this is the fourth year the Freeholders refused to take the raises.

Chair Walter said Mercer County is fourth in the State with high raises; however, Mercer County does not receive the perks.

Freeholder Frisby added that he would probably feel comfortable with receiving the perks; he requested a list of items that Freeholders from other counties received. He wanted to compare the numbers with the number of people that other Freeholders manage.

At this time, the Freeholder Board concurred to remove the Ordinance from the agenda until further notice.

ON-GOING BUSINESS:

Chair Walter said with Census 2020 approaching it is imperative to include all senior citizens because they have a large population of 85 years and older in senior citizen facilities. She added that census information should be posted in nutrition senior sites, libraries, and other senior programs.

OLD BUSINESS:

Chair Walter said that former Freeholder Anthony Verrelli was sworn into the New Jersey State Assembly.

Chair Walter made reference to the renovations at the courthouse and that the Freeholder Board requested, through the Mercer County Improvement Authority (MCIA), that a room is reserved for the Freeholder board to hold meetings and ceremonies. She complained that a pillar went through the courtroom making it unusable to have meetings and that the Board asked for the room to remain in its original state. She added that there is another room located upstairs that the board could utilize, however, the room has to be preserved and cleaned. Freeholder Walter indicated that the MCIA has not appeared before the board regarding the issue.

Mr. Mair said he would obtain further information, however this was the first time he was hearing about the issue.

Chair Walter said she thinks the County should have a space in the courthouse that the County owns and manage, and that there should be space that represents County government. She added that the courthouse is our history and space is needed.

The Board concurred with Chair Walter comments.

Freeholder Cimino asked if the Board could designate a Freeholder to attend meetings about the issues.

Mr. Mair said he could make recommendations for a Freeholder to attend the meetings.

PUBLIC SECTION:

At this time, Chair Walter invited the members of the public to comment on any item listed on the agenda.

Mary Walker, a resident of Hamilton, spoke about the union contracts. She indicated that several county employees are working without contracts.

Mr. Mair responded that ASCME union and the County of Mercer are negotiating the contract.

Ms. Walker questioned the salary ordinance and asked how much is the percentage increase.

Chair Walter responded that the salary ordinance is a 2% increase for thirteen (13) individuals.

Anne Chmielewski, Mercer County Quiet Skys made references to the Trenton-Mercer airport, she advised the Freeholders to think creatively with upgrades for the terminal. She referred to corporations utilizing the airport and that it is essential to make sure the community is reasonable, responsible and respectable.

Caitlin Koether, a Ewing resident, spoke about veteran's services and believed that Mercer County is not providing veterans with adequate assistance. She added that homelessness is growing because the cost of living is increasing. She asked what necessary steps could the county take to help veterans efficiently.

Mr. Mair responded that Mercer County has veteran services and homes are provided to veterans. He noted that the County is working to increase community outreach to inform the public about services for veterans.

Freeholder Colavita is a board member for Social Services and stated that currently, all veterans are in permanent housing.

Chair Walter said veterans services is an ongoing concern for Mercer County.
