Public Hearing – Proposed amendment to the Mercer County Water Quality Management Plan. This amendment proposal, titled "Radvany Baseball Facilities Hamilton Township," submitted by Mr. Tony DiLodovico of Tony D Environmental Permitting, LLC on behalf of land owner James Radvany, would expand the Hamilton Township Water Pollution Control Facility sewer service area (SSA) by 56 acres to accommodate the following structures associated with a private recreational complex: a 21,600 square-foot indoor baseball training building; a 57,600 square-foot indoor baseball 'bubble;' a 1,160 square-foot concession stand; a picnic field; a 2,400 square-foot storage/maintenance building; a 900 square-foot concession building; eight little league/softball fields; two baseball fields; two multi-purpose

Staff member Andrew Lloyd presented the proposed amendment to the Board. Mr. Tony DiLodovico, principal from Tony D Environmental Permitting, LLC, spoke to the Board on behalf of the landowner, James Radvany and Hamilton Commercial Realty, LLC. Mr. Shine open the meeting to public comments and comments were received from members of the public. Mr. Shine asked if there were any comments or questions and Mr. Lloyd noted that the public comment period will remain open for 15 days and that the Board will expect to take action at their meeting on February 13, 2019. The Public Hearing was closed. A copy of the verbatim minutes of this hearing are attached and made a part of these minutes.
