



The County of Mercer shall not be responsible for any maintenance or services of the bomb detection canine response vehicle or authorized related equipment.
- 3. The Clerk to the Board shall forward one (1) original copy of this Agreement to the Township of West Windsor and one (1) original copy to the Coordinator of the Office of Emergency Management.
