PUBLIC SECTION:

Ann Chmieleski, a resident of Ewing, NJ and a member of Mercer Quiet Sky's, thanked the Board for including the community in the process while scheduling meetings.

Les Paschall, CFG Health System, LLC, thanked the Board, Administration, and Warden Charles Ellis at the Mercer County Correction Center. Mr. Paschall indicated that the Mercer County Correction Center processed 6,000 inmates and that the majority of the inmates are receiving medical and counseling services for the first time. He noted that CFG provides the full range of medical, dental, and behavioral health care services to correctional facilities.

Freeholder Cannon thanked CFG for their commitment and partnership with National Associations of Counties (NACO).

Freeholder Frisby said CFG provides vast services in mental and medical health.

Chair Walter noted that the population is becoming more mentally and medically dependent. She said teachers are dealing more with these issues than ever before, and the pipeline is pushing individuals into the correction facility.
