MINUTES

Freeholder Board Chair Cimino called the Agenda Meeting to order at 6:03 P.M. on January 8, 2019, in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street, Trenton, New Jersey.

ROLL CALL

The following members of the Board answered the Roll Call of the Clerk to the Board:

Chair Cimino led the Pledge of Allegiance and Salute to the Flag.	

SUNSHINE LAW

The Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meetings Law, notice of this Informal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

Freeholder Cannon requested a moment of silence for Michelle C. Vuocolo, who was employed by the Mercer County Board of Social Services and for Ms. Delores Baker's brother, Mr. Kenneth Kelley.

COMMUNICATIONS

Ten (10) communications were discussed and approved for placement on the Agenda for the Formal Meeting of January 10, 2019.

RESOLUTIONS

Twenty-One (21) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of January 10, 2019.

Freeholder Walter made reference to the following proposed Resolution authorizing to execute a Shared Services Agreement with the Mercer County Board of Social Services for the provision of the Safe Housing and Transportation Project.

She explained that this program allows for vendors to enter into senior citizens homes and perform basic home repairs. Freeholder Walter asked if the people providing the work are required to have background checks completed.

Mr. David Miller, Deputy County Administrator explained that these services are up to the homeowner and vendors are not subject to background checks.

Freeholder Walter commented that she would want any person performing work on behalf of the County to have background checks completed.

Freeholder Walter made reference to the following proposed Resolution authorizing a Professional Service Contract with Kronick Resolutions to represent Mercer County with Employee Disciplinary Hearings and Investigations. She mentioned that many local firms specialize in this sort of work and asked why they were not considered before a Jersey City firm.

Mr. Miller responded that Mr. Kronick has worked with the County of Mercer previously and it was a positive experience. He mentioned that Mr. Kronick was also formerly employed with the firm of Genova Burns whom the County also has had an exemplary relationship with.

Chair Cimino made reference to the following proposed Resolution authorizing the early termination of the Shared Service Agreement with the County of Union for the detention of Mercer County Juveniles at the Union County Juvenile Detention Center.

He asked the Administration if they were working with any other counties to house Mercer County juveniles.

Mr. Miller responded that Burlington County and Union County were alternate County facilities used to house juveniles. He added that the State of New Jersey requires two Counties and that presently the Administration was in discussion with Ocean County since Union County was no longer a viable option.

Freeholder Walter made reference to the proposed Resolution authorizing to execute a Professional Services Agreement with C & S Engineers, Inc., to provide additional consulting services and conduct an Environmental Assessment at the Trenton-Mercer Airport. She was concerned with the increased amount of funding for the contract.

Freeholder Walter felt that the Freeholders' original concerns were not heard by C & S Engineers and because of this the County should not be responsible for the additional costs.

Chair Cimino suggested additional information be provided to the Board for the additional expenditures and requested an itemized list of all components. He also questioned if C & S Engineers have offices located in New Jersey and if the County has to pay for any travel expenses.

Mr. Miller responded that he would forward that information to the Board at a later date.

OLD BUSINESS

Freeholder Koontz mentioned that a few years ago a group of Hightstown High School students attended a Freeholder Meeting to discuss a bill that regarded unsolved civil rights cases from the 1950s and 1960s. He informed the Board that the bill was introduced and subsequently passed into law on January 8th, 2019. Freeholder Koontz was extremely proud of the students who made this bill happen and applauded them for all of their hard work.

ON-GOING BUSINESS

Freeholder Walter discussed the upcoming census and asked if Administration had any plans to do campaign billboards encouraging residents to complete the census forms. She stated that investing in the census will have greater payoff in the long run.

Chair Cimino asked if the Freeholders could do something collectively to help spread the word.

Mr. Miller stated that he would ask Mr. Mair, County Administrator, for further instruction on the matter.

Chair Cimino asked if the County had any plans for the billboard located on the New Jersey Turnpike. He said the billboard would be a great way to advertise different things pertaining to County business.

Mr. Paul Adezio, Esq., County Counsel, responded that there were significant issues raised by the Department of Transportation to raise the current height of the billboard over the sound barrier.

He explained that there are on-going discussions with the Robbinsville Board of Education and so he did not have any definitive answers.

PUBLIC SECTION

At this time, Chair Cimino invited the members of the public to comment on any item listed on the Agenda.

Ms. Ellen Coyote, a Hamilton resident, addressed the Board. She discussed the ongoing issues with deer hunting throughout Mercer County Park. Ms. Coyote expressed her concerns of public safety and killing wildlife. She attended meetings at the Park Commission and was looking for further direction.

Chair Cimino explained that the Executive Director of the Park Commission was Aaron T. Watson and he would be more informed to answer her concerns regarding the deer hunt.

Freeholder Walter explained that the hunt is setup with the public's safety first and foremost. She stated that the hunters are located in treetop stands and can oversee the deer from above. Freeholder Walter added that the deer are an on-going issue to residents and they have got to be eradicated.

Ms. Coyote thanked the Freeholder Board for their time.
