### **MARIJUANA USE & EDUCATIONAL OUTCOMES**





### **COLORADO & WASHINGTON STATE SINCE LEGALIZATION**

In the wake of multimillion-dollar political campaigns funded with out-of-state money, Colorado and Washington voted to legalize marijuana in November 2012. Though it would take more than a year to set up retail stores, personal use (in Colorado and Washington), and home cultivation/giving away of up to six plants (in Colorado) were almost immediately legalized after the vote.

Public marijuana use, though illegal, remains a common way to celebrate the law. Also, a brand-new marijuana industry selling candies, waxes, sodas, and other marijuana items has exploded, and with it a lobby to fight regulation.


These "experiments" in legalization and commercialization, have not succeeded. Perhaps unsurprisingly, Colorado now leads the country in past-month marijuana use by youth, with Washington in 6th place. Other states that have since legalized marijuana occupy 4th place (District of Columbia) and 5th place (Oregon). States with "medical marijuana" laws occupy 2nd and 3rd place (Vermont and Rhode Island, respectively). Additionally, as explained in greater detail below, the laws have had

serious, negative impacts on public health and safety.


The federal government, through the Department of Justice (DOJ), announced it would initially take a hands-off approach, promising to track the consequences of legalization, from youth marijuana use to use on public lands, and determine action later. So far, however, neither the federal nor state authorities have implemented a robust public tracking system. This failure led the U.S. Government Accountability Office (GAO) to criticize DOJ in 2016 for not appropriately monitoring and documenting outcomes.

Past-year and past-month marijuana use by all age groups exceeds the national average in both Washington State and Colorado. Marijuana use in both states has risen significantly\* in many categories.




### MARIJUANA-RELATED DUI CASES HAVE SPIKED IN BOTH COLORADO & WASHINGTON AFTER LEGALIZATION

### Percentage of total DUI/DUID citations related to marijuana in CO




### Percentage of total traffic fatalities where the driver tested positive for THC in CO

### Percentage of total DUI/DRE cases tested positive for THC\* in WA







Poisonings related to marijuana have surged in both Colorado and Washington since both states legalized marijuana in 2012.



Teen admissions to treatment for marijuana use at the Arapahoe House treatment network in CO increased by 66% between 2011 and 2014.



### COLORADO MARIJUANA IS REGULARLY DIVERTED TO OTHER STATES

### IS THE MARIJUANA INDUSTRY TARGETING LOW-**INCOME, MINORITY COMMUNITIES?**

A 2016 investigation by the Denver Post revealed that a "disproportionate share" of marijuana businesses are now located in lower-income and minority communities in Denver, communities that often suffer disparate impacts of drug use.

This is similar to a Johns Hopkins study that showed that predominantly black, low-income neighborhoods in Baltimore were eight times more likely to have carry-out liquor stores than white or racially integrated neighborhoods.

One of Denver's lower-income neighborhoods has one marijuana business for every 47 residents.

### A THRIVING BLACK MARKET IN COLORADO

In February 2015, Colorado Attorney General Cynthia Coffman told reporters:

"The criminals are still selling on the black market. ... We have plenty of cartel activity in Colorado (and) plenty of illegal activity that has not decreased at all."

Lt. Mark Comte of the Colorado Springs Police Vice and Narcotics Unit similarly commented that "[legalization] has done nothing more than enhance the opportunity for the black market." Indeed, a federal law enforcement official characterized Colorado as "the black market for the rest of the country."

### **DENVER CITY AND COUNTY CRIME IS UP**

In the city and county of Denver, overall crime was up 4.1% in 2015, compared to the prior year. Most saliently, drug and narcotics crime rose 12.5%, belying rampant media reports of "legalization linked with a drop in crime."



The political campaigns to legalize marijuana do not mention these branded marijuana products, candies, or advertising practices.



marijuana.




### Billions of U.S. dollars (indexed to 2012 values)

Currently there is no information indicating hat anyone would intentionally give out marijuana

plants. This oil is added to the candies during production. Marijuana chocolate is made by mixing marijuana oil with melted chocolate. Some marijuana products have different levels of THC, Marijuana candy is made with oil from marijuana and the levels of products sold on the black market may be unknown.

There has been an increase in the variety of edible marijuana products available, including candy. The higher levels of THC in these products presents increased risk if ingested by children.

### **MINUTES**

Freeholder Board Chair Cannon called the Agenda Meeting to order at 6:01 P.M. on March 22, 2016, in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street, Trenton, New Jersey.

### ROLL CALL

The following members of the Board answered the Roll Call of the Deputy Clerk to the Board:

### **SUNSHINE LAW**

The Deputy Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meetings Law, notice of this Informal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

Chair Cannon informed the Board that Ms. Milly K. Brown was scheduled to present a Black History Month Presentation but was unable to attend tonight's meeting.

Freeholder Colavita requested a moment of silence for the victims of the recent bombings that occurred in Belgium.

At this time, Chair Cannon invited the members of the public to comment on any item listed on the Agenda.

### **COMMUNICATIONS**

Six (6) communications were discussed and approved for placement on the Agenda for the Formal Meeting of March 24, 2016.

### **RESOLUTIONS**

Twenty-eight (28) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of March 24, 2016.

Freeholder Walter made reference to the proposed Resolution regarding her appointment to serve as a member of the Mercer County Vo-Tech Board of School Estimate. Freeholder Walter explained that due to a conflict, the only Board she is able and willing to serve on is the Mercer County Community College Board of School Estimate.

Freeholder Frisby made reference to the proposed Resolution regarding a Professional Services Agreement with Loomacres Wildlife Management, Inc., to provide Wildlife Hazard Management and Training for the implementation of an integrated Wildlife Hazard Management Plan for the Trenton-Mercer Airport. He asked if the County is involved in any other wildlife management programs.

Andrew Mair, County Administrator, stated the Park Commission also is involved with Wildlife Hazard Management and Training.

Freeholder Frisby explained that he has received several complaints from residents of Lawrenceville regarding the presence of coyotes.

Michael Herbert, Esq., Board Counsel, explained this matter may be better handled by the local animal control shelters.

Freeholder Walter made reference to the proposed Resolution authorizing to execute a Professional Services Agreement with Urban Engineers, Inc., to provide Consulting Services for the Development of an Airport Master Plan Update at the Trenton-Mercer Airport. She explained the language needed to be revised because she wanted to know what the miscellaneous services were.

Freeholder Cimino stated that it was his understanding that the contract was only requesting an extension of the actual contract and no funding would be involved.

Freeholder Walter discussed her concerns regarding the relocation of taxiways at the Trenton-Mercer Airport.

Mr. Mair assured her this particular contract only dealt with an extension of time.

Chair Cannon asked the Administration for an update on the Airport Master Plan.

The Freeholder Board concurred and requested any further information on this matter be provided to the Board for review.

### OLD BUSINESS

Freeholder Walter attended the Philadelphia Flower Show. She said she was very excited to see a very large display of flowers created by students who attend Mercer County Community College (MCCC). Freeholder Walter learned that MCCC was a recipient of the silver medal and placed very highly. Freeholder Walter stated the flower show was done exceptionally well and encouraged her colleagues to attend.

Freeholder Cimino asked the Administration for clarification regarding the recent employment issue that took place concerning the hiring process of a prospective employee at the Mercer County Special Services School District.

Arthur Sypek, Esq., County Counsel, explained that the Mercer County Special Services School District is a semi-autonomous board and the Administration rarely has any discussions regarding personnel matters. He informed the Board that he did not have any information regarding this matter.

Freeholder Cimino stated that the Freeholder Board should be aware of situations such as this before they are released in the press.

County Administrator Mair stated the Administration does not normally get involved in the Mercer County Special Services School District's personnel matters.

Freeholder Cimino was extremely concerned about the way the situation was handled and felt the Board should have had clarification on the issues that occurred throughout the hiring process.

### **PUBLIC SECTION**

At this time, Chair Cannon invited the members of the public to comment on any item listed on the agenda.

Jason Nordgren, a Hamilton Township resident spoke about the issues regarding the possible closure of the Mercer County Correction Center and the recent press regarding the hiring process of State Senator Shirley Turner at the Mercer County Special Services School District. He also suggested the Mercer County website become more user friendly and provide meeting minutes online.

Sherry Petrosky, a Hamilton Township resident spoke about her concerns regarding the Mercer County Community College Nursing Program. She provided the Board with her issues with documentation. (See Schedule A, attached hereto, and made a part thereof)

Marvin Gibson, City of Trenton resident, spoke about his concerns regarding the possible closure of the Mercer County Correction Center.

Dear Ms. Petrosky;

Assistant Vice President Susan Zambrio and I have reviewed the documents that you sent to us and the documents available to us on campus concerning your grade appeal for Nursing 230. What we found was that your grade appeal for Nursing 230 was rejected by Dean Scherr, and was then forwarded to the Academic Integrity Committee Chair, Prof. Ken Howarth. Prof. Howarth informed us that , in line with long-standing practice, the AIC did not formally take up your appeal because you had retained an attorney to accompany you; he directed you to the HR office. After having been informed by Vice President Chang that you no longer were working with an attorney, Prof. Howarth says that he contacted both you and your attorney to confirm the new situation, but that you never responded. Thus, the issue was not taken up by the AIC.

You also did not earn a qualifying grade in Nursing 231, and thus were not allowed to enroll in Nursing 240. You did not appeal Nursing 231 to either the Dean or the AIC; thus, I have no way of acting on that grade.

Much of the documentation that you have provided in support of your appeal is based on alleged misconduct by faculty and staff at MCCC. At this point, I cannot judge whether or not the alleged misconduct occurred because I am still familiarizing myself with the contractual steps and the policies and procedures, surrounding such complaints. While they may be connected to grading issues, obviously they must be proven before any connection to the grades can be made.

In the meantime, the Nursing Director has assured me that you can return to the program in Fall, 2016, to retake Nursing 230 and 231, and enroll in Nursing 240; as I understand it, those are the last three classes you must pass to complete the requirements for the Nursing degree.

My office will continue to investigate your complaints against faculty members and respond to you when that process is complete; our target date is May 1.

Polite, intelligent ded

Since several students and I spoke in front of this board on January 14, the harassment and discrimination has gotten so much worse than anyone expected it could. The main difference is now, my family and I have become the main targets. Starting just 1 hour and 14 minutes after the Trentonian news article was released online that same night, inappropriate and demeaning comments having nothing to do with the issues with the nursing program were posted in the comments section of the online article. Interestingly, the specific details contained within these comments could ONLY be found in documents placed in my husband's HR file in 2009 at MCCC which was just recently looked into by his boss, Dean Linda Scherr. Alerting me to these online comments just 25 minutes after they were posted was Christopher Giles, a 3<sup>rd</sup> semester nursing student and co-worker and avid supporter of Prof. Lori Kelty. The defamatory nature of these comments made public was so detrimental to me and my husband that they had to be removed immediately but not before I retained a copy for my records. Sadly, the retribution did not stop there.

In addition to Dean Scherr releasing private health information to Prof. Ken Howarth, Chairperson of the Academic Integrity Committee without my permission on November 11, 2015, he, in turn, forwarded it to VP Chang and President Wang the next day, again without authorization to do so. Not only is this unlawful and STILL has not been addressed to this day, but because of Dean Scherr's horrendous mistake, I was unable to move forward in the college's grade appeal process. Since being thrice denied authorization to forward my packet to the AIC (the next step in the process) due to it's sensitive and confidential content, she knowingly did it anyway. When I questioned her about it multiple times, she finally replied, "What do you want me to do, rescind it?" Now, all of the committee members and the vice president (who is the next and last step in the grade appeal process) were tainted with an inaccurate depiction of me thus potentially affecting their decisions for any of my grade appeals. Consequently, it did as was evidenced by Professor Sandra Kerr, AIC member, alerting Prof. Howarth of my presence as a witness to Kristina's AIC hearing at noon on February 2 and then Prof. Howarth discussing my personal grade appeal and screaming at me in the middle of the LA building hallway while students and faculty walked by. Kristina was finally told that she could have ANY other student EXCEPT ME there. So, Dean Scherr effectively took me out of the game for good and, along with several others at the college, has deprived me of any recourse for my grade appeal or other concerns.

As you know, ten students and I met with President Wang on December 7, 2015 where I gave her 247 pages detailing the problems within the nursing program from the past two years. During the meeting, she asked us repeatedly not to go to the board of trustee meeting scheduled 3 days from then but instead to "give her time" to address our concerns. To date, she has not addressed a single one of them. She has, however, taken my findings to "patch up the holes" in the nursing program by creating stricter policies and procedures for the students to follow and happily adopted my suggestions for improvement as her own, titled, "Spring 2016 Nursing Program Improvement Plan" which includes a fairer grading structure incorporating the mandatory reflective journals and classroom presentation as part of the course grade. With this grading requirement, Kristina, Carmen and I would have passed the course. If you ask me, I should have not only had my issues addressed immediately but have been paid a consultant's fee for providing her with such extensive and detailed documentation and making her job easier. Instead, on December 18, this politically-driven President exposed me to the very same people she asked me and other students to report to her about.

I have been to three board meetings at the college since coming here and nothing has been resolved. The board pushes me back onto the President who falsely testifies that I never responded to the Vice President who is no longer at the college to dispute such a claim. And around and around we go. All parties sitting around that, and this, great orthogonal table have copies of the email responses I provided Vice President Chang last November so that obviously is not the case. In fact, I have been able to disprove every deceitful remark uttered by anyone at the college. But, it's not that, is it? No, no it isn't. This is not your run-of-the-mill "disgruntled student" (as President Wang said during the Nursing Program Graduation on January 12) that they are used to dealing with. Nursing faculty have that play down pat. They have been running it for years and that is why the nursing program is in such a state of disrepair. This is the big leagues now. This student is not simply asking what you can do for her but what you can do for all students and they don't know how to handle that because that would mean they would actually have to CHANGE their

behavior and start treating people with respect; that they would have to stop using fear as a means to control students. The President made a statement by exposing the students to their tormentors and the nursing faculty received it loud and clear and have become emboldened by it.

12/14/15 I receive a call from a classmate, Lauren H., telling me that Prof. Kelty and Prof. Lisa Dunn were discussing Kristina's appeal and saying that I had a petition out to get them fired (recorded)

12/17/15 I meet with Dean Scherr and Director Donna Penn (who was brought in unexpectedly) for over 2 ½ hours on my birthday to discuss my email of 12/2 titled NRS 231 appeal and as a follow-up of the mtg with Dean Scherr on 12/8/15. Dean Scherr was to provide me with her response to my appeal as she stated on the 8th (recorded) but she did not. Dean Scherr and Prof. Penn used my time only to gather information from me. I mentioned how upset I was over Prof. Penn telling us in lab that students were "bashing their teachers" in the curriculum meetings. It was at this time that Prof. Penn admitted that she changed the Student Representative Guidelines for Curriculum Meetings in October 2014 after I presented the students' concerns because she thought "my tone" was negative and she "wanted to keep the meetings proactive" for her staff. I responded by telling her that I was only doing what was within the guidelines and that I was really scared to bring those things up so I had no idea I was being perceived that way. I went on to state that I wish she would have said something to me then all of this could have been avoided. She replied, "I thought I did." (recorded)

1/19/16 I found a revised grading policy updated by Prof. Lori Kelty in April 2014 and approved by Prof. Penn (which was not only mid-semester but mid-academic year). This revised policy took the passing grade from 76% to 77%. Why is April 2014 important? Because that is when approx. 20 students in our class had the first open forum session with Prof. Penn about the issues with the Nursing Program. Coincidence? Interestingly, this change was not made public until Spring of 2015, a whole year later, and well after the ACEN site visit in October of 2014. You can refer to pages 13 and 23 of the copy of the Spring 2015 Nursing Program Handbook I emailed to you where it states that starting in the Fall of 2015, our last and most difficult semester (ironically with Prof. Kelty) the passing grade will be 77%. Many of us refused to sign the acknowledgement of receipt but were told if we didn't we could not sit for any exams.

1/26/16 Kristina receives "Approved Academic Integrity Committee Procedures." The revised procedures included a new 6-week limit on filing a grade appeal. The deadline for filing a Fall 2015 grade appeal? January 26! So, I could no longer file an appeal even if that were an option for me. I also checked the properties of the document. It stated that Kenneth Howarth was the author and that he created the document on 1/21/16 at 7pm, except (come to find out) it NEVER went through the amendment process to be approved by the Board of Trustees.

2/2/16 As soon as Kristina and I show up for her pre-hearing meeting with the Student Advocate, Prof. Cynthia Matyas and Prof. Ratliff, Prof. Matyas leaps from her chair and bursts into the hallway of the MS building. I say hello to her and she responds, "What are you doing here?" (recorded) She adamantly refused to have me be a part of the meeting and tried to have me removed as witness to the hearing along with Dean Scherr until Kristina spoke up and stated that in the policy it says she is allowed to have a witness. Some advocate, huh?

2/5/16 My Facebook profile picture of my 8-year-old son holding a 4.0 High Honor Roll Award on stage at a Christian school is reported for 'nudity.'

2/13/16 My son's picture is reported for 'nudity' again.

2/15/16 Kristina's appeal is denied.

2/18/16 Kristina and I go to another board meeting. I speak out again. Kristina is approached by Pres. Wang who tells her to contact Ms. Susan Zambrio. At the same time, Ms. Zambrio approached me for a copy of any documentation I had and told me that the new Interim VP was starting the next day.

2/25/16 Security is noted standing outside of Prof. Dunn's office again.

3/1/16 I receive several phone calls from a student telling me that she met with Prof. Lori Kelty for a scheduled meeting at 8:30am but instead of discussing "NRS 231," Prof. Kelty told her that she was "very upset" and felt "personally attacked" by "Petrosky." This student said for over 30 minutes, Prof. Kelty continued to discuss how "offended" she was by me as she held in her hand posts from my Facebook, talked about quitting her job and "cried so hard that she went through at least 3 tissues." This, to me, describes a very unstable individual and, quite frankly, scares me.

Later that same day, my husband receives a confidentiality agreement which he must sign.

3/4/16 My son's picture is reported for 'nudity' yet again. This time, they also attack my husband's profile picture of him and my son. See a pattern here?

3/8/16 Since Pres. Wang insisted that I did not respond to Dr. Chang, Ms. Zambrio requested information and the increasing amount of cyber-bullying and terrifying way in which the student described Prof. Kelty's behavior, I emailed Ms. Zambrio and Interim VP Richard Fulton with all of this. I sent it in 4 emails and it included voice recordings. I finally received confirmation of receipt 3 days later. That same day, I also spoke with another classmate currently retaking NRS 231. She told me that in clinical on Sunday, the 6th, many students were discussing my situation at school and my son's adoptive status. She also told me that "sometime last week" Kristina was granted her appeal and is starting her preceptorship in April but is not allowed to talk about it. With permission, I viewed Kristina's unofficial transcript because, lo' and behold, her access to NRS 231 in Blackboard has mysteriously vanished. NRS 230 is still there, though. On her transcript under NRS 231, it says C+. Kristina passed!! How did she do it. I wonder?

3/10/16 Kristina's grade is changed from a C+ back to a C. Is it a passing C or a failing C? Why would they do that??

3/17/16 I receive a response from Dr. Fulton stating that I can retake NRS 230 and 231 in the Fall of 2016 and that his office is "looking into" my concerns and will get back to me by "May 1." I tell you that I am frightened by what these people are doing to me and my family and you respond by saying I'll let you know by May 1st? Am I missing something here?

You know, I shudder to think what would happen before SOMEBODY will actually stop and take notice of what is truly happening here. I have not ONE advocate in the entire college, not one. Is what I have done SO bad that I deserve to be treated like this? Harassed over and over, my husband, a dedicated MCCC employee for over 23 years shunned EVERY SINGLE DAY and my son watching his two loving parents try to deal with all of it.

Do you think that this has only happened to me? Chairperson Frisby even said during the January meeting that he's heard this before. These are not isolated incidents. My 247-page dossier alone underscores that this is not a singular incident perpetrated upon one student but ALL students. I have become the cautionary tale at school to instill fear as the new method of control in the classroom. Don't be like Petrosky...Students aren't toys to be played with and manipulated to satisfy your own egotistical agenda.

A wise man by the name of Mahatma Gandhi, you may have heard of him, once said, "Even if you are a minority of one, the truth is the truth."
