She continued that the State of New Jersey has undertaken the design and construction with federal funds. She concluded that due to the monies coming from the federal government, the State was involved with the design and construction of the bridge.

Freeholder Frisby expressed his concern regarding the County's lack of influence in the design and construction of the bridge.

Freeholder Walter suggested having a State representative attend a meeting to expound on the project.

Freeholder Cimino asked if the County were given the initial opportunity to accept the federal funds to take control of the project.

Freeholder Walter expressed her concerns regarding the safety hazards that would become the County's problem, when the bridge was completed. She asked if there would be a vote from the Freeholder Board to accept the project. Ms. Nazzaro stated that she would get more information.

Freeholder Walter asked what would happen if the Board decided to vote that they were not in favor of the project. Ms. Nazzaro commented that she would follow up and get clarification on the matter.

<u>State of the County Address</u> <u>Mercer County Executive Brian M. Hughes, Thursday, Jan. 23, 2020</u>

Freeholder Chair Andrew Koontz and members of the Board, I am pleased to deliver to you the 2020 State of the County.

I am also pleased to report that the state of our Great County is strong and healthy as we begin a new year, a new decade, and a new term for this administration.

I thank everyone for being here tonight. I would especially like to thank my Chief of Staff, Kelly Ganges, who has been with me every step of the way.

I am eager to finish projects we have begun, and to identify new initiatives that provide the best government to our constituents in the most cost-effective manner possible.

One of the most significant projects under way is the replacement of our passenger terminal at Trenton-Mercer Airport with a much-needed modern facility. The Environmental Assessment for the proposed new terminal – which is being done at the direction of, and in full compliance with, the Federal Aviation Administration – is still under review by the FAA. We believe we have met their requirements thus far, and their response is overdue. I am eager to see this project move forward, but until we hear from the FAA, we are in a holding pattern.

Enhancing our airport to meet the needs of today's travelers strengthens the regional economy and overall transportation network, which are part of Mercer's appeal as a desirable place to live and work. First-rate educational opportunities, exciting cultural offerings and a vibrant business community are other key ingredients that help produce a high quality of life in our Capital County.

A second ongoing project is the consolidation plan for our Correction Center. The plan that was approved by this board last October will save Mercer taxpayers \$12 million while preserving the job of every single officer. My administration, along with this board, worked extremely hard to satisfy the needs of each and every stakeholder. We stand by our commitment to bring this plan to fruition.

This administration has kept a commitment to excellence in all areas of County government, from economic development to human services to transportation & infrastructure and more. But two areas I would like to focus on tonight that are vital to our well-being and personal growth are open space and recreation, which we have always prioritized and have worked hard to provide.

I am proud of the fact that we have been involved in preserving more than 6,300 acres since I became County Executive. Freeholders, you have before you tonight, a resolution to purchase the development rights of almost 400 acres – Kerr Farm – one of the largest farm parcels available to us. In 2019, our Planning Department provided grants resulting in four new preserved properties in Hamilton and Hopewell Township. For 2020, the

Open Space Board has approved grants for six more properties in our towns of Hopewell, Princeton, Robbinsville and East Windsor. All told, more than 20 percent of land in Mercer County is forever preserved.

When it comes to recreation, we want there to be a wide variety of options so there is something for everyone in every segment of our communities.

Since 2006, our Mercer at Play program has resulted in more than 30 recreational projects across every one of our towns by using County capital funds matched by outside contributions. Some towns have completed projects under Mercer at Play 2, and in 2019 the Freeholder Board approved grant agreements for recreation projects in Ewing, Lawrence, Princeton, Trenton, and West Windsor, plus a joint effort by East Windsor and Hightstown. From a monetary standpoint, the return on our investment in Mercer at Play has been good. From a quality-of-life standpoint, I believe the return on our investment will be much greater.

We have continued to build and upgrade recreational facilities in our excellent park system. Among the many new offerings this past year were an award-winning bike-share program; overnight camping at Mercer County Park; and a trail-riding program that provides a low-cost first exposure to horses and horseback riding.

Looking ahead, the Park Commission is developing a new passive recreation park at the junction of Hamilton, Robbinsville, and West Windsor. The draft Master Plan calls for the creation of 64 acres of native meadows and 34 acres of reforested land within the 279-acre property.

We are excited about a potential future park facility that is a little farther off. Anyone who has encountered the dump trucks on Route 29 is aware of the Moores Station Quarry site at Pleasantville Road in Hopewell Township, adjacent to the Baldpate Mountain Preserve.

In anticipation of its future management of the site, when the current lease to Trap Rock Industries concludes in 2023, the Park Commission and County Planning Department are beginning a process to retain a qualified landscape architect consultant to aid in developing a Master Plan for the site. The Master Plan would identify potential options for the restoration and redevelopment of the property as a park, while considering the site's engineering constraints, sensitive environmental areas, township regulations, and the County's goals and budget. It is the County's goal to eventually integrate the quarry property into our Baldpate Mountain Management Plan. This is a project you will be hearing more about as it progresses.

As important as it is to preserve open space and create recreational amenities for the enjoyment of our residents and visitors, it is just as important that we protect those investments by being good stewards of our land.

Stewardship of county-owned properties is an ongoing cooperative effort of the Park Commission and Planning Department. Here are just a few examples of that effort from the past year:

- The stewardship team partnered with Ewing Township to complete two
 environmentally friendly lawn-to-meadow conversions in 2019, one at the Ewing
 Senior and Community Center and the other at Village on the Green, a
 neighborhood in Ewing.
- The County completed two projects on open space properties in the Crosswicks Creek area, as well as one lawn-to-meadow conversion at Roebling Park in Hamilton. These projects restored 13 acres of County land into habitat for native wildlife.
- A total of 4,200 native trees and shrubs were planted as part of two riparian restoration projects in Hopewell Township. Once established, these plantings will reduce erosion, mitigate flooding, filter contaminants from water, and supply food for native wildlife and pollinators.
- The first urban pollinator pocket -- with hundreds of grasses, flowers and ferns -was installed in South Riverwalk Park, as part of the first Trenton River Days Fair.

And I would like to point out that stewardship is a communitywide endeavor: A total of 2,756 volunteer hours were dedicated to stewardship efforts in 2019. Thank you to the many citizens and community groups that have taken part.

On a different topic, I want to reiterate that I recognize the need to have secure and reliable voting machines that have a voter-verified paper trail. This continues to be a top priority for this administration, and with the Freeholder Board's support, we will make the necessary investment to have new machines in place as soon as possible.

One more thing I want to emphasize tonight is the importance of participating in the upcoming 2020 census. The census helps determine the amount of federal funding our County receives and helps us plan for the future. Obtaining a complete and accurate count is crucial.

We have been working for the past year to engage our communities in the Census, so our constituents are prepared to respond. Complete Count Committees have been set up, and we recently received a \$164,000 state grant to help us reach hard-to-count populations such as non-native English speakers, homeless persons, college students, veterans, and others.

The impact of the Census is enormous. It is incumbent upon all of us to help spread the word.

Thank you for your time tonight. I am proud to be County Executive of the Greatest County. I look forward to working with this board to continue moving this County forward and improving the quality of life for our residents and visitors. Thank you.

INFORMAL MEETING OF JANUARY 21, 2020

MINUTES

Chair Koontz called the Agenda Meeting to order at 6:06 P.M. on January 21, 2020 in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street, Trenton, New Jersey.

ROLL CALL

The following members of the Board answered the Roll Call of the Deputy Clerk to the Board:

Absent – Freeholders Cannon, Cimino, Frisby, Melker, Walter and Koontz Absent – Freeholder Colavita
Chair Koontz led the Pledge of Allegiance and Salute to the Flag.

SUNSHINE LAW

The Deputy Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meetings Law, notice of this Informal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

PRESENTATION

At this time, Chair Koontz announced that Zechen (Peter) Wei, a senior at Princeton International School of Mathematics and Science, was in attendance to receive recognition for breaking the Guinness World Record for the fastest quadcopter ascent to 100 meters, with a record time of 2.732 seconds. The Freeholder Board congratulated him and presented him with a certificate of recognition.

Chair Koontz announced that Sergeant Jeremy Stewart from the Mercer County Sheriff Office was in attendance to discuss the purpose of the Extraordinary Unspecifiable Service (E.U.S) Contract with Tomahawk Strategic Solutions. Sgt. Stewart explained that the Contract would address the concerns regarding de-escalation tactics that was expressed during the procurement process for the armored vehicle. He added that the entire team would attend the training course.

Chair Koontz asked if other companies provide similar services. Sgt. Stewart described that other companies provide a host of tactical services, but he has not seen a company that had the philosophy and experience of Tomahawk Strategic Solutions.

Freeholder Cimino thanked Sgt. Stewart for listening to the Freeholder Board's previous concerns regarding the armored vehicle.

Freeholder Walter asked how many times the armored vehicle was utilized. Sgt. Stewart answered that the vehicle was utilized twice, once in Princeton and another in Ewing Township. Freeholder Walter asked if he felt the utilization of the vehicle were appropriate for the two instances. Sgt. Stewart agreed that having the vehicle on scene was entirely appropriate and expressed that trying to accomplish the jobs without the vehicle would have put them at a significant disadvantage.

Chair Koontz thanked Sgt. Stewart for attending the meeting to explain the details of the Contract.

COMMUNICATIONS

Five (5) communications were discussed and approved for placement on the Agenda for the Formal Meeting of January 23, 2020.

Freeholder Walter made reference to the Communication from the Purchasing Department, regarding the Minutes and Bid Results for the Week of December 30, 2019. She expressed her concern about the wide range of bid responses in terms of cost. She asked to have clarification as to why the wide range occurred.

Freeholder Frisby made reference to the Communication from the Mayor W. Reed Gusciora, City of Trenton, regarding the Assunpink Creek Daylighting Project. He expressed his concerns about how the original rendering looked nothing like what was currently there and what was being proposed. He added that no one would be able to utilize the current space because of the way it was developed and designed. He suggested that there needs to be communicate with the Department of Transportation regarding the end product and what was expected for the City of Trenton with this particular project.

Chair Koontz stated that he believed there would be a Resolution to come before the Freeholder Board at some point for approval.

Paul Adezio, County Counsel suggested that the aforementioned communication be shared with the Mercer County Department of Transportation.

Chair Koontz made reference to the Communication from Brian M. Hughes, County Executive, regarding the Executive Order 13888 "On Enhancing State and Local Involvement in Resettlement". He thanked the Administration for drafting the letter, which represented the proposed Resolution on the Agenda. He asked to adopt language into the Resolution that illustrates the support of the County Executive.

RESOLUTIONS

Forty (40) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of January 23, 2020.

Freeholder Walter made reference to the proposed Resolution authorizing the County of Mercer 2020 Temporary Budget Additional Appropriations. She asked for an update on the Temporary Budget. David J. Miller, Chief Financial Officer/Treasurer expressed that the Temporary Budget represented up to 50% of salary and wages of last year and it would move all contracted services and utilities to 100% of last year. He added that it would also put the money in the budget for the flags for the Veterans Center.

Freeholder Walter made reference to the proposed Resolution authorizing to submit a Grant Application with the New Jersey Department of Transportation (NJDOT) to reconstruct Taxiway F (Construct) and Reconstruct Taxiway F Lighting (Construct) Project at the Trenton-Mercer Airport. She highlighted that the project was part of a 4-million-dollar project and that there were various projects that come before the Freeholder Board almost every set of meetings. She asked why the County was not bundling projects to hit the 5-million-dollar threshold to qualify for a Project Labor Agreement.

Chair Koontz emphasized that the County seemed to be responding to a grant application, where the grantee is setting the specifics as to what they would grant funds for. He asked how flexible would the grantee be in terms of what projects they would fund.

Freeholder Walter explained that she was told that a Project Labor Agreement was possible. She added that it did not matter if it was grant, because if they were expending money on a project and it was the projected expense, then that is what would get them to the 5-million-dollar threshold. She recommended a thorough review on the possibilities of a Project Labor Agreement. Freeholder Cimino concurred.

Lillian Nazzaro, Esq., County Administrator, stated that she would get back to them with an answer.

Vice-Chair Frisby concurred with Freeholder Walter. He added that he would hope there was an opportunity for small or minority-owned businesses in the County to get a chance at these types of projects, considering the adoption of the Set-Aside Ordinance.

Freeholder Walter made reference to the proposed Resolution authorizing to execute an Amendment to the Professional Service Agreement with IH Engineers to provide preliminary engineering design services for Mercer County Bridge No. 441.4, Carrying Lower Ferry Road over Shabakunk Creek, Ewing Township, County of Mercer. She asked if bridge projects can be done through a Project Labor Agreement. Ms. Nazzaro answered that she would look into it.

Freeholder Cimino made reference to the proposed Resolution authorizing to execute a Professional Services Agreement with (awarded through a fair and open process) Urban Engineers, Inc., to provide construction administration, management and inspection to reconstruct Taxiway F (Construct) and Reconstruct Taxiway F Lighting (Construct) Project at the Trenton-Mercer Airport. He commented that he understood that Urban Engineers, Inc. had been doing a lot of the preliminary assessment for the terminal project. However, he mentioned that there were a lot of qualified engineering companies that could potentially provide the aforementioned services. He added that he did not understand why the County continuously used one engineering firm for consecutive projects.

OLD BUSINESS

Freeholder Koontz thanked Michael Herbert, Jr., Board Counsel, for the communication that followed up on the plastic bag ban law. Mr. Herbert stated that Camden County had passed an Ordinance that bans plastic bags at various County-owned facilities and events. However, he stated that there were some preemption issues with passing a plastic bag ban law.

Freeholder Koontz asked if it were possible to see an Ordinance drafted. He asked for the Administration to take a look at the impact on potentially passing an Ordinance for the ban of plastic straws, bags and Styrofoam.

NEW BUSINESS

Freeholder Frisby commented that he had the opportunity to visit Trenton Central High School, where the Smith Family Foundation recently announced that they were going to be doing a \$40,000 dollar scholarship for a high school student from Trenton Central High School each year. He expressed that he was really proud of the work they were doing to impact the entire County.

PUBLIC SECTION

At this time, Chair Koontz invited the members of the public to comment on any item listed on and off the agenda.

There were no comments.
