# **FORMAL MEETING OF FEBRUARY 13, 2020**

### **MINUTES**

Chair Koontz called the Formal Meeting to order at 6:05 P.M. on February 13, 2020 in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street Trenton, New Jersey.
The following members of the Board answered the Roll Call of the Clerk to the Board:

The Clerk to the Board read the Invocation.
Chair Koontz led the Pledge of Allegiance and Salute to the Flag.

## **PRESENTATION**

Ms. Gina Petrone Mumolie, DNP, MBA, RN NEA-BC., Senior Vice-President of Hospital Administration, Capital Health

Chair Koontz introduced Ms. Mumolie. She was present tonight to discuss February as Heart Month.

Ms. Mumolie thanked the Board for allowing her to be present tonight, also for adopting a Resolution recognizing February 2020 as American Heart Month and February 7, 2020 as National Wear Red Day. She stated that heart disease is the number 1 killer worldwide and strokes rank second globally. Ms. Mumolie stated that 80 percent of cardiac events can be prevented by just calling your doctor and understanding your symptoms. She said it is imperative that people know the risk factors and get help. Ms. Mumolie spoke of her husband who has suffered two strokes and her brother-in-law who was laid to rest yesterday because of a heart attack. She thanked the Board and was extremely grateful for their time.

Freeholder Walter thanked Ms. Mumolie for being here tonight. Freeholder Walter explained that women feel the oncoming of a heart attack or stroke differently than men. She said often times women take care of themselves last and that they often ignore the warning signs. Freeholder Walter hoped that women would try to be aware of their symptoms, adding that early detection is crucial. She noted that Freeholder Cannon pushed to have automated external defibrillators (AED) placed throughout the County and its numerous facilities.

The following individuals thanked the Board for the opportunity to be present this evening. They were present tonight because they had been awarded funding to help assist with the 2020 Census and the hard to count communities within Mercer County.

# **INFORMAL MEETING OF FEBRUARY 11, 2020**

### **MINUTES**

Freeholder Board Chair Koontz called the Agenda Meeting to order at 6:08 P.M. on February 11, 2020, in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street, Trenton, New Jersey.

### ROLL CALL

The following members of the Board answered the Roll Call of the Clerk to the Board:

# **SUNSHINE LAW**

The Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meetings Law, notice of this Informal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

# **COMMUNICATIONS**

Four (4) communications were discussed and approved for placement on the Agenda for the Formal Meeting of February 13, 2020.

Chair Koontz thanked the Administration for their professional and thorough answers to his questions. He also thanked Mr. Terry West, Director of Community Affairs, for his initiative when taking on the 2020 Census.

Freeholder Cannon commented that the Administration always quickly provides the Board with answers and added that the 2020 Census is an enormous feat and she was happy to see that the Latino community will be well represented.

Freeholder Walter spoke of an interesting piece of information she learned recently. She remarked that a projection was completed and found that for every person not counted for in the census a state could miss out on \$19,500.00 of funding over a ten year period. Freeholder Walter applauded Mr. West for heading the initiative and lamented how the census was a cause she so strongly supported.

# **RESOLUTIONS**

Forty (40) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of February 13, 2020.

Freeholder Frisby made reference to the proposed Resolution authorizing to "Exercise an Option to Extend" an Extraordinary, Unspecifiable Services (E.U.S.) Contract (Awarded through a Fair and Open Process) with Princeton Regional Chamber of Commerce for the Promotion of Tourism Services Services for the County of Mercer. He asked the Administration to provide the Board with a breakdown of numbers so they could do a comparison from previous years.

Ms. Lillian Nazzaro, Esq., County Administrator, said she would provide that information to the Board.

Freeholder Walter made reference to the following proposed Resolutions authorizing Award of Bids for Janitorial Services for the Civil Courthouse and for 1440 Parkside Avenue. She asked if these Awards were based solely upon being the lowest bid and wondered if there are any checks and balances regarding their performance.

Mr. Paul Adezio, Esq., County Counsel, answered that the Purchasing Department does award contracts to the lowest bidder.

Freeholder Frisby questioned if the Administration keeps a complaint log.

County Administrator Nazzaro said she believes most complaints come in the form of emails but was unaware of a formal log.

# **OLD BUSINESS**

Freeholder Frisby asked the Administration if there would be any displays throughout Mercer County and its libraries commemorating February as Black History Month.

County Administrator Nazzaro said she sent the Board an email explaining that the libraries will display historical depictions and the County sends out notices every Monday in February honoring various historical figures.

Freeholder Cannon added that she was a member of the Mercer County Board of Social Services, which holds weekly meetings and she commented that tomorrow they were having a small ceremony celebrating black history. She said this is now an annual event and she was proud of the different activities held throughout the County.
