II. PLANNING BOARD REORGANIZATION

Chairman Shine began the meeting with calling for a reorganization of the Mercer County Planning Board. Mr. Agress made a motion to nominate Mr. Shine for Chair of the Planning Board. Mrs. Wilson seconded the motion. All members voted in favor.

Chairman Shine nominated Mr. Agress for vice chair of the Mercer County Planning Board. Mrs. Wilson seconded the motion. All members voted in favor.

Chairman Shine made a motion to have Mr. Ridolfi continue as Counsel to the Planning Board. Mr. Agress seconded the motion. All members voted in favor. Chairman Shine thanked Mr. Ridolfi for his many years of guidance.

Mr. Agress made a motion to nominate Mr. Zochowski as the Mercer County Planning Board Secretary. Chairman Shine seconded the motion. All members voted in favor.

Chairman Shine announced that the Planning Board has three appointments to be made. One for the Open Space and Preservation Board, the Agricultural Development Committee as well as the Land Development Committee. Upon discussion by Board members, no changes were proposed to appointments from the prior year. Chairman Shine made a motion. Mr. Rubino seconded the motion. All members voted in favor.
