**FORMAL MEETING OF DECEMBER 3, 2020**

**MINUTES**

Chair Koontz called the Formal Meeting to order at 6:05 P.M. on December 3, 2020 through Cisco Webex Video Conferencing.

The Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meetings Law, notice of this Formal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

**MOMENT OF SILENCE**

Freeholder Cimino asked to have a moment of silence for Marilyn Jose, a long-time dedicated Hamilton resident.

Freeholder Cannon asked to have a moment of silence for Robert Downing, who served as the first black Undersheriff in the Mercer County Sheriff's Office.

**PUBLIC SECTION**

**At this time, Chair Koontz invited the members of the public to comment on any item listed on the Agenda.**

Judith Hoechner, resident of Yardley, Pennsylvania, made reference to the proposed Resolution authorizing the Award of Bid received September 24, 2020 to M.S.P. Construction Corp. for Phase Two of the Water Main Installation at North Quadrant for the Trenton-Mercer Airport. She asked for the purpose of the water main installation in the North Quadrant of the airport. Melinda Montgomery, A.A.E, Airport Manager, explained that the water mains were old and suffered from tuberculosis.

Johnnie Whittington, resident of East Windsor Township, commented that he was in favor of the Freeholder Board's decision of the Trenton-Mercer Airport expansion.

Glenn Reitmeier, resident of Yardley, Pennsylvania, expressed his continued opposition to the Trenton-Mercer Airport projects. He believed it was a misguided expansion at the time, in light of COVID-19 and the dramatic decrease in travel.

Patricia Fletcher, resident of Ewing, asked to have her comments read into the record regarding the Trenton-Mercer Airport. **(See Schedule A, attached hereto, and made a part hereof)**

Susan Herman, President of Residents for Regional Traffic Solutions, Inc., requested the Freeholder Board to oppose the two Resolutions regarding the Taxiway D to G Connector (Phase I) Project at the Trenton-Mercer Airport. She suggested the County perform a Voluntary Environmental Impact Statement to evaluate the cumulative impact of the continued unchecked large-scale expansion of Trenton-Mercer Airport.





Hello, All:

Pat Fletcher @ 134 W Upper Ferry Rd, W. Trenton, NJ.

Commissioner Koontz, please can you cc: the rest of the commissioners, read into the record during the public comment period, and attach my letter/attached images to the minutes.

I would like to share data I have collected in recent weeks from the "flightradar24" app. This represents a small sampling of real time data collected since Spring 2020.

In each screen capture, you can see the following:

1. The time of the capture (top of each image). The file names show the dates.
2. My home's location next to Ridge Ave, and in front of Sunset Ave. (large blue dot).
3. West end of runway 6 (thick gray line).
4. The flight path of whatever aircraft I had highlighted at the time (thin white or yellow lines).
5. Details of the aircraft/owner when not blocked by the pilot. Those blocking are usually the loud corporate or private jets.

The images do not give accurate altitudes for the planes passed over my home/block; you are seeing the plane's altitude by the time I got the screen capture, which could be minutes more into the flight. All of these planes passed over my home or block between 100-400 feet above the roof tops, as per usual.

I would like to draw your attention particularly to:

1. How far left off of runway 6 these aircraft are taking off/landing and the block of homes they routinely pass over at low altitude. Including on clear days when no other aircraft are near. Why? We have never had a defensible answer on this question from airport leadership, though we have asked for it at every meeting for over a year.
2. Many small aircraft repeatedly circle the neighborhood and depart or land low over homes hour after hour within a single day. For those attached to the flight school,

why is this behavior permitted by the instructors? It demonstrates inability to behave as a good neighbor.

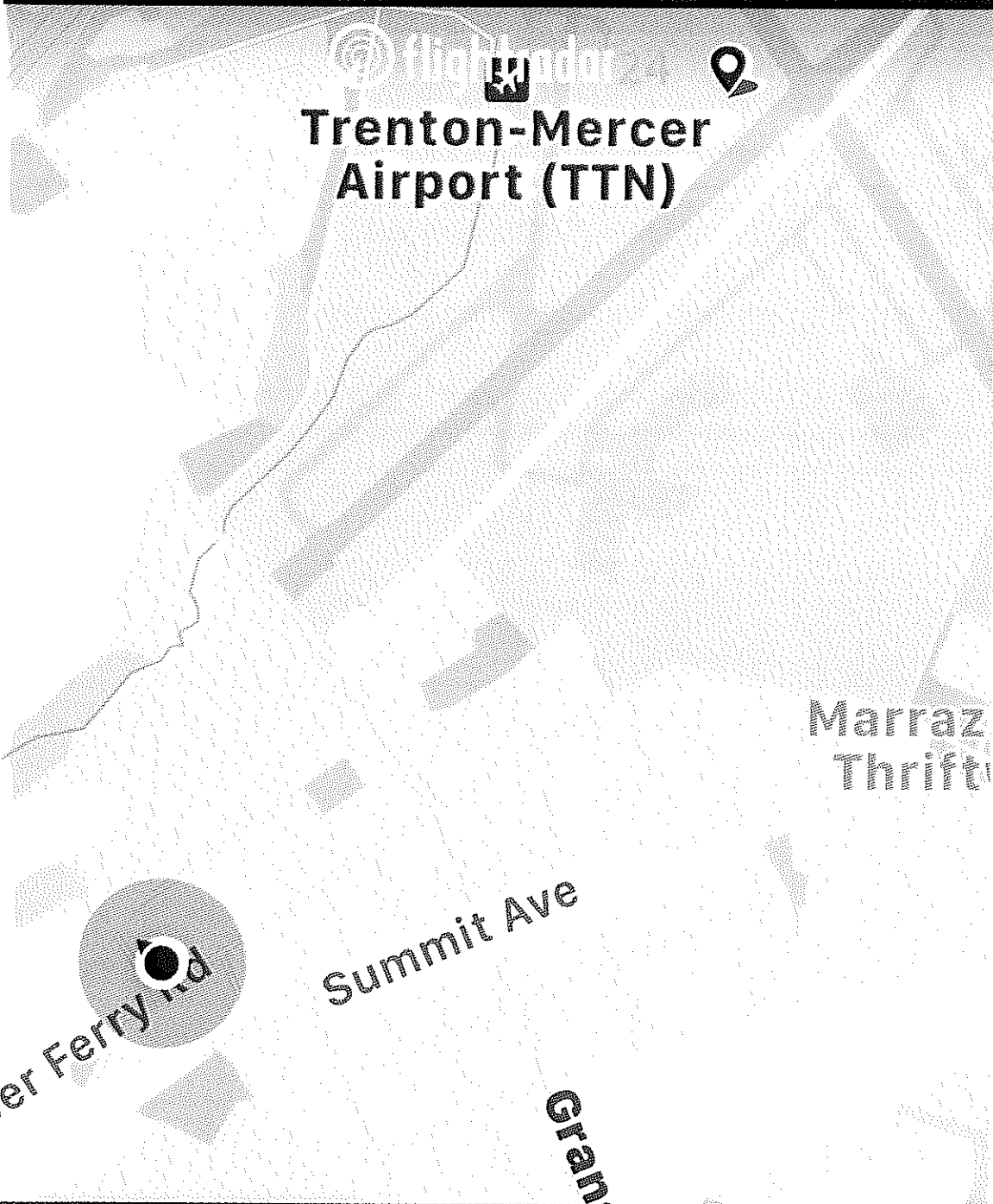
3. Every image attached is for an aircraft that was taking off or landing at TTN. I was able to observe in real time by eye & ear alongside flightradar24. However, some aircraft in the set have blocked their departure and landing places from being documented by flightradar24.
