#### **PRESENTATION**

# Paula Sollami-Covello - Mercer County Clerk's Five Year Plan

Chair Koontz said that Mercer County Clerk, Paula Sollami-Covello, was present this evening to present the Board with her Five Year Plan.

County Clerk Sollami-Covello addressed the Board. She was pleased to share with the Board her five-year plan for 2021 through 2025. (See Schedule B, attached hereto and made a part hereof)

County Clerk Sollami-Covello spoke of the plan including some new and innovative items such as standing desk conversions for each of the staff members and making records more accessible to the public by putting them online for their disposal.

Freeholder Walter asked the County Clerk her thoughts on the last election process in November.

County Clerk Sollami-Covello said they did not have a lot of time to prepare for an all vote by mail election. She informed the Board that they were able to send out roughly 260,000 vote by mail ballots in a generally short amount of time. County Clerk Sollami-Covello took a moment to thank County Executive, Brian M. Hughes, the Administration and the Freeholder Board for all of their support. They provided her with the funds to purchase the tools they needed to ensure all voters in Mercer County had the opportunity to vote during this pandemic. County Clerk Sollami-Covello said the Board of Elections was able to use the extension building as a makeshift hub allowing employees to work while being socially distanced and to have the amenities like new ballot scanners. County Clerk Sollami-Covello was hopeful that purchasing new voting machines in the future would ensure voter accuracy especially if they were equipped with a paper trail. She was confident in the work provided to Mercer County and its residents during this election season. Mercer County Clerk Sollami-Covello said that Daniels' Law was just passed. She explained the law requires public officers' information be redacted from the public record. County Clerk Sollami-Covello said she was still waiting on guidelines on how to navigate this new law moving forward.

Freeholder Walter said she noticed all the election drop boxes located throughout Mercer County. She asked if these boxes were property of Mercer County.

County Clerk Sollami-Covello said they are property of the County of Mercer. She explained that the State of New Jersey purchased only 10 boxes and she purchased the remainder on behalf of the Board of Elections.

#### Mercer County Clerk's Office Five-Year Plan

#### FIVE YEAR PLAN- County Clerk's Special Trust Account, 2020-2025

In 2006, 2010, and 2016, I came before you with five-year plan, which is required under law for expenditures of the County Clerk's Trust Fund. I am pleased to report to you that the goals set forth therein, and approved by you, under that plan were completed or initiated with the Special Trust as specified.

Pursuant to Statute, NJSA 22A:4-17.1, I am hereby submitting below a five-year plan at the end of my third term, with my goals for my fourth term over the next five years, for your review and approval.

The County Clerk's Five-Year Plan for Special Trust Account is set forth below:

#### Years 1-5 2021-2025-

In 2020, the Clerk's Office purchased several new elections scanners for counting votes on Election Night. These were needed to meet the needs of two all "vote by mail" elections in 2020, and the scanners will make counting faster and easier on election. They were for the Board of Elections Office to use to transmit the final count to my office for election certification. I will be purchasing additional scanners as needed with the Clerk's Trust as we go forward.

We purchased several drop boxes for the Board of Elections to collect ballots, and we also purchased a mail-opening machine for the election mail in 2020. These purchases for our team helped the County of Mercer in many ways as the County did not have to find money to meet the major and immediate demands of the election.

#### Elections:

We will continue to purchase supportive equipment as needed to meet the ongoing demands of the three election offices with the Trust Fund where we can, in order to perform election duties and meet demands. I thus, am submitting this to notify you that funds will be spent for unbudgeted election equipment and modernization to support the offices.

My trust will not be used for purchasing voting machines for Mercer County or basic machine equipment, but there may be new needs to support this purchase by the three offices once machines are purchased and the Clerk's Trust Fund will be used as needed to support this purchase.

We will provide educational funding for staff members to attend educational seminars/or conferences which will directly enhance their job performance and improve their skills. This will not include hotel or travel costs which are budgeted.

#### Passports:

We also will continue to purchase cameras and film for passport and County ID's, and associated repair costs, etc., as we continue to have a satellite location for passports and we hold passport events throughout the County.

#### Property Recording:

The majority of the Trust Funds spent this term will be dedicated to our back-scanning project of County Property Records. This is being done with the use of fees from the Trust Account.

We are back-scanning old books and have recently put out an RFP to scan additional older books. This preserves the books and allows for them to be placed in storage. Also, we must pay to upload the images and to index those images. It is an expensive process but it allows all books to be electronically accessible for internet property searching. Frankly, the public and the property industry expects the County Clerks to be able to provide this information electronically.

We will continue to digitize and electronically format property records as it preserves them and makes them available to property searchers. Our hope is that our record storage fees will have go down considerably as a result of the back-scanning project.

We plan to be using trust monies to update our office. Those improvements will be funded through the Clerk's special trust.

- Some back-scanning of the oldest (most fragile) books will be done in house. A scanner may need to be purchased for on-site scanning. Or, alternately, we will hire a vendor to begin scanning the oldest historical books on our shelves.
- Book-binding or record image-enhancement to make a record legible will also be paid for by this fund.

#### Other Items-

Finally, the Clerk's Trust will likely be used for other needed items that fit the statutory allowance

• Prepare Informational Brochures in multiple languages pertaining to changes in vote by mail law for elections.

- IGO Conference registration and/or COANJ conference registration fees as needed to learn new technologies for recording and elections with County registers, clerks and election officials.
- We plan to offer seminars on notary publics and seminars on how to use the new land-records management computer system for the public to attend. Funds for educational programming will come from this account.
- Election signage as needed for Election Office.

#### IN ADDITION TO THE ABOVE EACH YEAR, WE WILL:

- In 2021 and 2022, the County Clerk's Office will also be purchasing standing desk equipment for all staff members to modernize office services as this is healthier on their backs. In these two years, we will also look into better encrypting our on-line search system.
- Also, we have been required to remove certain data from records pursuant to Daniel's Law and we will be updating our redaction software to meet this legal requirement in 2021 and 2022.
- In 2023, the County Clerk's Office will be purchasing additional computers for the search room. We need more computers for property searchers as we continue to book books online. We will also repair bindings of the old priceless books.
- In 2024, we will continue back-scanning and binding of old priceless books.
- In 2025, we will continue to back scan and bind older books.

# **PRESENTATIONS**

# Dr. Jianping Wang, President - Mercer County Community College

Chair Koontz said that Dr. Wang was present this evening to provide the Freeholder Board with an update on Mercer County Community College (MCCC).

Dr. Jianping Wang addressed the Board. She thanked them for the opportunity to be present this evening and speak about MCCC. Dr. Wang wished everyone a happy holiday with continued success and happiness throughout the season. began her presentation informing the Board that MCCC continues to offer hybrid courses to its students. Dr. Wang stated that the college's fall enrollment was down 16% but this was on trend with national enrollees occurring throughout the country. She explained that community colleges were experiencing a decline mainly due to the uncertainties surrounding COVID-19. Dr. Wang said unfortunately enrollment for the spring semester was down 36% for minorities but explained that even students who were awarded full financial aid have not registered for classes in this current climate. Dr. Wang attributed much of the decline was a result of job uncertainty and the need of students' providing for their families. She was pleased that the college was offering \$800,000 in scholarships this year and was proud to inform the Board that they were one of the top learning institutions in the Country to do so. Dr. Wang informed the Board that she implemented hiring freezes within MCCC and asked employees to assist in fundraising efforts. She was pleased to announce that over 150 MCCC employees participated. Dr. Wang spoke about being a strong advocate of community outreach and discussed local dentist offices donating chairs to help dental students learn and hone their skills. She said that she was in contact with local officials offering her assistance and providing the MCCC campus as a local site for COVID-19 vaccine distribution. She spoke of numerous student success stories and was proud of all they have accomplished in these very unprecedented times. Dr. Wang thanked County Executive, Brian M. Hughes, the Administration and the Freeholder Board for always supporting MCCC's endeavors.

Freeholder Cannon said she was extremely proud of all the hard work that Dr. Wang continues to provide MCCC.

Chair Koontz thanked Dr. Wang for providing the Board with an extensive update and handling everything with such fortitude.

The Address of the State of the

Freeholder Frisby asked how students were fairing with talking courses online.

Dr. Wang responded that many students were feeling extremely isolated which in turn caused MCCC to offer services to both faculty and students assisting them with their mental health.

# Peter Crowley - CEO of Princeton Mercer Regional Chamber of Commerce

Peter Crowley thanked the Board for the opportunity to work together for the last twelve years. He expressed his sincere gratitude and said he considered many of the Freeholders friends. Mr. Crowley spoke of the first year he spent as President of the chamber and attending his first Freeholder meeting in March of 2009. He informed the Board that he would be retiring from his position at the end of the year but was leaving the Chamber in very capable hands. Mr. Crowley said that Hal English would be replacing him as President and hoped the Board would work together ensuring the Chamber's growth. He thanked the Board for their continued support and friendship over the last twelve years and looked forward to the future for both the Chamber and Mercer County.

Chair Koontz thanked Mr. Crowley and said he has done an incredible job as President of the Chamber. He spoke of first meeting Mr. Crowley when he was a Princeton Councilman and how the Chamber has come such a long way under his leadership especially in terms of tourism and economic drivers for Mercer County. Chair Koontz wished him the best of luck in his future.

Freeholder Walter thanked him for his time and always being a gentleman of honesty and integrity. She thanked Mr. Crowley for setting the standard high and was confident that Mr. English would continue his vision for the Chamber.

Freeholder Frisby referred to Mr. Crowley as "my guy" and was appreciative of his diligent work. He said that Mr. Crowley never took his critiques as criticism but utilized them as a learning tool and sometimes implemented them. Freeholder Frisby commented that Mr. Crowley was always there to listen and he was thankful for all he did for Mercer County.

Freeholder Cimino said that Mr. Crowley should be extremely proud of all his has accomplished in his tenure. He added that Mr. Crowley was able to accomplish many initiatives, one of them being the merger of the Mercer/Regional Chambers along with the help of his wife, Jeanine Cimino. Freeholder Cimino said it was a collective effort under his leadership and was for the betterment of this region. Freeholder Cimino wished Mr. Crowley health and happiness in his retirement.

Freeholder Melker mentioned that she has had a long working relationship with Mr. Crowley. She said that he actually hired her at the Bank of Princeton. Freeholder Melker was proud that she and Mr. Crowley have had the pleasure of helping grow that bank and it was a great working with him over the years. She wished him a wonderful retirement and congratulated him on all of his endeavors.

Freeholder Cannon told Mr. Crowley she would miss seeing him at the meetings and commented how moved she was by his tenacity. Freeholder Cannon wished him much happiness and health on his retirement.

Freeholder Colavita thanked Mr. Crowley for attending the Freeholder meetings and keeping them informed of what was occurring in Mercer County. He wished Mr. Crowley well on his retirement.

Chair Koontz thanked everyone for the comments and wished Mr. Crowley all the best on his next chapter.

# Ms. Yuki Moore Laurenti, Trustee, Open Space Institute

Ms. Laurenti was present this evening to discuss her ongoing concerns about ensuring environmental equity in open-space preservation efforts. (See Schedule A, attached hereto, and made a part hereof)

Chair Koontz commented that he was proud of Mercer County and their open-space acquisition and felt it prudent to mention that using the Hopewell golf course as the example of how the County handles open-space acquisitions was a bit unfair. Chair Koontz felt that it is great advice and commented that the revenue generated by golf courses is an extremely important source of revenue for the County. He asked that Ms. Laurenti submit her documents for the record.

Freeholder Frisby mentioned that he is part of a group that looks at environmental space and the equity in that environmental space, along with Director Aaron T. Watson. He mentioned that Director Watson is ironically one of the only Parks Directors of color throughout the State of New Jersey. Freeholder Frisby spoke of the importance of making open-space available to more diverse communities. He said that often times equity, diversity and inclusion are overlooked and many communities are underserved. Freeholder Frisby commented that he would love to connect with Ms. Laurenti and gain her perspective on this matter.

Freeholder Walter explained that in Ewing Township, the Benjamin Temple house has trails that connect into Lawrence Township and these areas are very well developed. She commented that these lands are often being inhibited by other projects with tree removal and damage to those lands. She felt areas such as Hopewell or the Windsor's which already have an abundance of open-space should have a portion of their funds set aside and utilized for urban areas and cities.

Ms. Laurenti agreed and thanked the Board for all of their concerns ensuring environmental equity and open-space accessibility.

Chair Koontz made reference to the Special Item of Revenue – funds will be received from the National Fish and Wildlife Foundation's Delaware Watershed Conservation Fund for the Mercer County Park Commission and Mercer County Planning Department for the design and partial installation of a living shoreline and ecologically friendly boat ramp in John A. Roebling Memorial Park. He said how impressed he was with the work that went into this Grant especially the Parks Department. Chair Koontz requested the Board receive the scope of work for their review.

Chair Koontz made reference to the Resolution authorized to Transfer Appropriations. He asked Chief Financial Officer, Dave Miller to update the Board.

Mr. Miller said his goal is to keep the transfer below 1% and noted this year the rate was 1.4% almost 1.5%. He commented that he was still diligently working on lowering the numbers. Mr. Miller said there was a relatively large transfer in the Prosecutor's office but stated those funds would be refunded by Grants.

Freeholder Walter said she was interested in the 1.4 million dollar transfer from the Mercer County Correction Center.

Mr. Miller explained that two major things occurred there. The first being that overtime was down and second there was an expectation that the Administration would enter in a contractual Agreement. He added there was a chance those funds could be put back to provide for any retroactive payments that many come up noting they had two open ended contracts for 2019 and 2020.

# Presentation to the Mercer County Board of Chosen Freeholders

Yuki Moore Laurenti, Trustee, Open Space Institute

Chairman Koontz, Vice-chairman Frisby, members of the Board of Freeholders, thank you for the opportunity to address you this evening on growing concerns about ensuring environmental equity in open-space preservation efforts.

I serve on the board of trustees of the <u>Open Space Institute</u>, which for half a century has worked with government agencies, landowners, and local land trusts to acquire land to protect diverse landscapes, preserve habitat for rare or endangered species, ensure water quality, and enhance recreational access. It also protects land in private hands from future development through conservation easements.

Simply keeping open space open was long thought to be its own reward. But our board has gradually come to realize that the benefits of these efforts may have been too narrowly felt. Good intentions, it turns out, are not automatically self-validating.

Now, the heightened debate about widening inequality and persistent neglect of racial minorities has prompted many in the environmental community, who had long thought that their work was inherently of universal value, to look more critically at their traditional assumptions.

I have represented the OSI board on its first review of these issues this year. While the focus of our exercise has been on how grant-makers like OSI need to incorporate equity concerns into their evaluation of projects to support, I believe some of the insights we have gained on equity in open-space protection should also resonate in government undertakings.

Our OSI inquiry notes several "values for external equity" that should constitute something of a check-list for proposed projects, deals, and grants, such as:

- Promote positive partnerships with community allies in underserved communities
- Ensure broad, safe, and equitable access
- Create education and programming opportunities for those historically excluded
- Promote equitable practices to mitigate climate effects

Our staff is now charged with creating metrics to hold OSI accountable for our commitments to equity. Yes, metrics to evaluate a project are difficult to craft. Still, we're expecting them to "crystal-ball" any impacts that a proposed acquisition might foster and list all potential impacts, even if purely aspirational.

Most of OSI's traditional efforts have preserved rural open space in New York State, South Carolina, Maine, and Georgia. One concrete sign of the re-thinking I've been describing has been OSI's initiative this year to create the <a href="Essex-Hudson Greenway">Essex-Hudson Greenway</a>, acting as a catalyst and agent to acquire a 9-mile defunct rail line running from Montclair

through Newark and the Meadowlands to Jersey City, in the two most densely populated counties in New Jersey.

I was led to think of how the OSI re-thinking process might be relevant to our own county with the acquisition this month of the Hopewell Valley Golf Club. It's a substantial land parcel that, by OSI's own traditional criteria, is far better preserved as open space than lost to commercial or residential development.

Yet, seen through the lens of environmental equity, the preserved land should serve more than the relatively small number of higher-income county residents who play golf. Plans are already being drafted, I would hope, to allocate some of that expanse to nature education and to paths for walkers and cyclists.

What also needs reflection is how to assure "broad, safe, and equitable access" to this new county facility – and, for that matter, to the county's other park facilities – for people who do not have private automobiles at their disposal. The crown jewels of our county park system, Mercer Meadows in Hopewell and Mercer County Park in West Windsor, assume that people will get there by car, effectively putting them beyond reach of many people living in or near Trenton.<sup>1</sup>

I would like to think the nature centers and nature programs have found ways of effective outreach to "create education and programming opportunities for those historically excluded." That, too, is an "external equity value" we need to keep in mind.

As we've belatedly come to understand at OSI, open space acquisition shouldn't be limited to rolling hills and expansive meadows. Perhaps the Essex-Hudson Greenway project can point a way whereby Mercer County can start re-balancing its open space program to improve environmental equity.

While there aren't hills and meadows in Trenton and the older developed sections abutting it in Ewing, Lawrence, and Hamilton, there are linear strips – old rail rights-of-way and creek banks – that perhaps can qualify. I think of the portion of the old Johnson Trolley Line in Ewing, or the old Delaware and Bound Brook rail bed in Trenton and Ewing, as possible examples.<sup>2</sup>

Of course, even our best intentions don't always engender the applause we expect. This fall, on a bike outing to the Delaware Water Gap, Jeffrey and I stopped at the Cherry Valley National Wildlife Refuge. This is a former golf course near Stroudsburg that OSI worked with local partners to save from sale to a developer. It was then turned over to the U.S. Fish and Wildlife Service to restore it to its natural state.

We walked on a trail through fields where the grasses were taller than I am, hearing the birdsong and seeing various species of warblers and sparrows and wrens flitting among them. We crossed a stream that's been restored to its pristine condition, and there met an older couple sitting on a bench, apparently enjoying the open space.

The couple told us this had been a golf course that somebody had saved from developers, and they were glad it had been kept as open space. Before I could tell them that in fact I was on the board of the group that had saved this space, they added, "But look at what they did. They just let it go to pot."

It was really much nicer, they explained, when the fields were of regularly mowed green grass. So much for Nature – that was literally "for the birds." And I was glad to have just kept my mouth shut.

Perhaps I should have just kept my mouth shut tonight. But I appreciate your allowing me the opportunity to raise these practical questions of environmental equity as we have been debating them at OSI and as the county might consider them here. Thank you for affording me the time to make this presentation.
