Freeholder Walter commented she understood the tree replanting program would not be financed by the Federal Aviation Administration (FAA), but believed that the County should bear the cost. She highlighted that planting trees in Ewing, rather than buying credits elsewhere would improve the air quality for surrounding communities.

Ms. Nazzaro explained that the purchase of credits improved wetlands and riparian zones, which was recognized by the FAA as a standard practice.

Freeholder Frisby suggested that the County look into doing a certain percentage of both buying credits elsewhere and replanting trees in Ewing.

Freeholder Walter asked could trees that would grow no taller than about 10 feet be planted, when they clear cut the taller trees. Ms. Nazzaro commented that she would follow up with the airport officials regarding her concerns.

Freeholder Walter stated that she would like to see a detailed plan before the grant returns to the Freeholder Board for vote.

Freeholder Koontz commented that he understood the County's concern with converting the shoulder on Washington Road in Princeton to a bike lane. He expressed that he favors bike lanes because they afford the cyclist legal protection if there were to be a motor vehicle accident.

### **INFORMAL MEETING OF SEPTEMBER 22, 2020**

### **MINUTES**

Chair Koontz called the Agenda Meeting to order at 6:02 P.M. on September 22, 2020 through Cisco Webex Video Conferencing.

### ROLL CALL

The following members of the Board answered the Roll Call of the Clerk to the Board:

Present – Freeholders Cannon, Cimino, Colavita, Frisby, Walter and Koontz Absent – Freeholder Melker
Chair Koontz led the Pledge of Allegiance and Salute to the Flag.

### **SUNSHINE LAW**

The Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meetings Law, notice of this Informal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

### **PRESENTATION**

Chair Koontz announced that the following representatives from the New Jersey Shared Services Czars was in attendance to promote and emphasize the importance of Shared Services throughout the State of New Jersey: Jocelyn Mathiasen, Jordan Glatt and Richard Richardella. (See Schedule C, attached hereto, and made a part hereof)

Freeholder Frisby questioned if there was any funding incentive programs that would help cities similar to Trenton, to attract partners that may want to enter into Shared Services Agreements.

Melanie Walter, Director of Local Government Services, answered that they award priority points within all of the grant programs, and also provide challenge grants to encourage larger scale sharing. She added that they prioritize resources within each community that need to be allocated to make sure all participants get a seat at the table, which tends to encourage participation of the smaller communities with the larger communities.

Freeholder Frisby stated that he noticed there was a significant rise in the total Shared Service Agreements from 2016 to 2017. Ms. Walter commented that she believed the reason for the large increase was due to getting the records up to date, due to the failure of fully reported shared services. She concluded that they also saw an uptick because many municipalities started to feel the pressure of the two percent spending cap, creating the incentive to enter into Shared Services Agreements.

Freeholder Frisby asked if they were able to identify the reason for success with the Shared Service Agreement between the City of Camden and Camden County Police Department. Mr. Richardella explained that Camden entered into a new type of Community Oriented Policing Program.

### **COMMUNICATIONS**

Six (6) communications were discussed and approved for placement on the Agenda for the Formal Meeting of September 24, 2020.

Freeholder Walter made reference to the Communication from Isamar Maldonado, Purchasing Agent, regarding the Minutes and Bid Results for the Week of August 17, 2020. She expressed her concerns regarding the large variation between bids results.

### **RESOLUTIONS**

Twenty-six (26) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of September 24, 2020.

Chair Koontz made reference to the proposed Resolution authorizing to execute a Grant Agreement with the New Jersey Office of Homeland Security and Preparedness (OHSP), State Homeland Security Program (SHSP), for 2020 Homeland Security Grant Funds. He asked for a list of projects that the grant would be used for. Lilian L. Nazzaro, Esq., County Administrator, stated that she would follow up.

Freeholder Walter made reference to the proposed Resolution authorizing to execute an Amendment No. 1 to the Professional Services Contract (awarded through a non-fair and open process) with the Lenox Law Firm to provide legal services in the Matter of Baldwin v. County of Mercer. She asked when the next update would be regarding pending or anticipated litigation. Ms. Nazzaro mentioned that she would discuss the matter with Paul Adezio, County Counsel.

Chair Koontz made reference to the proposed Resolution authorizing to execute a Professional Services Agreement (awarded through a fair and open process) with C & S Engineers, Inc., to provide consulting services for Land and Avigation Easement Acquisition Support Services for the Voluntary Runway Protection Zone (RPZ) and Avigation Easement Acquisition Project at the Trenton-Mercer Airport. He asked the Administration to provide a summary of what the aforementioned Agreement would provide.

Ms. Nazzaro reminded the Freeholders that letters went out a year ago to certain homeowners to inquire on whether or not they were interested in voluntarily selling their home to the County. She explained the Agreement involved the purchase of two homeowners who were interested in selling their properties, with a possible third homeowner interested. She concluded that C & S Engineers, Inc., would oversee the engineering, land easement acquisition and tree removal phases for the overall RPZ program.

Chair Koontz asked if the amount of the agreement involved the price of the homes. Ms. Nazzaro answered that the price of the homes was not included in the Agreement amount, but instead reflected the coordination and demolition of said properties.

Freeholder Walter asked what an Avigation Easement entailed. Ms. Nazzaro explained that it included the use of airspace, which prevents tall structures.

Freeholder Walter inquired about the County acquiring up to six homes mentioned in the back-up. Chair Koontz explained that the acquisition offer was made to a total of six homes, and only two homeowners accepted the offer.

Jerlene H. Worthy, Clerk to the Board, made reference to the proposed Resolution authorizing to execute an Extraordinary Unspecifiable Services (E.U.S) Contract (through a non-fair and open process) with Vault Medical Services of New Jersey, PC., to provide athome and on-site COVID Testing Services for Mercer County. She announced that her office did not receive a signed contract.

### **OLD BUSINESS**

Chair Koontz thanked the Administration for reducing Washington Road in Princeton to one lane. He inquired if a bike lane could be created since the shoulder was wide enough.

Freeholder Walter expressed her concern regarding the straight cut edge of the road project on Olden Avenue.

Freeholder Walter asked for an update for the plans of the West Trenton bypass.
Freeholder Walter congratulated the Park Commission for the tree planting event located at Rosedale Park in Pennington.
Freeholder Walter asked if anyone looked into whether the County could replant trees in Ewing Township to replace the filtering of air in and around the airport.
Freeholder Walter inquired about the height of the newly built structure in the new parking lot compared to the trees that would be clear cut.
NEW BUSINESS  Freeholder Frisby congratulated Aaron T. Watson, Executive Director of the Park Commission, for his leadership in a program called Swimming-to-Rowing. He explained that there would be a drive-in movie on Sunday, September 27 <sup>th</sup> , showing the film "A Most Beautiful Thing", which highlights the first African-American high school rowing team in the late 90's in Chicago.
Freeholder Colavita mentioned that he attended a tour and briefing at the Trenton Biogas facility.
Ms. Worthy asked to have a moment of silence at Thursday's Formal Meeting for the Supreme Court Justice Ruth Bader Ginsburg.

Freeholder Cimino asked for the protocols that have been put in place when the Administration building opened back up to the public. Ms. Nazzaro stated that all County facilities would be reopening on September 28<sup>th</sup>. She added that the Administration Building, County Connection and Veterans Services are open by appointment only. She mentioned that there was a temperature scanner, and X-Ray machine at the entrance of the Administration building. She highlighted that no one is allowed to enter the building without a mask.

Freeholder Cimino inquired about a plan for the Freeholder Board to return to the Administration Building for Freeholder meetings. Chair Koontz emphasized that he would consider a version of hybrid meetings for October, but believed was too early to invite the public into the meeting room.

Freeholder Frisby asked if services offered at Board of Elections Office on Parkside Avenue, was still available at the previous location on South Broad Street. Ms. Nazzaro explained that the entire Board of Elections Office was moved to 1440 Parkside Avenue in Ewing and that the voter would need to go to the facility in Ewing for Board of Election services.

Freeholder Frisby expressed his concern with the dissemination of information to the public regarding the change in location. Ms. Nazzaro assured that the information was adequately advertised to the public.

Freeholder Cannon inquired about the air filtration in the Administration building. Ms. Nazzaro confirmed that the HVAC system had high efficiency filters in them and that the air handlers were open for the flow of air coming inside and going outside the building.

### **PUBLIC SECTION**

At this time, Chair Koontz invited the members of the public to comment on any item listed on and off the agenda.

Dr. Robin R. Karf, resident of Princeton, asked for more information on the proposed Resolution authorizing to execute a Professional Services Agreement with Urban Engineers, Inc. She asked if there would be a bond referendum on the ballot in November.
Johnnie Whittington, resident of East Windsor Township, suggested that information about ballot box locations be published on the County website banner.
Susan Herman, President of Residents for Regional Traffic Solutions, Inc., expressed her concerns with the public not having access to the answers to the Freeholder questions from Ms. Nazzaro. She requested that all Resolutions involving the Trenton-Mercer Airport be separated out of block for vote on Thursday's meeting.
Nancy Buck, resident of Ewing, commented that she hoped the Freeholder Board would consider the proposed Resolution authorizing to execute a Professional Services Agreement with C & S Engineers, Inc., for Thursday's Agenda.

### Dear Freeholders

I strongly object to continued funding of TTN Mercer projects as manifest in the resolutions on the agenda. I have previously commented on the flawed economics of an airport expansion plan in a post-pandemic world that will have a greatly reduced demand for air travel. Video conferencing technology that we are using to hold public meetings ensures that business air travel will not rebound to 2019 levels in the foreseeable future. And if business travel is reduced, then there will be a great excess capacity at large airports such as EWR and PHL; how can the expansion of TTN make any economic sense when it will compete with excess capacity at major airports? Can't you see that technology is obsoleting a great deal of physical travel?

I also urge you to vote 'no' on these resolutions because they lack detail and transparency in terms of what the funds will be used for. These are large expenditures with no line item detail of expenditures and project deliverables. These requested funds are part of an irresponsible segmented expansion. At almost every Freeholder meeting the airport has its hand out collecting more and more County funds. Responsible government oversight demands that you, as leaders, stop approving segmented steps and unclear use of taxpayer money.

You have heard many concerns from the public about the negative impacts of airport expansion on health, environment, noise impact and property values. In spite of these concerns you continue to fund every new step of the airport expansion.

I respectfully urge you to be true leaders and responsible government stewards of taxpaxer money- say 'no' to these resolutions. Then step back and re-examine the airport expansion in light of a full Environmental Impact study and a rigorous financial scrutiny that considers the new reality of reduced air travel.

"I am asking that the freeholders vote no for resolution 18 and 19. The Freeholders should be seriously revisiting your past decision to spend tens of millions of dollars of federal and local money to expand the usage of this airport by commercial jets.

It was never a wise choice for the residents of Mercer and Bucks county and the local environment for the Freeholders to be pushing to create a commercial airport in this heavily developed area. But now with the fundamental change in air travel, it is also a poor financial decision. Over the next few years, the airlines will go through a dramatic rearranging and air travel will likely never return in the manner that we knew it before. You are approving money and taking on debt to: level neighborhoods, destroy woodlands, and build a terminal with 5 times the passenger throughput of the existing terminal.

Your constituents will be responsible for the debt the Freeholders are taking on until the airport has embarked many millions of passengers which will likely now be many years in the future. So you have a lose-lose situation here – you carry the debt with your taxes until, if and when, the PFC's ever start to pay down the loans and, by then, you will have destroyed our quality of life by having constant planes in our airspace and added cars on our roads.

I ask again that you vote no tonight on resolution 18 and 19 and seriously reconsider your plans for the massive, expensive expansion of this airport. "






