WHEREAS, Assembly Bill 5472 also bars law enforcement from transporting such persons to a police station to deliver the statutory warning for a first offense; and,

BE IT RESOLVED, that the Mercer County Board of County Commissioners does hereby support Assembly Bill 5472 which, requires notification to parent or guardian of certain underage persons for first offense of possessing or consuming alcohol, cannabis, marijuana, or hashish; and,

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Governor of the State of New Jersey Phil Murphy, the President of the New Jersey Senate Steve Sweeney, the speaker of the General Assembly Craig Coughlin and the legislators representing Mercer County.

WHEREAS, trees contribute to a clean, healthy environment by removing, ground level ozone and carbon monoxide from the air, and this has serious social justice impacts since removal of trees will negatively impact all of Mercer County, but data shows that the removal of trees is linked to asthma emergency room visits which are considerably higher in Trenton and its neighboring Mercer communities; and,

WHEREAS, the State of New Jersey has created a formula that can be easily adapted for County use to ensure this environmental, and social justice through requiring replanting with native species on the property from which trees have been removed, or if that is not feasible, then in descending order (1) on state, or municipal property in the town where the cutting occurred; (2) on state, county, or municipal property within five miles of the cutting; or (3) on other state owned property (N.J. Rev. Stat. § 13: 1L-14.2); and,

WHEREAS, additionally committing to limiting the use of Wetland Banking as a mitigation strategy, in order to concentrate on the importance of local tree replacement is encouraged; and,

WHEREAS, trees face damage from natural causes such as insects, disease, drought, and man-made causes such as air pollution and construction; and,

WHEREAS, Mercer County strives to maintain trees utilizing professionally arboricultural practices along our roadways and in our parks; and,

WHEREAS, establishing a "No Net Tree Loss" policy reinforces Mercer County's commitment to environmental, economic, and social stewardship; and,

WHEREAS, by incorporating a "No Net Tree Loss" policy into all decisions and embracing the New Jersey State statute hierarchy of replanting into decisions, Mercer County will positively affect health by reducing negative health impacts on humans and the environment, increasing economic growth through beautification of communities, and fostering social stewardship; and,

BE IT RESOLVED, that the Mercer County Board of Commissioners supports a "No Net Tree Loss" policy.

BE IT FURTHER RESOLVED, that the Clerk to the Board shall forward a certified copy of this Resolution to the County Administrator and all twelve Mercer County municipalities.
