

INFORMAL MEETING OF JANUARY 26, 2021

MINUTES

Chair Frisby called the Agenda Meeting to order at 6:08 P.M. on January 26, 2021 through Zoom Video Conferencing.

ROLL CALL

The following members of the Board answered the Roll Call of the Deputy Clerk to the Board:

Present – Commissioners Cannon, Cimino, Colavita, Koontz, Melker, Walter and Frisby

Chair Frisby led the Pledge of Allegiance and Salute to the Flag.

SUNSHINE LAW

The Deputy Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meetings Law, notice of this Informal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

MOMENT OF SILENCE

Commissioner Koontz called for a moment of silence for Jim Peto, Hightstown High School Athletic Director.

Commissioner Walter called for a moment of silence for Donald J. Apai, Former Ewing Township Councilman.

COMMUNICATIONS

Two (2) communications were discussed and approved for placement on the Agenda for the Formal Meeting of January 28, 2021.

Chair Frisby made reference to the Communication from Lillian L. Nazzaro, Esq., County Administrator, regarding the Commissioner Questions for January 26, 2021. He thanked the Administration for adding the component that identified whether a business was minority-owned and or women-owned to the bids.

RESOLUTIONS

Fifty-five (55) proposed Resolutions were discussed and approved for placement on the Agenda for the Formal Meeting of January 28, 2021.

Chair Frisby made reference to the proposed Resolution authorizing to exercise the option to extend a Competitive Contract with Capital Area YMCA for the provision of "After School Programming". He announced that he would be abstaining from the vote on Thursday, because he was the Chief Executive Officer of the Capital Area YMCA.

Commissioner Colavita made reference to the proposed Resolution authorizing to execute a Competitive Contract with CONTACT of Mercer County, NJ, INC., for the provision of crisis and suicide prevention hotline services. He stated that he would be abstaining from the vote on Thursday, as he was the President of CONTACT of Mercer County, NJ, Inc.

Commissioner Walter made reference to the three (3) proposed Resolutions authorizing to execute a Professional Service Contract with the Firm of Genova Burns, LLC. She asked that the Commissioners be updated if any movement was taken on any of the litigation cases, before reading about them in the newspaper.

Commissioner Cimino made reference to the proposed Resolution authorizing to execute a Professional Services Agreement with Traffic Planning & Design, to provide engineering design services for the Rehabilitation of Mercer County Bridge No. 140.4 (N.J.D.O.T. Structure #1100-051) carrying Montgomery Street over the Assunpink Creek.. He acknowledged that the design services for bridge rehabilitation was roughly around the same cost as the design services for bridge replacements. He questioned if there was the same expectancy of life of the rehabilitation with the replacement.

Commissioner Walter and Commissioner Koontz made reference to the proposed Resolution authorizing to execute an Award of Bid received December 1, 2020 to Marbro Inc., for replacement of County Bridge No. 364.15 (Structure #11000084) carrying Locust Lane over Harry's Brook, located in the Municipality of Princeton. They inquired about the pricing of the bridge replacement.

OLD BUSINESS

Commissioner Cannon expressed that on Friday, January 29, 2021, Commissioner Cimino would be sworn in as New Jersey Association of Counties (NJAC) 80th President during their virtual Reorganization Meeting.

Commissioner Walter recommended a Resolution be added to the Agenda to recognize February 5th 2021 as Wear Red Day in Mercer County.

Commissioner Cimino highlighted that there was data released in an online article that suggested that Mercer County was in last place (21st) in regards to the vaccinations by county. He expressed that Mercer County needed to do better. He asked how many doses the County received.

Lillian L. Nazzaro, Esq., County Administrator, stated that the numbers change on a daily basis and she was unsure about the accuracy of the aforementioned article he was referring to. Nevertheless, she stated that she would give the Commissioners a brief update on how many vaccines were received by Mercer County from the State of New Jersey. She informed the Board that the numbers may not have been accurate due to a delay with Princeton inputting their numbers and names of individuals vaccinated into the New Jersey Immunization Information System (NJIIS).

Ms. Nazzaro announced that the County had received 23,197 vaccines and of that number, 13,336 vaccines have been administered already. She added that currently the County was received 800 vaccines per week from the State of New Jersey. She explained the number does not include the vaccines that Capital Health received. She added that Capital Health received about 1000 vaccines a week from the Regional Medical Center, which were being administered at the Cure Arena. She concluded that the County Executive had been in communication with the Governor's Office to request additional vaccines.

Commissioner Walter noted that administering vaccinations seem to be more efficient in counties where they sort of manage their registration site little tighter. She suggested that perhaps the State system that Mercer County used was overwhelmed or convoluted.

Chair Frisby acknowledged that Mercer County had moved from being the 21st County in New Jersey for number of vaccinations to 15th in the State. He commented that the County was still woefully behind other Counties that compare to Mercer County in size.

NEW BUSINESS

Commissioner Walter requested to the Administration that perhaps the Mercer County Directors provide their annual reports in digital format to conserve funds.

PUBLIC SECTION

At this time, Chair Frisby invited the members of the public to comment on any item listed on and off the Agenda.

Judith Hoechner, resident of Yardley, Pennsylvania, asked if the Resolutions that involve environmental consulting and testing services were related to testing on or adjacent to the Trenton-Mercer Airport. Ms. Nazzaro stated that the Resolutions did not relate to the Airport.

Susan Herman, President of Residents for Regional Traffic Solutions, Inc., inquired about the Questions and Answers Communication received from Ms. Nazzaro to the Commissioners.

Johnnie Whittington, resident of East Windsor Township, wished the Commissioners a Happy New Year.

Commissioner Walter asked for an update on the hearing for the OTR Appeal.

Michael Herbert Jr., Esq., Commissioner Counsel, stated that the OTR hearing had been postponed until further notice.

Commissioner Chair Frisby and members of the Board, thank you for having me. Each year I am pleased to come before you to discuss the condition of our great county. 2020 was a year unlike any we have seen in our lifetimes. Despite the turbulence, the state of Mercer County is strong, and I, and my steadfast administration, persist each and every day to make Mercer County even stronger and more vibrant.

One way the pandemic has changed the way we do business is that we are forced to meet remotely, in venues such as this ZOOM call. Tonight, I will keep the radius tight by touching on the high points of my priorities for Mercer County.

A full copy of my remarks will be available on our website. (mercercounty.org).

For the time being, **confronting COVID-19** is our greatest mandate, but my eyes are on the future, and on a series of complex projects and initiatives that my administration will tackle over the next five years.

My 5-year projection can only be achieved through longterm commitments to time and resources, and we are pressing forward to complete projects and to kick off others as quickly as possible.

Before I go on I want to touch on our response to COVID-19. As I said, 2020 was unprecedented in countless ways. For close to a year we have lived through a global pandemic that already has claimed the lives of more than 429,000 people in the United States and more than 790 people here in Mercer County. It has impacted every person in our communities in some way -- especially those most vulnerable to this virus – and continues to do so.

The arrival of vaccines has provided a path out of the darkness. We are prepared for this phase of the response, and are working with our health care partners to vaccinate people as quickly as possible.

With Capital Health we opened a vaccination site at the CURE Arena in Trenton, and in a few weeks will open a second vaccination site at Mercer County Community College.

The only thing holding us back is the amount of vaccine we are allotted. Look, the Trump Administration blew it, with states, including our own, promised doses that were never received.

Let me be direct. I know that this board is frustrated with the vaccine distribution logistics. I join you in your angst. But even before there was a vaccine, my administration and our public health experts strategically identified clinic sites and I personally petitioned Governor Murphy to make the Capital City – Trenton – in the Capital County, one of his SIX mega sites.

Although Trenton was not selected as a mega site, we proactively made a backup plan to partner with Capital Health for a regional site, and I thank Capital for their commitment.

So we are clear, not a day goes by that I don't compel the state to increase our supply. To that end, I am extremely happy to announce that beginning next week, Mercer County will get 700 more vaccine doses per week, for a total of 1,500, not including those received by Capital Health, pharmacies, doctors and private clinics.

This is promising news but **the fact remains** that New Jersey needs more vaccine from the federal government, on

which we rely. We must work together, and when the vaccine supply improves, we will move forward as rapidly as we can.

In the meantime, we continue to rely on the heroic efforts of health care professionals and first responders throughout the county, as well as other essential workers who found themselves on the front lines. I'm proud of the people who have done that heavy lifting for us, and I thank them.

I also could not be prouder of our Mercer County workforce. Thanks to their efforts, County government has continued to deliver programs and services despite the many obstacles presented by the pandemic.

While our focus in the coming months will continue to be on vaccinating and testing, we will turn our attention to a number of long-range endeavors that have been slowed or sidelined. I am excited to bring them to fruition.

One initiative is our Open Space Trust Fund.

For the last 30 years the County has had a successful land preservation program, utilizing the Open Space Trust Fund acquisition funds while making modest but important improvements to our parks and stewarding our parks and County-owned open spaces.

I am proposing a voter referendum to permit the reallocation of the fund with greater emphasis on stewardship.

Let me be clear. This proposes no tax increase, but simply a

reallocation, to help ensure the health of the land entrusted to us. This shift would benefit our award-winning park system.

Speaking of which, there are several exciting park construction/development initiatives – either new or under way – that I believe will be brought to fruition in the next five to 10 years, including **Dam Site 21** in Hamilton; **Moores Station Quarry** in the Hopewell Valley; and **Princeton Country Club** in West Windsor. You will be hearing much more about these projects in the coming year.

The pandemic also created setbacks for a number of infrastructure projects, including the Lincoln Avenue Bridge in Trenton, the Brunswick Circle Extension in Lawrence,

and the Phase 1 Improvements on **Princeton-Hightstown**Road in West Windsor. These projects are a few of the more

than 20 projects currently in the pipeline.

It's no secret that leisure travel has taken a hit from the pandemic, but Frontier Airlines continues to operate flights to Florida and Atlanta at Trenton-Mercer Airport. However, with widespread vaccine distribution on the horizon, the outlook for the airport is good.

While the process may have been slowed, it is my intention to move forward with the replacement of our outdated airport terminal. We will have further updates soon.

In the meantime, and for as long as it takes, we will continue to put every ounce of effort we can muster into fighting the pandemic. I ask that everyone exercise patience while the vaccination process moves forward. If we work together, we WILL get through this crisis.

Thank you, board members, for your time tonight. I am proud to be County Executive of the Greatest County. I look forward to working with you to continue moving this County forward and improving the quality of life for our residents and visitors. Thank you.
