MERCER COUNTY BOARD OF COUNTY COMMISSION FORMAL MEETING OF MAY 13, 2021 MINUTES

Chair Frisby called the Formal Meeting to order at 6:00pm on May 13, 2021 through Zoom Video Conferencing.

The following members of the Commissioners answered the Roll Call of the Clerk to the Board:

Present – Commissioner Cannon, Cimino, Koontz, Melker, Walter and Frisby.
Absent – Commissioner Colavita
The Clerk to the Board read the Invocation.
Chair Frisby led the Pledge of Allegiance and Salute to the Flag.

The Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meeting Law, Notice of this meeting has been mailed to The Trenton Times, The Trentonian, and the Princeton Packet newspapers, as well as having been posted in the Courthouse and the Administration Building at least 48 hours in advance of this meeting.

Both adequate and electronic notice of the meeting has been provided, specifying the time, place, and manner in which such notice was provided.

PRESENTATION:

The following individuals discussed the economic impact study and community services at Mercer County Community College:

Mark Matzen, Kevin Drennan, Kyla Malloy, and Dr. Jianpping Wang.

Commissioner Walter asked if there was break out done and the economic effects on the Trenton campus.

Ms. Malloy responded that there was no campus break out in the analysis.

Commissioner Walter stated that she would be interested to see the break out for Trenton because the former County Executive wanted to close that campus, however, the County Commissioner Board fought to keep the campus open. She commended the individuals for attracting more programs at the campus.

Dr. Wang said the Trenton campus received the Good Neighborhood Award from New Jersey Business Industry Association.

Chair Frisby advised the college to conduct a real estate study for the Trenton campus.

Dr. Wang said she is pleased to report that several students have been accepted to Princeton, New York University, Cornell, Smith College and Harvard.

Chair Frisby requested a copy of the power point presentation.

At this time, Chair Frisby invited the public to speak on any item listed on the Agenda.

Judith Hoefner, resident of Yardley PA, referenced the Resolution authorizing the issuance and sale of up to \$61,794.000 of general obligation bonds, series 2021 of the County of Mercer, New Jersey; making certain covenants to maintain the exemption of the interest of said bonds from federal income taxation, and authorizing such further actions and making such determinations as may be necessary or appropriate to effectuate the issuance and sale of the bonds. She questioned why would bond issuance not be an Ordinance on the ballot and if the funds would be used for airport projects.

Dave Miller, CFO/Treasurer said airport projects consist of phase I on the control tower, construction on maintenance building, matching funds for grants with the expectations that passenger facility charges would reimburse several projects.

Chair Frisby asked are the projects new.

Mr. Miller responded that the projects were adopted in 2018. The reason the Resolution is not listed on the ballot was because that is not the methodology New Jersey follows to adopt bond ordinances.

MERCER COUNTY BOARD OF COUNTY COMMISSIONERS INFORMAL MEETING OF MAY 11, 2021 MINUTES

Chair Frisby called the Agenda Meeting to order at 6:01 PM on May 11, 2021 through Zoom Video Conferencing.

ROLL CALL:

The following members of the Board answered the Roll Call of the Clerk to the Board:

Present - Commissioners Cannon, Cimino, Melker, Koontz, Walter and Frisby

Absent- Commissioner Colavita (arrived at 6:19 PM)

The Clerk to the Board read the Invocation.

Chair Frisby led the Pledge of Allegiance and Salute to the Flag.

SUNSHINE LAW:

The Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meeting Law, notice of this Informal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspaper as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

Both adequate and electronic notice of the meeting has been provided, specifying the time, place, and manner in which such notice was provided.

COMMUNICATIONS:

Nineteen (19) Communications were discussed and approved for placement on the Agenda for the Formal Meeting of May 13, 2021.

Commissioner Walter made reference to the Communications regarding supporting S-3522 to establish a new Board of Trustees for the Local Part of the Public Employees Retirement System (PERS) to preserve the structure and integrity of the more solvent local part. She suggested that the Commissioner Board and the County Executive create a Resolution supporting Senate Bill 3522.

Lillian Nazzaro, County Administrator, noted that the County Executive would support this joint Resolution.

RESOLUTIONS:

Thirty-one (31) Resolutions were discussed and approved for placement on the Agenda for the Formal Meeting of May 13, 2021.

Commissioner Walter made reference to the Resolution regarding the authorization of issuance and sale of up to \$61,794.000 of general obligation bonds, series 2021 of the County of Mercer, New Jersey; making certain covenants to maintain the exemption of the interest of said bonds from federal income taxation, and authorizing such further actions and making such determinations as may be necessary or appropriate to effectuate the issuance and sale of the bonds. Commissioner Walter asked about any large projects being funded that to date, were not fully funded, and now this is the funding for the project.

Dave Miller, CFO/Treasurer, responded that there were about \$4 million open space, \$1.5 to \$1.7 parks improvements, and \$4 million miscellaneous projects that have not been fully expended.

Commissioner Walter made reference to the Resolution supporting Assembly Bill 4284 which establishes the Crime of a Law Enforcement Officer for choking another person. She stated before we add the Resolution, she questioned if the Mercer County Police Academy are teaching officers chokeholds. Chair Frisby also questioned the procedures for chokeholds and asked if training was being performed at the academy.

Ms. Nazzaro responded that at the Mercer County Police Academy, the recruits are instructed that chokeholds are completely barred and that this has been the instruction for many years. The recruits are taught against "positional asphyxiation" which occurs when someone's position prevents the person from breathing adequately.

Commissioner Walter made reference to the Resolution authorizing a Professional Service Agreement with Trimboli & Prusinowski, LLC, for professional legal services regarding labor issues at the Office of the Mercer County Sheriff in the amount of \$100,000.00 for the period of April 1, 2021 through March 31, 2022. She asked for an update on how much was expended from this contract in the past two (2) years.

Commissioner Walter made reference to the Resolution authorizing an agreement of sale for the purchase of property from Gary P. and Nancy Buck, known as 1 Ridge Avenue, Ewing NJ 08628 and identified as block 423, lot 110 on the municipal tax map for Ewing Township, purchase price \$280,000.00; estimated purchase price differential, moving, and closing costs: \$36,000.00 –total cost not to exceed: \$316,000.00. She noted that it is inappropriate that properties are removed from tax rolls without compensation to the Township. Although she did not oppose the purchase, she did oppose the mechanism that does not reimburse the Townships which properties were removed from tax rolls indefinitely. She asked to separate the Resolution and that she would not vote.

OLD BUSINESS:

Commissioner Cimino made reference to the communication supporting S-3522 to establish a new Board of Trustees for Local Part of the Public Employees Retirement System (PERS) to preserve the structure and integrity of the more solvent local part. He noted that New Jersey Association of Counties (NJAC) has provided authorization to the Executive Director that if the legislature and the governor do not act accordingly to support County government for NJAC to file a lawsuit for unfunded liability that would be available on some of the programs coming from the State. He noted that several legislators support NJAC's decision to act on the unfunded mandates that are coming.

Commissioner Walter spoke about the attendance of members who serve on Mercer County Boards and Commissions. She referenced the Administrative Code 301050 amended by Ordinance No. 77-50 attendance at meeting – "failure to attend 3 consecutive scheduled meetings without reasonable justification shall be grounds for removal of any board member from his/her respective board - such removal shall be initiated by the County Executive, but should not be final without the approval of Board of County Commissioners". She was concerned that boards were able to fully function and that board members should commit to attending meetings. She was told that there was no attendance policy code.

Commissioner Melker asked for an update on reviewing the purchase of voting machines.

Ms. Nazzaro said between the Administration, County Commissioners, Board of Elections, Superintendent of Elections and the County Clerk, a decision would be determined on the type of voting machines. She said the Commissioners would be able to provide their input on the machines.

NEW BUSINESS:

Chair Frisby stated that the next meetings would take place in -person held at 640 South Broad Street- Room 211, and noted that COVID restrictions would be implemented with staying 6 feet apart.

At this time, Chair Frisby invited the members of the public to comment on any item listed on and off the agenda.

There was no public comment.
