

# ORDINANCE NO. 2021-2

THE BOARD OF COMMISSIONERS OF THE COUNTY OF MERCER, NEW JERSEY DOES ORDAIN AS FOLLOWS:

1. As approved in the annual budgets, the annual salary of the County Executive, County Administrator, Deputy County Administrator, Warden, Human Services Director, Planning Director, Personnel Director, Economic Development and Sustainability Director, Mercer County Clerk, Mercer County Surrogate, Mercer County Sheriff, Mercer County Commissioner Chair, and Mercer County Board of Commissioners, shall be established in accordance with the following schedule:
