Your First Stop for Business Answers

Whether you're an established business or a start-up, the Mercer County Office of Economic Development is here to assist you in answering questions about government programs and public and private business opportunities.

Through this Handbook, you will find available programs at the federal, county, state and municipal levels for businesses. As always, the Mercer County Office of Economic Development should be your "first stop" in answering questions or directing you to the proper resources found in Mercer County and throughout the State of New Jersey. Please do not hesitate to contact our office with any business-related question.

Included in the Handbook is information that pertains to the economic development programs at the county level. You will learn about the small-business lending program of the Mercer County Loan Fund, which provides loans to small businesses ranging from \$25,000 to \$250,000. You will also learn of the county's small-business counseling program. Through knowledgeable professionals, the program guides start-ups and small businesses through business requirements and local resources, potential bidding opportunities on municipal and county contracts, and available financing programs from private lenders. Finally, you will be able to learn of the on-the-job training program offered through the County One-Stop Career Center that features partial salary reimbursement for new hires.

Financial Assistance Programs for Businesses Mercer County Loan Programs

UCEDC

Mercer County has partnered with the UCEDC on a County Business Lending Program. These loans come in a variety of different forms and include the following:

Crisis Loan Program:

Mercer County recently partnered with the UCEDC on a County Business Lending Program. In addition to the lending options offered under this program, UCEDC is now offering a low-interest, quick-response, working capital loan program in response to COVID-19. Small business owners can borrow up to \$15,000 at 2% for up to five years with no collateral requirements to meet their COVID-19 crisis needs.

The Crisis Relief Loan Program is designed to provide broad access to much-needed working capital. The program features a quick turn-around (after completing the application requirements), no collateral requirements, no pre-payment penalties, and no processing or application fees.

Eligibility Requirements:

- Business impacted by the COVID-19 pandemic
- Businesses in existence at least two years and with a credit score of 680 and up are eligible to apply for up to \$15,000
- Businesses in existence between one and two years, or with a credit score between 650-680 are eligible to apply for up to \$10,000
- Profitable prior to the COVID-19 crisis
- No loan or credit card charge –offs within 3 years

Application Requirements:

- Personal guarantees of all owners with more than 10% ownership interest
- Completed UCEDC Loan Pre-Qualification form for all guarantors
- Copy of driver's license
- Personal cash flow statement
- Personal financial statement
- 2018 complete business tax returns (2019 if already available)

Microloans:

General Microloan: loans up to \$50,000 at a fixed rate (5.25% - 8.25%) for up to six years with as little as 10% down. Click here for more information.

- Rapid Response Loans: loans up to \$10,000 (no collateral required) with a decision in two days or less. Click here for more information.
- Prime Lock Loans: loans up to \$25,000 (no collateral required) in which you can lock in your prime interest rate for up to five years (currently 3.25%). Click here for more information.

Women-Owned Business Loans:

- **Tory Burch Foundation Loans:** loans up to \$50,000 to women owned businesses with a 2% interest rate reduction. Long-Term Loans:
- **SBA 7(a) Community Advantage Loans:** loans from \$50,000 up to \$250,000 for a term of 7-20 years are available to existing businesses. Loans from \$50,000 up to \$150,000 for a term of 7-20 years are available to start-ups.

The **Capital Financing Program** is designed to supply organizations such as municipalities, schools, fire districts and nonprofit organizations with cost-effective financing to meet project-specific capital needs. Typical purchases include new buildings, improvements to existing facilities and land.

The Mercer County Improvement Authority (MCIA) will help these qualified organizations find the best possible financing vehicle for their particular projects. You can also benefit from the MCIA legal status and frequent market exposure. In addition, the Authority will negotiate your capital needs with financing professionals and will represent you at the required agencies' hearings. Upon request, the MCIA will also conduct the bidding process and manage and oversee the construction projects financed through the Authority.

To get started, you will need to complete and submit an application for financing, which can be found on the MCIA website at www.mcianj.org. Upon receiving the application, the MCIA will contact you to discuss possible financing options, repayment schedules and costs associated with the particular transaction.

The MCIA team of project management professionals can provide design, contract administration and construction management services. Additionally, the County Improvement Authorities Law allows the MCIA to act as the redevelopment entity for various redevelopment areas throughout the county. As such, the MCIA facilitates commercial and residential redevelopment with innovative approaches that solve complex development issues.

New Jersey Economic Development Authority



The Economic Development Authority (EDA) offers a wide variety of financial assistance programs to businesses located in New Jersey. The EDA can provide businesses with low-interest financing through bonds, loan participations, loan

guarantees and direct loans with either variable or fixed interest rates. Most importantly, the EDA offers longer repayment schedules than those offered by traditional lenders.

Below is a brief overview of some of the programs that are available:

1. Bank Partnerships

EDA partners with banks across New Jersey to provide low-interest financing through loans, loan participations and guarantees, and line-of-credit guarantees to lower the cost of borrowing.

2. Bond Financing

Through the proceeds from tax-exempt private activity bonds, financing can be used by qualified manufacturing firms and not-for-profit organizations for real estate acquisition, new equipment and machinery, and building construction and renovations, as well as working capital for not-for-profit organizations.

3. Direct Loans for Small and Mid-size Businesses

EDA can offer low-interest loans for fixed assets or working capital for businesses that have not yet engaged a bank on potential financing, or are working with a bank. Up to \$2 million is available for fixed assets or up to \$750,000 for working capital for up to 10 years with a fixed or variable interest rate.

4. Small Business Fund

Creditworthy small, minority-owned or women-owned businesses in operation for at least one full year that may not have the ability to get financing or not-for-profit corporations in operation for at least three full years may be eligible for direct loans of up to \$500,000 under the Small Business Fund.

5. Access to Technical Assistance

EDA has formed a partnership with the UCEDC to assist and finance small businesses.

6. Technology-Focused Programs

EDA offers a continuum of assistance for technology and biotechnology companies at every stage of growth. From networking and mentoring to financial assistance such as loans and tax credits.

7. Business Advocacy

The State's Business Action Center (BAC) can help your business cut through red tape with professional and coordinated assistance in the resolution of permit applications, licenses, certificates and other business-related approvals.

8. The Emerge Program

Created under the Economic Recovery Act (ERA) of 2020, this program encourages economic development in Governor Murphy's priority sectors and in targeted communities across New Jersey. The program provides per-job tax credits to projects that invest private capital into the state and create new, goodpaying jobs (or retain a large number of good-paying jobs).

9. Aspire Program

Aspire is a gap financing tool to support commercial, mixed use, and residential real estate development projects that replaced the Economic Redevelopment and Growth Grant (ERG)

10. New Jersey Innovation Evergreen Fund (NJIEF)

NJIEF is a partnership with the private sector that will raise and invest funds in New Jersey-based companies to address New Jersey's shortfall in venture capital funding and create the conditions necessary for entrepreneurs to succeed. Professional, institutional venture capital investors can apply and those that meet the NJEDA criteria will have access to up to \$10 million per year to invest in New Jersey-based companies in innovative industries.

11. The Historic Property Reinvestment Program

This is a \$50 million competitive tax credit program to leverage the federal historic tax credit program to support rehabilitation projects of identified historic properties.

New Jersey Redevelopment Authority

The New Jersey Redevelopment Authority (NJRA) provides urban centers with opportunities to create functional public/private partnerships, to leverage funds for entrepreneurial growth and job creation, and to enhance community empowerment. The Mercer County municipalities where businesses are eligible for financing are Trenton, Ewing and Hamilton.

New Jersey Redevelopment Investment Fund (RIF)

The NJRA manages this flexible investment fund that provides debt and equity financing for business and real estate ventures. Through the RIF program, the NJRA is able to offer direct loans, real estate equity, loan guarantees and other forms of credit enhancements.

To request financing through the RIF program, please visit the New Jersey Redevelopment Authority website at www.njra.us and submit the information requested in the NJRA Funding Assessment Guidelines.

Bond Program

The NJRA offers creative bond financing solutions to companies seeking financing for capital improvements and expansions. The NJRA acts as a conduit by issuing its qualified small-issue bonds for the purpose of acquiring or constructing capital facilities for qualifying borrowers so that the borrowed funds (bond proceeds) can be treated as tax-exempt.

The NJRA sells bonds to raise capital for making long-term loans at attractive, below-market interest rates to a broad range of qualified businesses and not-for-profit organizations. The NJRA has the ability to issue \$100 million of taxable and tax-exempt bonds annually to stimulate revitalization in New Jersey urban areas.

To qualify for tax-exempt bond financing, you must meet the eligibility requirements outlined in the Internal Revenue Code (IRC) including:

- Manufacturing/processing facilities
- Governmentally owned public airports, docks, wharves
- Facilities that furnish water, electric, and gas; sewer facilities; and solid waste disposal, including certain recycling facilities
- Certain facilities for governmental bodies, which qualify as tax-exempt governmental obligations
- Certain not-for-profit 501(c)(3) entities, including service organizations, educational institutions and health care facilities
- Certain assisted living facilities, which qualify as residential rental projects.

Registering Your Business

State of New Jersey

Depending on the type of business you operate, you will need to take one or two steps for your business to be properly registered in New Jersey. For information on the registration process, please visit the NJ Department of Treasury website and use the following link: http://www.state.nj.us/treasury/revenue/busregcert.shtml.

All businesses must register for tax purposes.

If your business is a legal entity such as a corporation, limited partnership or limited liability company, you must file formation or authorization documents for the public record. General partnerships and sole proprietors are not subject to this first step.

Registering New Business Entities

This first step applies to all New Jersey (domestic) and out-of-state (foreign) corporations, limited liability companies, limited partnerships and limited liability partnerships. You must file an original formation/authorization certificate with the State of New Jersey. The filing process can be completed online. All profit businesses (domestic and foreign) and foreign nonprofits must pay a filing fee of \$125. The filing fee for domestic nonprofits is \$75. If you choose not to register online, you may download the forms and instructions, which are found in the Business Registration Packet.

Registering All Businesses for Tax & Employer Purposes

This next step applies to all businesses. You must file Form NJ-REG to be registered for tax and employer purposes. The online registration is available on the Department of Treasury website.

Filing Form NJ-REG ensures that your business is registered under the correct tax identification number and that you will receive the proper returns and notices. Normally, you will use your federal identification number (FEIN) as the New Jersey tax identification number. A business with employees must obtain a FEIN. If you do not have a federal identification number for your business, you may apply for one as you fill out the online NJ-REG or you may apply directly to the IRS online.

If you are subject to the entity formation/authorization filing above, you may submit both the business entity and the tax registration filings together. The NJ-REG, however, must be filed within 60 days of filing the new business entity if the registrations are submitted separately.

If you choose not to register online, you may download the paper forms and instructions, which are found in the Business Registration Packet.

Proof of Registration

Businesses planning to contract with any public agency in New Jersey, including state agencies, local governments, colleges/universities and local school boards as well as with casino licensees, will be required to provide a Business Registration Certificate as proof of registration. To obtain a Business Registration Certificate, you must have filed Form NJ-REG.

Choosing a Name for your Business

Before choosing a name, you may review business names on file with New Jersey online, free of charge. If you want assistance in checking the availability of a business name, you may call the Division at (609) 292-9292. Fees apply for this service.

County of Mercer

All new businesses established in Mercer County can file a Trade Name Certificate with the Mercer County Clerk's Office. (Please note the Trade Name Certificate is only for small businesses and nonprofit churches). Banks generally require businesses to register a trade name before opening a business checking account. The Trade Name Certificate can be purchased for \$50. You can receive an electronic version of the application by clicking on the Mercer County website under County Clerk's Office or by contacting the Business Advocate at (609) 989-6912.

Municipal Business Registration

Depending upon the location of your business, you may be required to file a registration application with that municipality. Following is a complete list of the municipal clerk offices in Mercer County.

Mercer County Planning Department

In addition, you may also need to contact the Planning Department at the County of Mercer for further oversight and approvals. The Mercer County Planning Board reviews and approves development applications as administered by the Mercer County Land Development Committee. A municipal approving authority will not issue final approval to a subdivision or site plan requiring Mercer County Land Development Committee approval until final County approval is granted. All subdivisions of land within Mercer County need to be submitted for review to the Mercer County Land Development Committee.

Specifically, site plans that require Mercer County Land Development Committee review are plans that:

- a. abut a county road or county drainage structure.
- b. do not abut a county road or county drainage structure which contain one or more acres of impervious surfaces.
- c. do not abut a county road or county drainage structure that contain less than one acre of impervious surfaces but:

Mercer County Foreign Trade Zone

The County of Mercer and its Office of Economic Development are responsible for the administration of the Mercer County Foreign Trade Zone (FTZ). As a business in Mercer County, you may be interested in learning about the advantages of this program. The Mercer County FTZ service area encompasses all of Mercer County. A designated FTZ operator is legally considered outside of Customs territory for the purposes of duties, so goods may be brought into the site duty-free and without formal customs entry.

FTZs are a tool that Mercer County businesses can use to increase their international competitiveness, lower costs and boost profits.

Benefits include:

Duty Reduction - In most cases, duties are higher for parts than for finished products. In an FTZ, a company can import parts duty-free, assemble a product, and then only be required to pay the lower duty rate on the final product.

Duty Elimination - Customs duties are never paid on goods that are brought into an FTZ and then re-exported or scrapped.

Duty Deferral - Since FTZs are considered outside Customs territory, goods are not considered imported until they leave the zone facility and enter the U.S. stream of commerce. As a result, duties are deferred as long as they are in the zone facility.

Weekly Entry - FTZ "Weekly Entry" procedures can help zone users save time and money. Under this aspect, the zone user files only one Customs entry per week, rather than filing one Customs entry per shipment.

Logistics Flexibility - Products made overseas for overseas markets may be brought into an FTZ for storage or consolidation with other products, allowing distribution of complete shipments to customers. This not only provides flexibility for the company but can improve supply chain velocity.

Employer Incentive Programs On the Job Training (OJT) Program

An employer provides job-specific training as well as long-term employment and benefits to new employees who are Work First New Jersey clients. For incurring training costs and lost production time, the employer is reimbursed 50% of the new employee's wages. OJT allows for the custom training of new employees, thereby offsetting employer training costs while helping the employee to acquire the training and skills necessary to satisfy job requirements. The employer gains a new hire at a reduced rate for up to six months and the jobseeker gains employment and training for his or her new position.

- Provides reimbursement to the employer for costs associated with training the new employee in the skills needed to perform the job.
- Reimbursement is provided for 50% of the employee's wages during the training period, which can be from six to 26 weeks.
- The training period depends on the complexity of the job to be learned, skill level of the individual, and other qualifications.
- The position must be full-time permanent employment with a starting salary of a minimum of \$8 per hour based on a 35- or 40-hour work week.
- All OJT trainees must be determined to be eligible consistent with Workforce Investment Act and other regulations prior to the start of the contract.
- OJT trainee must complete the full training period and continue employment after training to qualify the employer for full reimbursement.
- Employer is required to maintain performance evaluations, attendance and payroll records.
- The OJT trainee must receive the same wages and benefits as those in comparable positions. In addition, the company may not have had any layoffs for at least 120 days prior to the commencement of the contract.
- The OJT contract must be in place prior to the new employee start date.

Small Business Outreach Program

Our mission is to contribute to the growth and economic development of the small business community by increasing Mercer County government procurement opportunities for small businesses.

In July of 2018, Mercer County Executive Brian M. Hughes and the Mercer County Board of Chosen Commissioners passed **Ordinance No. 2018-5** establishing a Mercer County Set-Aside Program. The program reserves 10 percent of the dollar value of all the County's goods, which total more than \$70 million USD in professional services and construction contracts each year to the following businesses: 30 percent for qualified minority-owned businesses; 30 percent for qualified women-owned businesses; 30 percent for qualified veteran-owned businesses; and 10 percent for small businesses. To qualify, businesses must be incorporated or registered with the Division of Revenue & Enterprise Services to do business in the State and have their principal place of business in Mercer County, New Jersey.
