INFORMAL MEETING OF MARCH 22, 2022

MINUTES

Chair Melker called the Agenda Meeting to order at 6:02PM on March 22, 2022 in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street, Trenton, New Jersey.

ROLL CALL:

The following members of the Board answered the Roll Call of the Clerk to the Board:

Present – Commissioners Cimino, Frisby, Koontz, Stokes, and Melker Absent – Commissioners Frisby and McLaughlin

SUNSHINE LAW:

The Clerk to the Board announced that in accordance with the provisions for the New Jersey Open Public Meeting Law, notice of this Formal Meeting has been mailed to The Trentonian, The Trenton Times, The Princeton Packet newspaper as well as having been posted in the County Administration Building and Courthouse at lease forty-eight (48) hours in advance of the meeting.

PRESENTATION:

At this time, the Board invited James Chambers Jr., MBA, Coordinator of Business Outreach to address the Board.

Mr. Chambers appeared before the board to present the Mercer County Disparity Study. He explained that the program provides a direct connection to local, state and federal businesses for minority, veteran, and women-owned small businesses who qualify for an opportunity to expand their client base and grow their businesses through the Mercer County "Set-Aside Program." He stated that County Executive Brian M. Hughes presented twelve (12) business owners with the 2022 Mercer County Unstoppables certificate of recognition. Mr. Chambers added that the businesses opened their physical locations during the pandemic. He discussed how he was notifying individuals to apply for the program.

The Board thanked Mr. Chambers for the presentation and requested a breakdown of the disparity study.

Commissioner Stokes asked what was the process for businesses to apply for the program.

Mr. Chambers responded that he was committed to educating businesses and urging them to participate in the County program.

COMMUNICATIONS:

Five (5) communications were discussed and approved for placement on the Agenda for the Formal Meeting of March 24, 2022.

RESOLUTIONS:

Twenty-nine (29) proposed Resolutions were discussed and approved for placement on the Agenda for the Formal Meeting of March 24, 2022.

Commissioner Walter made reference to the proposed Resolution to Amend Resolution No. 2021-642, adopted December 9, 2021 and authorize the County Executive and Clerk to the Board to execute Amendment No. 1 to the Grant Award Contract with the New Jersey Department of Human Services, Division of Mental Health and Addition Services for the 2022 Mercer County Comprehensive Alcoholism and Drug Abuse Service Contract – amend Resolution to include additional funds in the amount of \$200,000.00

(state funds) for the period of February 28, 2022 through December 30, 2022- revised total amount: \$1,090,435.00 (\$987,828.99; \$102,607.00 (County match). She asked if the County had the van already.

Lillian L. Nazzaro, Esq., County Administrator, stated that the County would put the program out for bid and the van would be purchased by the agency implementing the program.

Michael Herbert, Esq., made reference to the Resolution authorizing to execute a Professional Service Contract with the Law Firm of Parker McCay, P.A. to provide certain legal services necessary in connection with the authorization and issuance bonds or notes by the County of Mercer for the period of January 1, 2022 through December 31, 2022 in the amount of \$125,000.00. He stated for the record his non-participation on the Resolution due to him working for Parker McCay, P.A.

Commissioner Koontz made reference to the Resolution acceptance of Deed of Dedication from West Windsor Township to the County of Mercer for the purpose of improvements at the intersection of Old Trenton Road and Edinburg Road, property block 25, lot 22, Old Trenton Road, West Windsor no County funds. He asked what was the plan to improve the intersection.

Ms. Nazzaro responded that the project involves widening of Edinburg Road to add a dedicated right turn lane from Edinburg Road (CR526) to Old Trenton Road (CR535). She stated that there would be upgrades to the traffic signal system at the intersection, which would include a video camera detection system and a new timing plan to coordinate signals at Old Trenton Road (CR526). She said there would also be installation of a new concrete curb, sidewalk, signage, road striping, storm water drainage pip and inlets.

Commissioner Walter made reference to the Resolution for the rejection of bids received February 15, 2022 for furnish and install of commercial washers and dryers for the Mercer County Correctional Facility. Commissioner Walter inquired about the water situation at the Correction Center. She asked if the Correction Center was still on water restriction and if so, why would the County install the washers and dryers.

Ms. Nazzaro responded that the Correction Center is no longer on water restrictions since the population has decreased significantly. She said the washers and dryers would be

used for inmates undergarments and socks. She added that heavy duty items such as blankets and jumpers would continue to be sent out for laundry service.
