#### **PROJECTS UPDATE:**

(Deputy Director, Joe Pizza)

- 2020 Annual Day of Golf-Mercer County Park Commission Golf Courses are scheduled to host the 2020 Annual Day of Golf on March 6, 2020.
- Princeton Country Club Restrooms Renovation-The renovation project for the restrooms located at the Princeton Country Club facility has been completed.
- Moore's Station Quarry Master Plan RFQ On February 18, the review committee held interviews with firms who submitted requested qualifications. Three (3) teams have been invited to attend a site visit to the quarry on March 3; and then will be given the opportunity to submit proposals by March 23. Based on staff review of the proposals, a final recommendation will then be presented to the Park Commissioners for consideration at a future meeting.
- Challenge Ropes Course Ropes course engineers are in the process of developing design specifications, based on research provided by outdoor adventure course operators.
   A proposal has been submitted for consideration to expand the design scope to include a zip line into the course design.
- Henry Phillips Barn West Wing Rehabilitation Project The Purchasing Department has provided a draft of the bid package, as well as a tentative bid schedule, which are currently under review for finalization to advertise for public bidding. Purchasing will determine the Schedule of Values parameters and determine new dates.
- Mercer Oaks Clubhouse Door Replacement Public Bids were opened and read on February 21, 2020. Five (5) firms submitted bids for the project; two (2) bids were under the cost estimate. The low bidder was 1<sup>st</sup> Line Locksmith; the second lowest bidder was Padovani Construction.
- Paving Mercer Stables Driveway and Problem Areas of Mercer Meadows / LHT
   Trails (Mount Construction, \$1,895,093.20, 180 Calendar Days from Notice to Proceed) Formal Notice to Proceed is anticipated to be issued early next month.
- Stony Brook Pedestrian Bridge Construction of other sections of trail and boardwalk are moving forward. Contracted consulting firm, Engineering and Land Planning (E&LP) will provide a cost estimate for modifications required to bolster rainwater management in certain areas; the firm is considering some stonework and additional boardwalk.
- **MCP Festival Grounds Concession** –The sewer line will need to be completed prior to the start of Phase 1 of the project. It is anticipated that Phase 2 Sewer Line project will begin in the Spring of 2020; and the Concession project will begin construction in the Fall of 2020.

- Mercer Lake Bank Restoration Following a request by the Park Commission, contracted consulting firm, Engineering & Land Planning (E&LP) has revised project specifications to allow for additional lake view frontage to accommodate regattas and Princeton National Rowing Association events. E&LP's revised proposal includes an expanded Scope of Services to accommodate the request along with provisions to secure new permits from New Jersey Department of Environmental Protection (NJDEP). The revised proposal is currently under review by Executive Staff for consideration on the subsequent Mercer County Park Commission Public Meeting Agenda.
- Mercer County Park Spray Park This project was awarded at the December 4, 2019 Park Commission Meeting to contractor, V&K Construction, \$478,648.00, 180 Calendar Days from formal Notice to Proceed. Formal Notice to Proceed will be issued upon confirmation that permitting has been finalized. It is anticipated that work will begin in March 2020.
- Replacement of a Pre-flight Cage at Mercer County Wildlife Center Specifications are currently being developed by contracted consulting firm, Saphire & Albaran. Our office is additionally awaiting confirmations from the D&R Canal Commission for finalization of the project site.

#### **NEW INITITAVES:**

Dam Site 21- Contracted consulting firm, Simone Collins is currently finalizing a narrative report and print final copies of the Master Plan for distribution. Next Steps will include working with Simone Collins to identify the components for each phase of the proposed improvements to the Dam Site.

#### **2020 NJRPA AWARDS**
