#### **EXECUTIVE DIRECTOR'S REPORT**

#### **GOLF**

- August Rounds of play as well as Memberships are up over 2019 figures. In August we recorded 20,265 rounds / 17,423 in 2019. And membership increased from 450 (2019) to 691 (2020). Golf outings have resumed at Mercer Oaks East, West and Mt. View. Outings will continue through mid-October.
- Overall 2020 revenue still trails 2019 figures by 11%, due to course closures in the Spring. This despite the fact we have been experiencing peak attendance at all our courses throughout the summer.

#### **TENNIS**

- 1,010 Tennis/Pickleball ID membership continues to grow. 1,010 ID cards have been sold to date.
- The Mercer County Fall Tennis League regular season concludes on September 27<sup>th</sup>, 343 players participated. Playoffs will begin October 3 31.
- Our Indoor tennis center is scheduled to re-open on October 1<sup>st</sup>. To date,101 indoor courts dates have been sold.

#### **RECREATION AND EVENTS**

#### Spray Park

On September 25, the Park Commission held a ribbon-cutting for the new Spray Park, located adjacent to Lakeside Village Park and the Boathouse Marina. The spray park will be open to the public on Fridays, Saturdays, and Sundays from 11 a.m. to 4:45 p.m., weather permitting:

#### - Drive in Movie and Concert Events

The Recreation & Events Department, in partnership with our Park Maintenance & Rangers, are in the final stretch of a wildly successful five (5) week drive-in events series.

# o Drive-In Movie Nights:

Since the first Friday of September, we have hosted weekly drive-in movie nights featuring "Harry Potter & the Sorcerer's Stone", "Moana", "The Addams Family" & "Sonic the Hedgehog", which was our first movie viewing ever held at the Rosedale Park. Moviegoers are directed to parking spaces with a designated tailgate space to allow for socially distance outdoor enjoyment. The movies continue to boast full and diverse crowds.

# o Drive-In Concert Nights

Every Saturday evening, we have hosted the drive-in concerts in the cricket field across from the festival grounds at the Mercer County Park. There has been an overwhelming show of support for these events in the recorded attendance. Each week, the shows have focused on various genres and have highlighted local talent such as *Kindred Spirit*, *The Sounds of Sandstorm* and *Instant Funk*. We've utilized the same parking/tailgating layout as the movie nights to ensure the health & safety of all concert attendees, bands, vendors and staff.

#### 2021 Concert Series

We are currently planning for the 2021 season. While we hope conditions improve so that we can enjoy a more normal season, we will be prepared to move forward with the new format.

# **COMMUNITY OUTREACH:**

# Swimming to Rowing Program

In partnership with the PNRA, the Park Commission hosted a drive-in movie event at the Cure Insurance Arena parking lot on September 27. The movie, *A Most Beautiful Thing*; about the first all-black high school rowing team; is intended to generate an audience to get more public-school students interested in swimming and rowing programs.

# **STEWARDSHIP DEPARTMENT**

#### Deer Management

Deer management has begun at Baldpate Mountain and Mercer Meadows. With deer population densities still Eight (8) to ten (10) times their healthy size; reducing the region's deer population is one of the most important stewardship activities. Funds have been allocated to participate in the Hunters Helping the Hungry program again this season.

#### Roots 4 Rivers

The Roots 4 Rivers restoration planting was completed at Rosedale Park. Over 1400 native trees and shrubs were planted in the meadow at the park entrance by our Stewardship staff and local volunteers.

# - National Fish and Wildlife (NFWF) Grant Award

- o The Stewardship Department has received notification of award for a 2020 Delaware Watershed Conservation Fund matching grant through the National Fish and Wildlife Foundation; in the amount of \$150,000.00.
- o Grant funds will be dedicated to furthering the restoration efforts at Roebling Park. Additionally, the grant will fund installation of an ecologically friendly boat ramp.

#### **ENVIRONMENTAL EDUCATION:**

- **River Days Event at South Riverwalk Park-**Our River Days event in South Riverwalk Park attracted over 400 people. Due to COVID, the annual event shifted to a safe and socially distant walk-through format where visitors received masks, hand sanitizer, fresh produce and a bagged lunch. The event served an ethnically diverse population from local communities.

### **MERCER STABLES:**

- Due to ongoing construction and renovation work program availability has been limited since July. Beginning in October, we will welcome the restart of the following programs:

# o Group Lessons (10/1)

We have been running private lessons since May for advanced riders so as to limit contact with inexperienced riders.

- o **Trail riding (10/3)**-The first weekend is already booked.
- New and Beginner Level Riders (10/5)-Students with no or limited experience lessons. We have received a lot of calls with interest in this level of riders.

### **HOWELL FARM:**

# Foodbank Support and Outreach

As of September 25, 11,340 Mercer County residents have received distributions of the farm's grain products, vegetables, and eggs through the *Share the Harvest Program*. Over 22,000lbs of products have been donated thus far, and farmers are currently planting extra crops of winter wheat, rye, spelts, and barley to assist with anticipated needs.

# Educational Programs

The farm has partnered with the Environmental Education Department, Stewardship Department and Wildlife Center to provide new on-line educational programs for schools; as well as virtual versions of the popular "Naturally Friends" program series.

#### Public Programs

The farm's 37<sup>th</sup> Annual Plowing Match had the best public turnout in many years and saw Howell Farm's own Ian Ferry win the match for the second year in a row.
