- 1. The speed limits for both directions of traffic along (County Route 579), Bear Tavern Road, Township of Ewing, County of Mercer, be amended as follows:
 - 35 M.P.H. 700' south of Windy Bush Drive to 1000' north of Maddock Road; and,
