

WHEREAS, on December 1, 2012, the County issued its Bond Anticipation Notes of 2012, Series A in the principal amount of \$39,000,000 ("2012A Note") to temporarily finance certain of the improvements authorized by Bond Ordinance 2012-5 all as more particularly set forth in Exhibit "A" attached hereto (collectively, the "2012 Improvements"); and

WHEREAS, the 2012A Note matured on December 5, 2013; and

WHEREAS, on December 3, 2013, the County issued its Bond Anticipation Notes of 2013, Series A in the aggregate principal amount of \$45,000,000 ("2013A Note"), to (i) refinance the principal of the 2012A Note at maturity; and (ii) temporarily finance certain of the improvements authorized by Bond Ordinances 2012-4 and 2013-15 all as more particularly set forth in Exhibit "A" attached hereto; and

WHEREAS, the 2013A Note matured on December 2, 2014; and

WHEREAS, on December 1, 2014, the County issued its Bond Anticipation Notes of 2014, Series B, in the aggregate principal amount of \$45,000,000 ("2014B Note"), for the purposes of refinancing the principal of the 2013A Note at maturity; and

WHEREAS, the 2014B Note matures on February 13, 2015; and

WHEREAS, it is the desire of the County to issue its general obligation bonds in the aggregate principal amount of up to \$39,000,000, the proceeds of which will be used to: (i) permanently finance the costs of the 2012 Improvements by the repayment of a portion of the principal of the 2014B Note at maturity; (ii) pay certain costs and expenses incidental to the issuance and delivery of such bonds (items (i) and (ii) are hereafter referred to as the "Project"); and (iii) authorize the County Executive, County Administrator and County Treasurer / Chief Financial Officer to make certain related determinations and covenants and take certain actions in connection therewith.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF MERCER, NEW JERSEY (NOT LESS THAN TWO-THIRDS OF ALL THE MEMBERS THEREOF AFFIRMATIVELY CONCURRING), PURSUANT TO THE PROVISIONS OF THE LOCAL BOND LAW, AS FOLLOWS:

Section 1. Pursuant to the Local Bond Law and Bond Ordinance 2012-5, the issuance and sale of general obligation bonds of the County, to be designated substantially "County of Mercer, New Jersey, General Obligation Bonds, Series 2015" in an aggregate principal amount of up to \$39,000,000 for the Project, is hereby authorized and approved.

Section 2. The Bonds shall be dated their date of delivery and shall mature on February 1 in the following years and amounts

The term of the Bonds is equal to or less than the average period of usefulness of the 2012 Improvements being permanently financed through the issuance of the Bonds.

Interest on the Bonds shall be payable semiannually on February 1 and August 1 of each year until maturity or earlier redemption commencing on February 1, 2016.

The County Treasurer / Chief Financial Officer of the County is hereby authorized to revise the principal amounts set forth in the maturity schedules set forth above in accordance with the Local Bond Law.

Section 3. The Bonds maturing on and after February 1, 2026 shall be subject to redemption prior to their stated maturity dates at the option of the County, upon notice as set forth below, as a whole or in part (and, if in part, such maturities as the County shall determine and within any such maturity by lot) on any date on and after February 1, 2025, at a redemption price equal to 100% of the principal amount of Bonds to be redeemed, plus accrued interest to the redemption date.

Notwithstanding the foregoing, the County Treasurer is hereby authorized to determine whether the Bonds shall be subject to redemption and/or to revise the dates upon which the Bonds shall be subject to redemption, all in accordance with the Local Bond Law.

Section 4. Notice of redemption for the Bonds shall be given by mailing first class mail in a sealed envelope with postage pre-paid not less than thirty (30) days nor more than sixty (60) days prior to the redemption date to the owner of every Bond of which all or a portion is to be redeemed at his or her last address, if any, appearing on the registration books of the County. So long as the Bonds are issued in book-entry-only form, all notices of redemption will be sent only to the Securities Depository (hereinafter defined) and not be sent to the beneficial owners of the Bonds. Failure of an owner of the Bonds to receive such notice or of the Securities Depository to advise any participant or any failure of a participant to notify any beneficial owner of the Bonds shall not affect the validity of any proceedings for the redemption of Bonds. Such notice shall specify: (i) the series and maturity of the Bonds to be redeemed; (ii) the redemption date and the place or places where amounts that are due and payable upon such redemption will be payable; (iii)

if less than all of the Bonds are to be redeemed, the letters and numbers or other distinguishing marks of the Bonds to be redeemed; (iv) in the case of a Bond to be redeemed in part only, the portion of the principal amount thereof to be redeemed; (v) that on the redemption date there shall become due and payable with respect to each Bond or portion thereof to be redeemed the redemption price; and (vi) that from and after the redemption date interest on such Bonds or portion thereof to be redeemed shall cease to accrue and be payable.

Section 5. The Bonds will be issued in fully registered form. One certificate shall be issued for the aggregate principal amount of the Bonds maturing in each year. Both the principal of and interest on the Bonds will be payable in lawful money of the United States of America. Each certificate will be registered in the name of Cede & Co., as nominee of The Depository Trust Company, New York, New York ("DTC"), which will act as securities depository ("Securities Depository"). The certificates will be on deposit with DTC. DTC will be responsible for maintaining a book-entry system for recording the interests of its participants or the transfers of the interests among its participants. The participants will be responsible for maintaining records recording the beneficial ownership interests in the Bonds on behalf of individual purchasers. Individual purchases may be made in the principal amount of \$5,000 through book-entries made on the books and the records of DTC and its participants. The principal of and interest on the Bonds will be paid to DTC by the Paying Agent (as hereinafter defined) on the respective maturity dates and due dates and will be credited on the respective maturity dates and due dates to the participants of DTC as listed on the records of DTC as of the fifteenth (15th) day of the calendar month immediately preceding an Interest Payment Date ("Record Dates" for the Bonds). The Bonds will be executed on behalf of the County by the manual or facsimile signatures of the County Executive

and County Treasurer / Chief Financial Officer, attested by the Clerk of the Board or Deputy Clerk of the Board (such execution shall constitute conclusive approval by the County of the form of the Bonds), and shall bear the affixed, imprinted or reproduced seal of the County thereon.

Section 6. The County is hereby authorized to make representations and warranties, to enter into agreements and to make all arrangements with DTC, as may be necessary, in order to provide that the Bonds will be eligible for deposit with DTC and to satisfy any obligation undertaken in connection therewith.

Section 7. In the event that DTC may determine to discontinue providing its services with respect to the Bonds or is removed by the County and if no successor Securities Depository is appointed, the Bonds which were previously issued in book-entry form shall be converted to registered bonds in denominations of \$5,000, or any integral multiple thereof ("Registered Bonds"). The beneficial owner under the book-entry system, upon registration of the Bonds held in the beneficial owner's name, will become the registered owner of the Registered Bonds. The County shall be obligated to provide for the execution and delivery of the Registered Bonds in certified form.

Section 8. The preparation of a preliminary official statement ("Preliminary Official Statement") relating to the Bonds, and the distribution of said Preliminary Official Statement, in electronic or physical form, to prospective purchasers of the Bonds and others having an interest therein, is hereby authorized and directed. The County Executive, County Administrator and County Treasurer / Chief Financial Officer are each hereby authorized to deem the Preliminary Official Statement "final", as contemplated by paragraph (b)(1) of Rule 15c2-12 promulgated by the Securities and Exchange Commission pursuant to the Securities Exchange Act of 1934, as amended ("Rule 15c2-12").

Section 9. The County Treasurer / Chief Financial Officer is hereby authorized and directed to engage the services of one or more qualified firms (collectively, the "Printer") to provide printing and dissemination (in electronic and/or physical form) of the Preliminary Official Statement and Official Statement (hereinafter defined), all pursuant to and in accordance with the provisions of the Local Public Contracts Law and the regulations promulgated thereunder. The County Treasurer / Chief Financial Officer is hereby authorized and directed to enter into an agreement with the Printer for the services to be provided.

Section 10. If deemed necessary or required, the County Treasurer / Chief Financial Officer is hereby authorized and directed to solicit proposals for, and engage the services of, a qualified financial institution to serve as paying agent for the Bonds ("Paying Agent") for the Bonds. The County Treasurer / Chief Financial Officer is hereby authorized to enter into an agreement with the Paying Agent for the services to be provided.

Section 11. The appointment of NW Financial Group, LLC, Hoboken, New Jersey, as financial advisor ("Financial Advisor") to the County in connection with the issuance and sale of the Bonds is hereby authorized, approved, ratified and confirmed. The County Treasurer / Chief Financial Officer is hereby authorized to enter into an agreement with the Financial Advisor for the services to be provided.

Section 12. Pursuant to Section 34 of the Local Bond Law, *N.J.S.A.* 40A:2-34, the County Treasurer / Chief Financial Officer is hereby authorized and directed to sell and award the Bonds at a public sale. The sale of the Bonds shall be in accordance with the provisions of Sections 27, 30 and 32 of the Local Bond Law, *N.J.S.A.* 40A:2-27, 30 and 32, and the advertised terms of such public sale. The County Treasurer / Chief Financial Officer is hereby authorized and directed to cause a summary notice of sale and a notice of sale of the Bonds to be prepared and published in

accordance with Sections 30 and 31 of the Local Bond Law, *N.J.S.A.* 40A:2-30 and 31. At the next meeting of the Board after the sale and award of the Bonds, the County Treasurer / Chief Financial Officer shall report, in writing, to the Board the aggregate principal amount, the rate or rates of interest, the maturity dates, the dates upon which interest on the Bonds shall be paid, the price and the purchaser or purchasers of the Bonds.

Section 13. The utilization of i-Deal LLC, New York, New York, to provide electronic bidding services to the County in connection with the competitive sale of the Bonds ("Bidding Agent") through the use of the Bidding Agent's BiDCOMP/PARITY auction system, pursuant to the Local Bond Law and the regulations promulgated thereunder, is hereby authorized, approved, ratified and confirmed.

Section 14. The preparation of a final official statement ("Official Statement") with respect to the Bonds is hereby authorized and directed. Within seven (7) business days of the sale of the Bonds and in sufficient time to accompany any confirmation that requests payment from a customer, the County will deliver sufficient copies of the Official Statement to the purchaser of the Bonds in order for the same to comply with Paragraph (b)(4) of Rule 15c2-12. The County Executive, County Administrator and County Treasurer / Chief Financial Officer are each hereby authorized to execute the Official Statement in final form, and the distribution thereof to purchasers and others is hereby authorized and directed. The execution of the final Official Statement by the County Executive, County Administrator or County Treasurer / Chief Financial Officer shall constitute conclusive evidence of approval by the County of the changes therein from the Preliminary Official Statement. The County Executive, County Administrator and County Treasurer / Chief Financial Officer are each hereby severally authorized to approve any amendments of or supplements to the Official Statement.

Section 15. The Bonds shall be general obligations of the County. The full faith and credit of the County are irrevocably pledged to the punctual payment of the principal of and interest on the Bonds and, to the extent payment is not otherwise provided, the County shall levy *ad valorem* taxes on all taxable real property within the County without limitation as to rate or amount for the payment thereof.

Section 16. In order to assist the underwriters of the Bonds in complying with the secondary market disclosure requirements of Rule 15c2-12, the County Executive, County Administrator and County Treasurer / Chief Financial Officer are each hereby severally authorized to execute on behalf of the County before the issuance of the Bonds an agreement providing for the preparation and filing of the necessary reports in accordance with Rule 15c2-12. The County Treasurer / Chief Financial Officer is hereby authorized to enter into an agreement with the Paying Agent or a separately designated dissemination agent for the services to be provided under said agreement.

Section 17. The County hereby covenants as follows that it will not make any use of the proceeds of the Bonds or do or suffer any other action that would cause (i) the Bonds to be "arbitrage bonds" as such term is defined in Section 148(a) of the Internal Revenue Code of 1986, as amended ("Code"), and the regulations promulgated thereunder; (ii) the interest on the Bonds to be included in the gross income of the owners thereof for federal income taxation purposes; or (iii) the interest on the Bonds to be treated as an item of tax preference under Section 57(a)(5) of the Code.

Section 18. The County hereby covenants as follows: (i) that it shall timely file with the Internal Revenue Service, such information report or reports as may be required by Sections 148(f)

and 149(e) of the Code; and (ii) that it shall take no action that would cause the Bonds to be "federally guaranteed" within the meaning of Section 149(b) of the Code.

Section 19. To the extent not otherwise exempt, the County hereby covenants that it shall make, or cause to be made, the rebate required by Section 148(f) of the Code in the manner described in Treasury Regulation Sections 1.148-1 through 1.148-11, 1.149(b)-1, 1.149(d)-1, 1.149(g)-1, 1.150-1 and 1.150-2, as such regulations and statutory provisions may be modified insofar as they apply to the Bonds.

Section 20. Application to Standard & Poor's Ratings Services, a division of The McGraw-Hill Companies, Inc. ("Rating Agency"), for a rating on the Bonds and the furnishing of certain information concerning the County and the Bonds for the purpose of qualifying the Bonds for municipal bond insurance, is hereby authorized, ratified, confirmed and approved.

Section 21. All actions heretofore taken and documents prepared or executed by or on behalf of the County by the County Executive, County Administrator, County Treasurer / Chief Financial Officer, Clerk of the Board, Deputy Clerk of the Board, other County officials or by the County's professional advisors, in connection with the authorization, issuance and sale of the Bonds are hereby ratified, confirmed, approved and adopted.

Section 22. The County Executive, County Administrator, County Treasurer / Chief Financial Officer, Clerk of the Board and Deputy Clerk of the Board are each hereby authorized to determine all matters and execute all documents and instruments in connection with the Bonds not determined or otherwise directed to be executed by the Local Bond Law, Bond Ordinance 2012-5 or by this or any subsequent resolution, and the signatures of the County Executive, County Administrator, County Treasurer / Chief Financial Officer, Clerk of the Board or Deputy Clerk of the Board on such documents or instruments shall be conclusive as to such determinations.

Section 23. All other resolutions, or parts thereof, inconsistent herewith are hereby rescinded and repealed to the extent of any such inconsistency.

Section 24. This resolution shall take effect immediately upon adoption this 22nd day of January, 2015.

MERCER COUNTY **BOARD** OF CHOSEN FREEHOLDERS **OPPOSES** THE NEW **JERSEY** LEGISLATURE'S RECENTLY PASSED "WATER INFRASTRUCTURE PROTECTION URGES GOVERNOR CHRISTIE TO VETO THE BILL

WHEREAS, the New Jersey Senate and General Assembly recently approved Senate Bill 2412, known as the "Water Infrastructure Protection Act" (the Act), which is currently being reviewed by Governor Christie; and,

WHEREAS, the Act concerns certain public water and wastewater assets, supplementing Title 58 of the Revised Statutes and amending R.S. 40:62-3, regarding voter approval of the sale of public water utility assets; and,

WHEREAS, the Act eliminates the requirement of voter approval prior to the sale of public utility assets; and,

WHEREAS, in order for the sale of public utility assets to be subject to a public referendum, the Act will require the filing of a petition protesting the sale with the municipal clerk within 45 days of the publication of the municipality's Emergent—Conditions Certification; and,

WHEREAS, said petition would require the signatures equal to at least 15% of the total votes cast in the last election at which members of the General Assembly were elected, creating an onerous task for the public; and,

WHEREAS, in 2010, the voters in the City of Trenton, County of Mercer, rejected the sale of a portion of the Trenton Waterworks to American Water by a 4 to 1 margin; and,

WHEREAS, under the Act, and based upon the 2013 general election results, a new effort to sell a portion of the Trenton Water Works by the City would only be subject to voter approval by the gathering of over 1,800 signatures in just 45 days; and,

WHEREAS, the Act was amended to include an exception for a municipality that is a city with a population of 270,000 or more, however the Act makes no consideration for the sale of public utility assets owned by smaller cities with regional customer bases – such as Trenton, which serves approximately 250,000 customers in all or parts of Trenton, Ewing, Lawrence, Hamilton, and Hopewell Township; and,

WHEREAS, the Act strips the authority from the Board of Public Utilities (BPU) in the process of setting rates by requiring the BPU to accept the negotiated sale price as the new rate base, passing the entire cost of the sale to ratepayers; and,

WHEREAS, the Act also allows for closing and transition costs incurred during the purchase of the public asset, which are generally charged to shareholders, to instead be recoverable in rates; and,

WHEREAS, according to legislative testimony by the New Jersey Division of Rate Counsel, allowing the entire sale price and transition costs to be recoverable by rates acts as a disincentive for investor-owned utilities to negotiate a "prudent purchase price" as they strive to submit the highest bid; and,

WHEREAS, the Rate Counsel also testified that provisions which remove the authority of the BPU to determine how much of these costs may be recoverable through rates may render the Act unconstitutional, as they violate the ratepayers' statutorily protected due process; and,

WHEREAS, a diverse group of environmental, business, government and consumer groups have recorded their opposition to the Act, including: the New Jersey Chapter of the Sierra Club, the Association of Environmental Authorities, the League of Municipalities, New Jersey Business & Industry Association (NJBIA), the New Jersey Division of Rate Counsel, Communications Workers of America (CWA) Local 1036; now, therefore,

BE IT RESOLVED, that the Mercer County Board of Chosen Freeholders oppose the Water Infrastructure Protection Act, which removes the requirement of voter approval prior to the sale of public utility assets, and strips the authority of the New Jersey Board of Utilities to determine how much the purchase price and associated costs can be recovered by rates, and urges Governor Christie to veto the bill; and,

**BE IT FURTHER RESOLVED,** that the Clerk to the Board shall forward a certified copy of this Resolution to the Office of Governor Chris Christie, the delegations of the 14th, 15th and 16th Legislative Districts, and the Mayors of the City of Trenton, Ewing Township, Lawrence Township and Hopewell Township.
