Mercer County Juneteenth Observance

On June 19th, 1865 Major General Gordon Granger issued General Orders 3 in Galveston, Texas that "all slaves were free" and that there would be "equality of personal rights and rights of property between former masters and slaves." He was leading the Union Army through Texas in the closing days of the American Civil War. This was the last corner of the Confederate States of America, not yet occupied by the Union Army. While General Lee had surrendered to Ulysses S. Grant a few months earlier, some remnants of the Confederate Army remained in the west, including rebel bushwhackers, and fleeing slave owners determined to keep owning African Americans as long as they could.

In theory, African Americans had already been freed for a little over two years following Abraham Lincoln's Emancipation Proclamation. Lincoln's words declared that African Americans held in rebel territories were "and henceforward shall be free." However, it had no legal standing and was simply a promise that the Civil War would now be about ending slavery. Southern states in rebellion ignored this proclamation and continued to hold African Americans in bondage. The 13th amendment would guarantee a legal end to slavery in 1865, but that was still in the process of being ratified when Juneteenth occurred. It would rest on the Union Army to forcefully liberate states in the Confederacy.

Even the Juneteenth announcement itself was not the end-all to slavery or the fight for equal rights and treatment in our nation. It still took some time for slave owners in Texas to be forced to free some two hundred and fifty thousand African Americans. However, the day marks when the last African Americans in bondage were made aware of their freedom. Sporadic celebrations began to ensue in the state. Finally, all African Americans would realize freedom and emancipation, though the challenges of Reconstruction, the Jim Crow era, and the Civil Rights movement would still lay ahead.

Juneteenth honors the day the last African Americans learned of their freedom, but it is also a call to the necessary fact that the fight for equality and justice for all is never over. Even when laws improve rights for oppressed groups, Americans committed to justice need to be willing to carry them out. This day honors the work of brave abolitionists like Frederick Douglass, who worked tirelessly to end slavery. It honors the nearly four million freed African Americans, and all of those who carne before them, who helped build this nation on their backs. It honors the nearly 200,000 African Americans who fought in the Union Army to help liberate their brothers and sisters and hold the Union together. Perhaps most importantly, the day is a reminder that the struggle for equality is never over. We must all be diligent guardians of liberty, justice, and fair treatment for all, and must always be committed to doing the necessary work to make it a reality.

Mercer County is pleased and honored to celebrate this wonderful holiday and to be committed to upholding the day's values for all of its citizens.

MINUTES

Vice -Chair Walter called the Agenda Meeting to order at 6:03 PM on June 21, 2022, in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street, Trenton, New Jersey.

ROLL CALL:

The following members of the Board answered the Roll Call of the Clerk to the Board:

Vice- Chair Walter l	ed the Pledge of Allegiance and Salute to the Flag.

SUNSHINE LAW:

The Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meeting Law, notice of this Formal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty- eight (48) hours in advance of the meeting.

Vice-Chair Walter held a moment of silence for Eugene Elias, an auditor with Mercadien Group who worked with Mercer County.

At this time, County Executive Brian Hughes addressed the Board and recommended the appointment of Kristin Appleget to serve as a member of the Mercer County Community College Board of Trustees. County Executive Hughes said Ms. Appleget would be a great addition to the Mercer County Community College Board of Trustees. He noted that she has an extensive background and is a person of exceptional character.

Ms. Appleget thanked County Executive Hughes for his consideration to serve on the Mercer County Community College Board of Trustees. She stated that she believes in the transformative impact community college offers students and is looking forward to serving the students and the community.

Commissioner McLaughlin stated that Ms. Appleget could work closely with the business community to engage with Mercer County Community College. She noted that partnerships with businesses and the college would be beneficial.

Ms. Appleget said her partnership with the Princeton Chamber of Commerce was a great opportunity to develop relationships with businesses throughout.

Commissioner Stokes said Ms. Appleget's resume was impressive, and that he looked forward to working with her on upcoming projects.

Commissioner Koontz stated that with the rising cost of higher education, he proposed offering financial assistance to students who could not afford tuition.

Ms. Appleget said that students must have a financial barrier, and that the college must consider the cost. However, she added that community leaders are doing a great job of ensuring affordability and accessibility to students.

Vice-Chair Walter indicated that exceptional character and competence describe Ms. Appleget. Vice Chair Walter said the college has a critical mission and that she was looking forward to working with Ms. Appleget.

Eleven (11) Communications were discussed and approved for placement on the Agenda for the Formal Meeting of June 21, 2022.

Vice -Chair Walter referred to the Resolution regarding Amending Resolution No. 2020-397, adopted August 13, 2020, the County Executive and Clerk to the Board authorized to execute Amendment No. 1 to the Award of Bid contract with Broadway Moving & Storage, Inc., for delivery of electronic voting machines for the Mercer County Superintendent of Elections. Amend Resolution to increase contract by an additional \$50,000.00, revised total amount is \$291,171.00.

Commissioner Frisby stated that he has several questions for the Mercer County Clerk, Mercer County Board of Elections and Mercer County Superintendent of Elections.

Vice- Chair Walter suggested to hold all questions until the Mercer County Board of Elections, Superintendent of Elections and County Clerk can address the questions at a later meeting around election time.

RESOLUTIONS:

Fifty -seven (57) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of June 21, 2022.

Vice -Chair Walter made reference to the Resolution regarding authorization to submit a grant application to the New Jersey Department of Community Affairs, Division of Housing and Community Resources for community services block grant

funds for the period of January 1, 2023, through December 31, 2023, in the amount of \$ 107, 686.00. She noted that Commissioner Melker would abstain from voting on the Resolution because she serves as a member of the John O. Wilson Board.

Vice-Chair Walter made reference to the Resolution regarding the Grant Award fiscal year 2022 with the State of New Jersey Department of Community Affairs for the Mercer County re-entry program to provide re-entry support services to inmates released from incarceration for the period of July 1, 2021, through June 30, 2022, in the amount of \$786,353.00. She said that the turn-out rate was low for recipients to receive services.

Commissioner Frisby indicated that funding resources are available; however, the process must be redefined.

Vice—Chair Walter said recipients could not get through the application process. She noted that the re-entry coordinators are the liaison with the Mercer County Board of Social Services and the State of New Jersey. She discussed that the process breaks down when people leave correctional facilities.

Commissioner Stokes felt that there were several gaps in the process as a whole.

Commissioner Frisby referred to the Resolution regarding the Commission on the abused, neglected, and missing children. He asked for more information on the Commission.

Lillian Nazzaro, Business Administrator, responded that the Commission meets monthly and primarily focuses on two events per year. She said one event was the Cherish the Children dinner, which celebrated individuals and groups who work with youth and are nominated to be honored for their service. She said they also hold an annual multi-disciplinary conference in which the County brings in speakers to

discuss current topics related to youth and that this year's topic is the impact of the	ne
pandemic on youth and their mental health.	

OLD BUSINESS:

Commissioner Koontz commented that he deeply appreciated the County for building a roundabout on Rosedale Road in Princeton.

At this time, Vice- Chair Walter invited the members of the public to comment on any item listed on the agenda.

There were no comments.
