- 2. SIGN DESIGNATIONS WITH THE PREFIX R OR W REFER TO STANDARD SIGNS IN THE CURRENT M.U.T.C.D. INSTALLATIONS, DIMENSIONS, COLOR AND DETAILS OF ALL SIGNS ARE TO FOLLOW STANDARDS IN THE CURRENT "STANDARD HIGHWAY SIGNS PUBLICATION" (S.H.S.) AND THE CURRENT M.U.T.C.D.
- 3. ALL TRAFFIC SIGNS SHALL BE INSTALLED BY THE CONTRACTOR SO THAT THEY DO NOT OBSCURE EACH OTHER OR ARE HIDDEN FROM VIEW BY OTHER ROADSIDE OBJECTS.
- 4. ALL SIGNS, EXCLUDING PARKING SIGNS, SHALL BE MOUNTED FACING THE DIRECTION OF THE TRAFFIC THAT THEY ARE INTENDED TO SERVE. POSITIONING OF ALL SIDE—OF—ROAD MOUNTED TRAFFIC SIGNS SHALL BE DETERMINED BY THE COURSE OF THE APPROACHING TRAFFIC, RATHER THAN BY THE ROADWAY EDGE AT THE POINT WHERE THE SIGN IS TO BE LOCATED. PARKING SIGNS SHALL BE MOUNTED AT A 45 DEGREE ANGLE TO THE DIRECTION OF APPROACHING TRAFFIC.
- 5. THE PROPOSED STRIPING SHALL MEET THE EXISTING STRIPING AT THE PROJECT LIMITS AS DEPICTED ON THE PLANS.
- 6. THE PROPOSED SIGNING AND STRIPING SHALL BE INSTALLED AT THE LOCATIONS SHOWN ON THE PLANS. IF DIMENSIONS EXIST THEY SHALL GOVERN OVER THE SCALED MEASUREMENT.
- 7. REMOVE OR RELOCATE ALL EXISTING SIGNS AS SHOWN ON THE PLAN OR AS DIRECTED BY THE ENGINEER. SIGNS TO BE RELOCATED OR REMOVED FOR SIDEWALK CONSTRUCTION SHALL BE RESET AS SOON AS PRACTICABLE, BUT NO LATER THAN TWO (2) WORKING DAYS. ALL REMOVED SIGNS ARE TO BE RETURNED TO MERCER COUNTY OR AS DIRECTED BY THE ENGINEER.
- 8. THE PROPOSED LAYOUT OF STRIPING AND PAVEMENT MARKINGS SHALL BE MARKED IN THE FIELD AND APPROVED BY THE ENGINEER PRIOR TO INSTALLATION.
- 9. TRAFFIC STRIPES SHALL CONSIST OF EPOXY RESIN LONGITUDINAL STRIPES AND THERMOPLASTIC TRANSVERSE STRIPES AND PAVEMENT MARKINGS.
- 10. RETAIN EXISTING SIGNS UNLESS NOTED OTHERWISE.
- 11. R10-3e SIGNS ARE INCLUDED IN THE PUSH BUTTON PAY ITEM.


