Since 1990, more than \$145 million in matching grants has been awarded to worthy historic preservation construction and planning projects throughout the state; and,

The structure is a significant example of colonial farmhouse architecture. The oldest parts of the farmhouse date to c. 1717 and the newest to 1830; and,

WHEREAS, in 2007, TCNJ funded a mothballing and stabilization of the house to ensure that no further deterioration occurred to the property, unfortunately, the property was listed in 2015 as one of New Jersey's 10 most endangered historic sites by Preservation New Jersey; and,

WHEREAS, it is critical to preserve our past, of which the Green Farmhouse is part; now, therefore,

BE IT RESOLVED, that the Mercer County Board of County Commissioners support the application of The College of New Jersey for a grant from the New Jersey Historic Trust to Develop a plan to preserve, restore, and repurpose the William Green Farmhouse.
