INFORMAL MEETING OF FEBRUARY 7, 2023

MINUTES

Commissioner Board Chair Walter called the Agenda Meeting to order at 6:01 P.M. on February 7, 2023, in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street, Trenton, New Jersey.

ROLL CALL

The following members of the Board answered the Roll Call of the Clerk to the Board:

Present – Commissioners Cimino, Frisby, Lewis, McLaughlin, Melker, and Walter Absent – Commissioner Stokes

Chair Walter led the Pledge of Allegiance and Salute to the Flag.

SUNSHINE LAW

The Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meetings Law, notice of this Informal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

COMMUNICATIONS

Three (3) communications were discussed and approved for placement on the Agenda for the Formal Meeting of February 9, 2023.

RESOLUTIONS

Thirty-four (34) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of February 9, 2023.

Chair Walter informed the Board there was an additional Resolution that needed to be added to the Agenda this evening. She made reference to the following proposed Resolution authorizing to execute a Professional Service Agreement with Mercadien, P.C. certified public accountants for preparation of schedules and completion of County's financial statements for FY 2021 Audit and Single Audits. Chair Walter asked the Administration to provide further clarification in regard to the Resolution.

Dr. Sharon Sharp, Ed, Temporary Chief Financial Officer informed the Board that in October 2022 the County's auditing firm, Mercadien provided her office with an updated memorandum with items needed to continue their work on the 2021 audit. She said at that time the Commissioner Board gave her authorization and allowed her to hire a financial consulting firm to assist in getting the Finance Department in order. Dr. Sharp explained that it was discovered that the County's previous Chief Financial Officer completed all schedules that account for funding and she was unaware that was something her office would need to provide. Dr. Sharp explained this Resolution would allow Mercadien to complete the necessary schedules and assist with the completion of the 2021 the auditing process. She said their original Contract did not include preparation of schedules.

Commissioner Lewis spoke of questions she submitted to the Administration regarding the Resolutions listed on tonight's Agenda.

County Administrator, Lillian Nazzaro, Esq., responded that she was in receipt of those questions but explained that it would be helpful if they were submitted earlier so she can forward them to the appropriate Directors. She said she would get those answers to Commissioner Lewis by Thursday.

Chair Walter informed the Board that after reviewing the Agenda she requested that the scoring sheets be included for all Competitive Contracts. She felt it would be a helpful piece of information for their review.

Chair Walter made reference to the following proposed Resolution authorizing to execute a Lease Addendum No. 7 with Hana Associates, LLC for the housing of voting machines for the County of Mercer; extending the Lease Termination notice date from February 1, 2023 to March 1, 2023. Property: 1 Johnston Avenue, Hamilton Township. She wanted to know how many times the County could extend its Lease with Hana Associates.

Paul Adezio, Esq., County Counsel, answered that he reviewed the Lease and there is no end date listed so it is up to either party and whoever decides to end it.

Commissioner Lewis asked if the cost remains the same or is that re-negotiated.

County Counsel Adezio answered that some negotiations include improvements or necessary adjustments to the existing structure.

Commissioner Cimino made reference to the following proposed Resolution authorizing to execute a Professional Services Agreement with Bowman and Company, LLP, for Auditor Services for the Mercer County Insurance Fund Commission. He discussed the trouble with having an auditor with longevity overseeing the County's documents. Commissioner Cimino suggested the Administration looking into changing the auditor for the Insurance Fund Commission as well.

Commissioner Frisby asked how long it would take the Administration to hire another auditor.

County Administrator Nazzaro answered at least April or May.

Commissioner Frisby felt the Board may not want to "table" this Resolution due to the time constraints. He suggested moving forward utilizing the three-year strategy and employing a different auditing firm.

The Commissioner Board collectively discussed the importance of changing auditors and agreed to allow this Resolution to go forward this time. They discussed their goal of getting a fresh perspective and asked the Administration to bring in a new auditor next year.

Chair Walter made reference to the following proposed Resolution authorizing to execute Change Order No. 1 & Final with Orchard Holdings, LLC for the installation of Traffic Signal Underground and Electrically Operated Traffic Control devices at various locations throughout Mercer County. Chair Walter wanted to clarify the purpose of this Resolution. She was under the impression that this would move the location of the traffic light foundations back from the corners. Chair Walter spoke about a traffic signal she just drove past and noticed everything stayed the same but they were moved further from the street.

Commissioner Lewis asked if this Resolution was authorizing specific locations or just an authorization of funds.

County Administrator Nazzaro answered there were specified locations and said she would provide that information to the Board.

At this time, Chair Walter invited the members of the public to comment on any item listed on the Agenda.

Jeffrey Laurenti, a resident of the City of Trenton addressed the Board. He was present this evening to give accolades on the recently adopted Resolution regarding the "Great Western Bikeway". Mr. Laurenti thanked the Commissioner Board and Administration for bringing forward such projects that assist residents in both quality of life and expand their ability to forgo traditional transportation and safely get around outside and enjoy all that Mercer County has to offer.
