COMMUNICATIONS

Four (4) communications were discussed and approved for placement on the Agenda for the Formal Meeting of April 27, 2023

RESOLUTIONS

Fifty-one (51) proposed Resolutions and one (1) Ordinance Introduction were discussed and approved for placement on the agenda for the Formal Meeting of April 27, 2023.

Commissioner Walter made reference to Resolution R-33, authorizing an option to extend the Competitive Contract with Royal Printing service for the provision of ballot printing, vote by mail, envelopes, and applications for the Primary, Special, and General Elections. She explained that the funds for this contract were allocated in the 2023 and 2024 budget.

Commissioner Walter made reference to Resolution R-34, authorizing Amendment No. 1 to the Professional Services Agreement with Joseph A. Deluca Advisory & Consulting services LLC., for special forensic audit services. She informed the Board that the letter from Deluca was provided as back up to help answer any questions the Commissioners had pertaining to the contractual amount increase.

Commissioner Walter requested that for Resolution R-36, authorizing Mutual Aid and Assistance Agreement with the County of Mercer and Public Safety participating units throughout the State of New Jersey, language be added to the title to include an expiration date of the Agreement. She noted the additional language added to the resolution would include "Term to expire December 31, 2032".

Commissioner Walter welcomed Mitchel Newman from the Lennar Group to answer any questions relating to Resolution R-39, authorizing Amendment No. 1 to the Deed Restriction and a partial release of mortgage. Property: Block 93, P/O former Lot 5.02, Scotch Road, Hopewell Township; Homefront TLC, INC. N/K/A/ Homes By TLC, INC.

Mr. Newman discussed with the Board that the adoption of the Resolution would allow the Lennar group to deed Homefront two homes that currently exist on the land and in addition, the Lennar group would be able to build a new inclusionary development consisting of 1,000 new homes of which 216 would be affordable homes.

Commissioner Mclaughlin thanked Mr. Newman for coming to the meeting and briefly spoke of her time working with Mr. Newman while on Council in Hopewell Township on their affordable housing communities. Commissioner Mclaughlin looked forward to all the great things that Mr. Newman and the Lennar group have planned for the land on Scotch Road.

Commissioner Frisby also thanked Mr. Newman for undertaking this project and spoke to the importance of home ownership and allowing these opportunities and projects to be accessible to resident throughout the County.

Mr. Newman shared with the Board that he took TCNJ Engineering students on a tour of the work site, he mentioned that the young adults really enjoyed the tour and all that they learned. He hoped to continue this practice going forward.

Commissioner Stokes mentioned the need for this exposure to this type of career path given to high school students. Mr. Newman agreed and was hopeful to speak with Commissioner Stokes about this matter further.

County Administrator Lillian Nazzaro, Esq., introduced Superintendent of Parks, Anthony Cucchi to answer any questions with respect to Resolution R- 40, authorizing to execute and accept a Grant Award with the United States Department of Housing and Urban Development (HUD) for a community project funding award for park improvements at the Trenton Wharf property, City of Trenton.

Commissioner Walter questioned how much money was in the Open Space Trust Fund. Mr. Cucchi responded that he was unsure and did not believe any of the funds would be used out of that account for this portion of the project.

Commissioner Walter requested the account balance for the Open Space Trust Fund be provided at the next meeting.

County Administrator Nazzaro responded that the Temporary CFO is currently working on all Trust Fund accounts.

Commissioner Walter questioned if the City of Trenton would have a share? Mr. Cucchi responded that the City of Trenton owned a parcel of land but would not be financial contributors on this project.

Commissioner Mclaughlin requested that Mr. Cucchi provide a brief overview of the project.

Mr. Cucchi gave a brief overview of the Wharf development project that started over 20 years ago. He explained the park improvements that were previously made had failed due to geotechnical issues and the property had to be fenced off. There was now a commitment from the State of New Jersey Department of Transportation to construct and build a flood wall to reinforce the foundation for future park improvements. He noted that all committed parties entered into an Agreement about a year ago to join efforts to work on this project together.

Commissioner Frisby questioned completion time for this project?

Mr. Cucchi believed the improvements would begin in about a year to a year and a half.

Commissioner Walter referenced Resolution R-51, Emergency Budget Appropriations. She questioned if the appropriations being used at 100% were from the introduced budget?

County Administrator Nazzaro responded that it was from the fourth quarter of the 2022 budget.

During the discussion of the Emergency Budget Appropriations, the Board agreed that they would conduct a Special Formal Meeting to discuss the Emergency Temporary Budget. At this time Resolution R-51 was pulled from Agenda.
