At this time, Chair Walter invited the members of the public to comment on any item listed on the agenda.

Mark O'Dea, a Hopewell Township resident addressed the Board. He was present this evening to speak about 135 Blackwell Road; the property where he currently resides. Mr. O'Dea explained that he had been living and tending to the farmland located in Hopewell Township for quite some time up until the property was purchased by Penn East. He said that he had several discussions with Penn East and they said he would be able to continue to live on the property and be given the opportunity to purchase the property since he was repairing and restoring it already. Mr. O'Dea said he was disheartened to hear that the property was now being sold to the County of Mercer instead of him. He explained that he has every intention of preserving the farmland and to utilize the property as intended. Mr. O'Dea asked the Commissioner Board to intervene if there was a way to stop the sale of the property.

Chair Walter confirmed that Mr. O'Dea was a tenant farmer and was allowed to continue to farm and rehabilitate the land with only a verbal request between himself and Penn East.

Mr. O'Dea agreed and insisted that his plans were to purchase the farmland and use it as intended. He was extremely upset because over several years he has put timeless hours into the repair and rehabilitation of the property.

Commissioner Frisby asked if there was any written memorialization of the Agreement between either party.

Mr. O'Dea responded that there were many emails and noted that Penn East paid him personally for part of the cleaning outside and interior work that was completed. He referred to himself as the "caretaker" of the property and in return Penn East allowed him to stay on the property as such.

Commissioner Frisby asked if the County was planning to purchase this property.

Paul Adezio, Esq., County Counsel, responded that the Administration hired a surveying firm to go out and conduct a survey on the property with the intent to purchase the land.

Commissioner Frisby left at 7:35 P.M.

John Hart, a resident of Hopewell addressed the Board. He was present this evening on Mr. O'Dea's behalf and to discuss farmland preservation. Mr. Hart commented how he was a member of the State Board of Agriculture and felt farmland preservation was imperative because farms were a thing of the past. He discussed his farm consisting over 60 acres and the fact Mercer County was losing farmland each month to developers purchasing land and using it for development construction. Mr. Hart pleaded for the County to intercede and assist Mr. O'Dea with keeping the land as it was intended, "farmland".

Chair Walter thanked Mr. Hart and referred to him as being an "unsung" hero when it pertains to open space preservation around the State of New Jersey. She said she would gather further information from the Administration and proceed from there.

Mike McKitish, a resident of Robbinsville addressed the Board. He was present this evening to discuss his concerns with the voting process in Mercer County as well as the 2023 Mercer County budget process. He commented on the tax rate and respected the Commissioner Board for all of their due diligence when dealing with taxpayer dollars. Mr. McKitish brought up concerns with the election process including election software glitches and security flaws. He thanked the Board for always being attentive to his concerns and looked forward to open conversations regarding the election process.

Chair Walter mentioned that she attended a meeting on Wednesday night and that County Clerk, Paula Solami-Covello was there and they had a discussion regarding how the primary election went. She was pleased to inform Mr. McKitish that many issues during the general election were corrected and the process went much smoother this time around. Chair Walter noted that locks were on ballot bags and they were also trackable because of the censors that were used.

Mr. McKitish was pleased to hear this news. He remarked how the County was still in need of poll workers and how polling locations were decreased. Mr. McKitish asked how the County planned to remedy that issue.

Chair Walter explained there had been some discussion with the Board of Elections to see if poll workers' wages have to be taxed. She discussed how election day was a long "working" day and the money paid to workers' may not seem worth it after taxes were paid. Chair Walter mentioned the idea of not taxing poll workers was still an on-going discussion.

Chair Walter asked if the Department of Community Affairs (DCA) would flag our proposed budget because it would not cover the amount that has been expended and we are now in an emergency temporary budget.

Dr. Sharp responded that would not occur because this Resolution is requesting permission from the Board to reduce those budget lines to align with the introduced & amended budget. She explained this was a necessary step to move forward with the budget process.

Commissioner Lewis mentioned the last column referring to the 2023 Introduction numbers, she asked which set of numbers she should be referencing.

Dr. Sharp noted that the numbers in parenthesis were negative numbers, required to align the budget accordingly.

Commissioner Frisby explained that Dr. Sharp created her own stop-gap ensuring that the Departments do not over-expend what the Commissioner Board already approved for the budget.

Dr. Sharp concurred.

RESOLUTIONS

Twenty-two (22) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of June 22, 2023.

Commissioner McLaughlin made reference to R-5, proposed Resolution authorizing to Submit a Grant Application (No. 2023-05213-1062) to the State of New Jersey Department of Community Affairs for the Mercer County Re-entry Program to provide Re-entry Support Services to Inmates released from incarceration. She noted that the Application was delayed due to the high level of grant activity and that the Human Services department was understaffed. Commissioner McLaughlin asked the Administration if the consultants that were hired to assist with Grants could support the department with these types of Grants.

County Administrator Lillian Nazzaro, Esq., explained that this Resolution was specific to Assemblyman Anthony Verelli's grant for the re-entry program.

Commissioner Cimino believed that the County entered into two different contracts with consulting firms; one for Federal grants and the other for State grants.

Chair Walter asked the Administration if the consultants of WSW and Bruno Associates could assist with this process and help with the delay.

County Administrator Nazzaro explained that Marygrace Billek, Director of Human Services, works with her own group of individuals on grants and they have a scope of work that they are required to follow. She explained that the two firms that the County hired were to assist with obtaining new grants and aid for the County.

Chair Walter asked if the Board could be provided with a list of all grants that have been brought in to date by WSW and Bruno. She wanted to be able to see the activity they have procured thus far.

Commissioner Lewis asked to additionally provide the Board with a list of grants they have applied for as well.

Commissioner Frisby asked if there was any leeway within the Contract that would allow them to assist with this type of work.

County Administrator Nazzaro said she would look into the matter further and inform the Board.

OLD BUSINESS

Chair Walter mentioned that the Mercer County Board of Social Services (MCBOSS) was in the process of unwinding the Covid-19 Emergency benefits. She said that MCBOSS sent out approximately 1600 notices to people receiving Medicaid asking them to recertify their benefits. Chair Walter said that to date 600 recipients have not replied. She added that there were a number of job placements and that Mercer County's numbers were decent in comparison to the rest of the State but explained that if people did not continue with specified requirements, they could lose funding.

NEW BUSINESS

Commissioner Frisby spoke of a recent opportunity he had to visit Trenton-Mercer Airport's flight training school through Mercer County Community College (MCCC). He asked if MCCC was ever included in the economic impact study that was completed a few years ago. Commissioner Frisby spoke about the pilot shortage and how many commercial airlines are paying up to \$500,000 a year for pilots. He said there were currently 250 participants out of Mercer County and 100 participants who reside outside of Mercer, along with veterans who returned from service being trained at the school. Commissioner Frisby was unsure that Mercer County was marketing this asset to its full potential to residents. He wanted to ensure that the County could benefit from the potential impact this could have when hiring local individuals interested in becoming an airline pilot. Commissioner Frisby noted that MCCC has one of the largest flight schools in North America.

Chair Walter said originally the flight school was based out of Princeton NJ at a time when Mercer was very close to losing their tower because the federal government was going to pull the funding. She explained that it was the flight school that kept the tower going because it maintained the tower funding and fire safety training with touch-and-go flights.

Commissioner Frisby noted that the flight school currently was brining in 500 touch-and-go flights a week.

Commissioner Melker had the pleasure of presenting proclamations and pins; along with Commissioner's Stokes and Mclaughlin to the Steinert High School girls' softball team for winning the State Championship. She commented that her daughter was the head coach, who was also named Coach of the year. Commissioner Melker thanked her colleagues for allowing her to present the proclamations on their behalf.

PUBLIC SECTION

At this time, Chair Walter invited the members of the public to comment on any item listed on the Agenda.

Ira Marks, a resident of Lawrenceville addressed the Board. He was present this evening to discuss the 2023 Mercer County Budget. Mr. Marks asked when the budget was originally introduced.

Chair Walter said the budget was originally introduced May 9th and the Commissioner Board held 23 hours' worth of budget meetings with cuts and additions made to the working budget. She explained that after the changes were made it then was sent to the State and they are able to make changes and/or suggestions and then it would have to be re-advertised.

Mr. Marks commented that this process seems to have been started late in the year.

Chair Walter remarked that budget process was started later than usual due to the financial issues within the finance department.

Mr. Marks commented on the substantial increase of 30% for employee healthcare and why that occurred.

Chair Walter explained that healthcare costs went up due to the State, which made provisions for State employees but not local or municipal employees. She added that she was aware the Administration was looking to see what other options were out there to assist with the rising costs.
