INFORMAL MEETING OF OCTOBER 10, 2023

MINUTES

Chair Walter called the Formal Meeting to order at 6:02 P.M. on October 10, 2023, in Room 211 of the Joyce L. McDade Administration Building, 640 South Broad Street, Trenton, New Jersey.

The following members of the Board answered the Roll Call of the Clerk to the Board:

Present – Commissioners Cimino, Frisby Lewis, McLaughlin, Melker, Stokes and Walter

Chair Walter led the Pledge of Allegiance and Salute to the Flag.

The Clerk to the Board announced that in accordance with the provisions of the New Jersey Open Public Meetings Law, notice of this Formal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at least forty-eight (48) hours in advance of the meeting.

Chair Walter thanked her colleagues and everyone that reached out to her and her family as they mourned the death of her mother.

COMMUNICATIONS

Three (3) communications were discussed and approved for placement on the Agenda for the Formal Meeting of October 12, 2023

During the discussion of communications Chair Walter requested that the Administration's response to Board Counsel's request to pause civil service placement as it could have negative budgetary impacts to the next Administration.

County Administrator, Lillian L. Nazzaro Esq., requested the entire exchange be added to communication 3 to complete the record.

The Board concurred.

PRESENTATION

Commissioner Lewis, also the leader of two Girl Scout Troops, lead the presentation of certificates to the Girl Scouts that received Silver and Gold awards from the Girl Scouts of Central and Southern NJ. Commissioner Lewis explained that Girl Scouts create sustainable changes within their community and one way they establish change was by collectively barnstorming different ideas, create an action plan and then see the project through completion. RESOLUTIONS

Fifty-seven (57) proposed Resolutions were discussed and approved for placement on the agenda for the Formal Meeting of October 12, 2023.

Chair Walter made reference to R-1, "Special Item of Revenue- Proceeds from the National Opioid Litigation settlements" She questioned why this item was not included into the budget prior to passage?

County Administrator Nazzaro responded she would check with the Temporary C.F.O and get back to the Board

Competitive Contract with John O. Wilson Hamilton Neighborhood Center, Inc., for case management services for comprehensive social service programs to income eligible residents of Hamilton, be pulled from block and voted on separately because she is a member of the with John O. Wilson Board.

Commissioner Melker made reference to Resolution R-24 authorizing to accept a Grant Award from the State of new Jersey, Department of Health, Division of Public Health Infrastructure, Laboratories and Emergency Preparedness program grant. She questioned if positions specific to COVID-19 response and relief are no longer filled due to those positions being funded through grant funds.

County Administrator Nazzaro responded, that it depended on the position as some roles where being filled and helped by the Office of Emergency management and Human services. However, there were specific positions funded fully through grants, and those positions were no longer available.

Commissioner Frisby questioned if there was still a need for services funded through grants. He questioned if all grant money has been expended are those services still being met?

County Administrator Nazzaro responded, yes, all public health needs were being fulfilled through Kristen Reed, Public Health Officer for the County.

Commissioner Cimino made reference to Resolution R- 28 authorizing to execute a Professional Service Agreement with Vanasse Hangen Brustlin Inc., to provide engineering and design services for the PFAS water system at the Mercer Cunty Correctional Center. He shared information regarding stage one and phase of a national settlement for these issues of PFAS because communities were impacted by these forever chemicals. He felt this was something the County should look into. Commissioner Cimino was willing to share contact information so the County could take advantage of these significant dollars and resources coming out of these settlements.

Chair Walter made reference to Resolution R-36 authorizing to execute a Professional Service Contract with Bowman & Company LLC to provide financial accounting services to the County of Mercer. Chair Walter questioned if the position of Chief Financial Officer must be held by a person or can a company assume that role?

County Counsel Adezio, answered it is required by Statue.

Commissioner Stokes questioned the value in outsourcing the position of Chief Financial Officer?

Chair Walter explained that this position already outsources numerous functions to private entities and questioned if it was a necessary position?

Chair Walter referenced Resolution R-37 authorizing to execute a Professional Services Contract with Bridges Law Group to represent Mercer County with employee disciplinary hearings and investigations. Chair Walter asked when the current contract expires?

County Counsel Adezio believed the contracts expired one month before the new contract was set to begin.

Chair Walter questioned if the contract period could be six months instead of the year?

County Counsel Adezio replied that the length of a contract was usually one year.

With respect to Resolution R-39, authorizing to execute a Professional Services Agreement with Vaughn Collaborative, Inc., to provide architectural/engineering services related to the installation of a new standby generator at the prosecutor's Office. Commissioner Cimino mentioned that he was aware of the new Local Public Contract Law with respect to the political contribution requests that companies must disclose any contributions of \$200.00 or more. He questioned if the current Ordinance that enforces the previous threshold amount should be rescinded?

County Counsel Adezio replied that the purchasing agent included the updated information when sending out financial packages to vendors, and added that the Board could rescind the Ordinance that established the old Local Public Contract Law.

Mr. Michael Herbert, Esq., Board Counsel, added that he represents local towns, and they have not yet rescinded that Ordinance, due to the fact that the new political contribution disclosure is fairly new and everyone was trying to get a better understanding of it.

Chair Walter made referenced to Resolution R-46 authorizing to execute an application with the New Jersey Department of Transportation for Fiscal Year 2024 Annual Transportation Program for County aid to various bridges in Mercer county. She noticed that the support documents for this Resolution mentioned an anticipated amount of 10 million dollars in revenue. The current application is only applying for about 5 million dollars, she questioned if this was only a partial amount?

County Administrator Nazzaro, Esq., replied that she would find out that information and inform the Board.

Chair Walter made reference to Resolution R-50 authorizing to execute Amendment No. 1 to the Professional Services Agreement with Urban Engineers. Inc., to provide engineering design for replacement terminal design development, construction document design, and bidding support at the Trenton-mercer Airport. Chair Walter requested a break down of how much funding had been given to Mercer County from the FAA and what was the total anticipated cost to complete all of the outstanding projects at the Airport.

County Administrator Nazzaro, Esq., replied that she would look into the matter further.

Chair Walter made reference to Resolution R-52, Award of Bid received August 17, 2023 to Amchar Wholesale Inc., for the purchase of Glock firearms for Mercer County Prosecutor's Office for a one-time purchase. Chair Walter mentioned that the funding letter stated funds from the 2011 capital account were utilized. She requested clarification if funds from 2011 were actually used or if it was a typo.

In addition, Chair Walter also requested the balance of outstanding capital accounts to get a better understanding of the monies left.

County Administrator Nazzaro, Esq., replied that she would get that information.

The Board discussed at length the Ordinance establishing the Opioid Settlement Advisory Council, before placement on the Formal Agenda. Chair Walter questioned if a person's eligibility to serve on the council was dependent upon their employment status with the County of Mercer? In addition, she also questioned the time frame in which the advisory council must be formed to follow State law and disperse the funds.

Commissioner Stokes questioned if the County was in compliance with State law because the County had received funds and the advisory council had yet to be formed?

County Administrator Nazzaro Esq., responded that she would need to read into the State Statue more to have a better understanding of the time frame and the deadline to begin the dispersing of funds before being penalized by the State.

It was the will of the Board to hold the placement of this Ordinance on the Formal Agenda until they had an opportunity to read the Ordinance, State Statue, and ask questions.

OLD BUSINESS

The Board and Administration discussed in length Civil Service and its processes in connection with Communication C-3 from Lillian L. Nazzaro, Esq., County Administrator, dated October 6, 2023: RE: Designation of certain employment positions as Civil Service.

The Board's largest concern was placement of personnel into new civil service titles that were not previously budgeted for and the negative impact on next year's budget.

Chair Walter requested a copy of the communications with New Jersey Civil Service Commission in reference to these positions be provided to the Board.

NEW BUSINESS

Commissioner Stokes requested information on the set side programs. He requested a list of the distribution of awards by subgroup and their amounts. He would like year to date information and a running total from the inception of the program.

County Administrator Nazzaro, Esq., responded that she would provide that information upon completion

PUBLIC SECTION

Mr. Mike McKitish, a Robbinsville Township resident addressed the Board. He began by offering Chair Walter his deepest sympathies on the passing of her mother. He then went on to commend the Board for their "out of the box" thinking during the discussion of the possibility of out sourcing. He also mentioned his request for the forensic audit report. Chair Walter requested that the report be posted online since the report was complete.

Mrs. Barbara Hairstone, a Lawrenceville resident, addressed the Board to explain her growing concerns regarding the new traffic pattern located in Lawrence Township, on Princeton Pike. She felt the placement of the new stop sign would eventually cause an accident as was already causing a lot of traffic congestion. She was advised from her local Police Department to address her concerns with the Board.

The Board suggested that the Administration have Leslie Floyd, Director of Planning, reach out to Mrs. Hairstone to explain the plans for the new traffic pattern.

County Administrator Nazzaro and County Counsel concurred.

ADJOURNMENT

A motion to adjourn the Formal Meeting was offered by Commissioner Cimino and seconded by Commissioner Frisby, which was adopted by the unanimous vote of the members of the Mercer County Board of County Commissioners.
