# MERCER COUNTY BOARD OF COUNTY COMMISSIONERS INFORMAL MEETING OF SEPTEMBER 26, 2023 MINUTES

Chair Walter called the Formal Meeting to order at 6:03 P.M. on September 26, 2023 in Room 211 of the Joyce L. McDade Administration building, 640 South Broad Street, Trenton, New Jersey.

The following members of the Board answered the Roll Call of the Clerk to the Board:

Present – Commissioners Cimino, Frisby, Lewis, McLaughlin, Melker, Stokes, and Walter

Chair Walter led the Pledge of Allegiance and Salute to the Flag.

## SUNSHINE LAW

The Clerk to the Board announced that in accordance with the provision of the New Jersey Open Public Meeting Law, notice of this Formal Meeting had been mailed to The Trenton Times, The Trentonian and The Princeton Packet newspapers as well as having been posted in both the County Administration Building and Courthouse at lease forty-eight (48) hours in advance of the meeting.

## **COMMUNICATIONS**

Three (3) communications were discussed and approved for placement on the Agenda for the Formal Meeting of September 28, 2023.

## **RESOLUTIONS**

Forty-seven (47) proposed Resolutions were discussed and approved for placement on the Agenda for the Formal Meeting of September 28, 2023.

Chair Walter made reference to the following proposed Resolution, a Special Item of Revenue, The Notational Association of County and City Health Officials (NJACCHO) awards a Grant to the County of Mercer for the 2023 Enhancing Local Public Health Infrastructure Grant. Chair Walter asked the Administration why this Grant, received in April of this year, was not included into the budget.

Chair Walter made reference to the following proposed Resolution, a Special Item of Revenue, the State of New Jersey awards Mercer County a Grant for the 2018 HAVA Election Security Grant to establish an online Board Worker Training program. She mentioned the County did not have to fund that in the budget since the Grant was already awarded.

Ms. Jerlene H. Worthy, Clerk to the Board of County Commissioners, informed the Commissioner Board that the two following proposed Resolutions that were Tabled on previous meetings would be added to the Agenda for the Formal Meeting on Thursday, September 28, 2023:

1. MERCER COUNTY BOARD OF COUNTY COMMISSIONERS AUTHORIZES COMPETITIVE CONTRACTING FOR A CONSULTANT TO PROVIDE PUBLIC RELATIONS SERVICES TO PROMOTE TOURISM IN MERCER COUNTY. PERIOD: JANUARY 1, 2024 THROUGH DECEMBER 31, 2026

2. COUNTY EXECUTIVE AND CLERK TO THE BOARD AUTHORIZED TO EXECUTE A LEASE AGREEMENT BETWEEN THE COUNTY OF MERCER AND SIGNATURE FLIGHT SUPPORT, LLC, FOR THE LEASE OF APPROXIMATELY FIVE AND SIX/TENTH'S (5.6) ACRES AT THE TRENTON-MERCER FOR THE PURPOSE OF PERFORMING FIXED BASED OPERATIONS. Chair Walter asked the Administration if they were able to recoup money from companies that owed approximately \$39,000.00 on back taxes to Ewing Township.

Lillian L. Nazzaro, Esq., County Administrator, responded she would look into the matter.

Commissioner Frisby asked the Administration if the County were capable of providing flight school students with a discounted price on parking at the flight school.

Administrator Nazzaro responded she would find out and that she would have an answer for Thursday Formal Meeting.

Commissioner Frisby asked Chair Walter if the County would be able to identify awarded Grants that were not applied to the budget, and asked what would happen to those grant surpluses.

Chair Walter answered the surplus funds would supplement departments in need of it for their essential operations.

## **OLD BUSINESS**

Chair Walter shared that she attended the Hispanic Heritage Month celebration at the Mercer County Park. She explained that the purchase of a metal detector was a great decision because it was used for many events at the park.

Chair Walter informed the Commissioner Board that a full-time student that attended Mercer County Community College was deemed ineligible to receive a scholarship due to his final credits total not equaling the twelve credit requirement. The Chair asked if the Board would agree to amend the language for the scholarship to say, "full time" rather than based on the number of credits.

The Board unanimously agreed to waive the stipulation for that student and change the language.

Commissioner Cimino asked the Administration if Ewing Township were short of hired nurses.

Administrator Nazzaro answered that the County used a temp agency that supplied the nurses. She said the County had a shortage of Correction Officers working hospital duty as many officers are on FMLA. She insisted that the County cannot legally order Corrections Officers to come in while on leave. She said to alleviate that need the County continues to use Sheriff Officers and that they are paid out of County Correction's budget.

Chair Walter informed the Commissioner Board that she had been approached by constituents inquiring about open nursing positions with the County. She mentioned she directed them to the county's website, after further follow up she realized there were no postings.

Administrator Nazzaro said she would follow up with Human Resources.

## **ADJOURNMENT**
