

**THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF MERCER,  
NEW JERSEY DOES ORDAIN AS FOLLOWS:**

- 1. The annual salary of the County Executive, County Administrator,  
Human Services Director, Transportation & Infrastructure,  
Mercer County Clerk, Mercer County Sheriff, Mercer County  
Surrogate, shall be established in accordance  
with the following schedule:**
