- **Take this to the ICX - Ballot Marking Device** and hand the Voting Authority to the Board Worker.

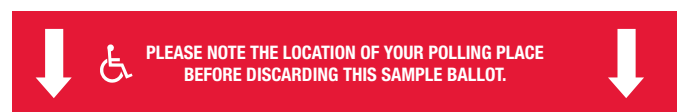

<p><b>2</b></p>  <p>Voter instructions appear, select <b>'Go to Ballot'</b>.</p>	<p><b>6</b></p>  <p>Select <b>'Print your ballot'</b> to print your completed ballot, <b>WAIT FOR THE GREEN CHECKMARK</b>, next take your ballot, to the ICP - Scanner.</p>
<p><b>3</b></p>  <p><b>Touch the screen</b> to select your choices. To vote for any person whose name is not printed on this ballot, fill in the oval by the words "Write-In". Insert the name of the person for which you wish to vote on the blank line.</p>	<p><b>7</b></p>  <p><b>At the ICP - Scanner</b>, feed the ballot into the tabulator entry slot.</p>

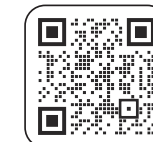

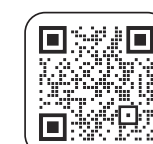


2024 Primary Mercer County Early Voting Locations
