- Take this to the ICP - Ballot Marking Device and hand the Voting Authority to the Board Worker.

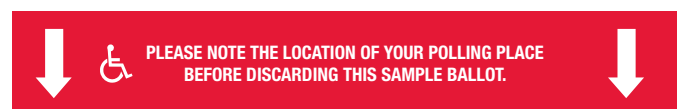

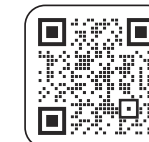

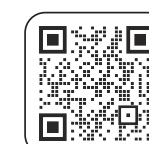
