### Welcome from the County Clerk

As we move into a very busy Fall at the Mercer County Clerk's Office, where we will prepare for the General Election administration along with Mercer County's two other election offices, it seems appropriate to remind constituents of some of the many other services offered by the Mercer County Clerk's Office.

Seeing a rise nationwide on property fraud, our office prioritized efforts this summer to crack down on property fraud in Mercer County. I currently serve on a Property Fraud task force with City of Trenton Mayor Reed Gusciora and other officials, the Mercer County Prosecutor, members of the NJ Assembly and the Mercer County Consumer Fraud Division. This task force works together to address fraudulent activity taking place by squatters and other bad agents who engage in property-related money-making schemes against property owners and renters throughout Mercer County. One of the tools in our arsenal is the property fraud alert system offered by my office.

As the County's property registrar, my office offers a Property Fraud Alert Service in order to notify property owners with free email alerts when someone tries to record a lien or take any action on a local property. We offer it in conjunction with our land recording computer system, Catalis, so that an email is triggered whenever an action is recorded on a property. This alert is free to use, but you must sign-up with your current email address. Please call the County Clerk's Office to sign up and register your property, and receive alerts immediately.

We also provide a property alert hotline for those in need of help if they feel they have been victimized by such a property scheme. This number is 609-989-6466. A Supervisor from our office will provide you with law enforcement information, or mortgage resources available from HUD certified agencies.

Additionally, our office offers a Property Information Portal, where Mercer County properties can be viewed via GIS satellite. Any bona fide real estate professional can sign up to use this system and obtain information on the same property address from the County Clerk's Office, the Mercer County Tax Office and the Planning Office in a coordinated effort. Basically, this unique property tool saves on research time and it is easy to use. This website is PIP.Mercercounty.org It is free to search for qualified users, and we encourage you to sign up if you work in the real-estate field.

#### **2024 General Election**

The Mercer County Clerk's Office is integral in conducting the Presidential Election, where we anticipate issuing over 44,000 vote by mail ballots for the upcoming general election in November to those currently signed-up on our permanent list of applicants. In fact, we anticipate mailing out even more ballots to residents and higher voter participation in 2024, with candidates running for offices ranging from U.S. President, U.S. Senate, County and municipal government, school board, and fire commissioner.

#### 3 Ways to Vote in Mercer County

#### VOTE-BY-MAIL

Registered voters can apply for a vote-bymail ballot by following the instructions found at VOTE.NJ.GOV or by contacting the County Clerk.

#### IN-PERSON EARLY VOTING

In-person you can vote on a voting machine at any early voting location. Early voting will be open Saturday, October 26 through Sunday, November 3. Hours will be Wednesday-Saturday, 10:00 a.m.-8:00 p.m. and Sunday, 10:00 a.m.-6:00 p.m.

#### AT YOUR POLLING PLACE ON ELECTION DAY

Vote in person at your polling place, from 6:00 a.m. to 8:00 p.m. on Election Day, November 5. Your polling locations will be listed on your sample ballot.



### Mercer County Clerk Shares Online Passport Renewal Information

Mercer County Clerk Paula Sollami Covello is pleased to inform constituents that the U.S. Department of State has launched a public website tool for updated Online Passport Renewal (OPR). This innovative tool is designed to streamline the passport renewal process, making it more efficient and convenient for U.S citizens.

The online passport renewal tool aims to save time and effort, providing a user-friendly platform for renewing passports from the comfort of homes. The U.S department of State created this process to enhance the everyday lives of Americans, offering significant benefits to working families and travelers by giving them more time back in their busy schedules.

"We are excited about this new development from the U.S. Department of State," said Mercer County Clerk Paula Sollami Covello. "The updated Online Passport Renewal tool is a step forward in our mission to make essential services more accessible and convenient for everyone. I encourage all eligible Mercer County residents to take advantage of this new tool and experience the ease of renewing their passports online."

Online Passport Renewal is set to accept new applications at 1:00 pm Eastern Standard Time each day. Eligible individuals must first create an account to renew passports online here: the public's one account for government. | Login.gov, applicants will be able to apply online until the daily office threshold is met.

To be eligible to renew a passport online, an applicant must meet the following criteria:

- Have a recent 10-year passport and be age 25 or older
- Possess a U.S passport issued between 2009 and 2015, whether expired or valid.
- No change to name, gender, date of birth, or place of birth.
- No travel internationally for at least eight weeks after applying. (Note: Processing times are the same as for mail-in renewals.)
- Request routine service only (expedited service not available online).
- Apply for a regular (tourist) passport (special issuance passports are not eligible).
- Reside in the U.S. or its territories (not eligible if living abroad or with an APO/FPO address).
- Possess an undamaged passport (not reported lost or stolen). Applicants can pay the passport application fees using a credit/debit card; current fees are found here: <u>Fees (state.gov)</u>

The Mercer County Clerk's Office continues to offer passport renewals services at both of its offices in Trenton on South Broad Street, and Hamilton Township at the Mercer County Connection. The online service is simply an additional option for those who wish to take advantage of this opportunity.

The County Clerk is dedicated to providing efficient, courteous, and professional services to the residents of Mercer County. ### **US Real ID Requirements**

Mercer County Clerk Paula Sollami Covello would like to inform Mercer residents that starting May 7, 2025, if you plan to use a driver's license as proof of identity at airport security or to enter certain federal buildings and facilities, it must be the new, more secure Real ID license. A standard driver's license or non-driver identification card can still be used to drive in New Jersey, but it will no longer be considered a valid form of federal identification. Real ID can only be obtained at the DMV, *the Clerk's Office does not offer this service*.

It must be noted, there is no requirement to get a Real ID license. Standard, non-Real ID licenses will still be issued at the DMV. Passport books and passport cards will also remain as valid proof of identification for international travel and are Real ID-compliant for domestic flights.

Real ID complies with federal standards that impose stronger requirements to prove US residency. Real ID is a more secure, federally mandated document that will be accepted at airports as identification and to enter federal buildings. The intent of Real ID is to ultimately reduce identity theft and fraud, and enhance the nation's security.

"Don't wait until 2025 to apply for a passport or to obtain a Real ID from the DMV. The time to do this is now to avoid the expected rush and backlog of appointments," said Clerk Sollami Covello.

## Mercer County Clerk Announces Foreclosure Resources and Information

Mercer County Clerk Paula Sollami Covello is dedicated to supporting residents through challenging times, particularly those facing foreclosure. In light of the growing concerns surrounding foreclosures, the County Clerk is pleased to provide some valuable resources and information to empower individuals and families within our community.

The Mercer County Clerk's office is the official record keeper of all Notices of Lis Pendens. A Notice of Lis Pendens is the document that is recorded before property goes into the foreclosure process. When this notice is received at the Mercer County Clerk's office, a letter is immediately sent to the owner of that property notifying them that their house will be going into foreclosure to give the resident an opportunity to take steps save their property.

#### For Those Currently in Foreclosure:

We recommend you contact the Office of the Courts Foreclosure Mediation Hotline at 888-989-5277 or visit Foreclosure Self-Help | NJ Courts. This program offers access to housing counselors and trained mediators to assist in resolving foreclosure actions and establishing affordable mortgage arrangements. Explore Federal and State Mortgage Modification Programs, which are available at no cost for information and assistance.

#### For Those Not Yet in Foreclosure:

If you're currently struggling to make mortgage payments, contact your mortgage servicer immediately to discuss your situation and explore available options. Seek assistance from a HUD-certified housing counseling agency in your county. Act promptly; early intervention provides more options for resolution. #### Beware of Foreclosure Rescue Scams:

Assistance for foreclosure-related issues should not come with a fee. Be cautious of organizations or individuals requesting payment for housing counseling or loan modifications. Avoid signing over property deeds without direct involvement from your mortgage company, and only submit mortgage payments directly to your mortgage company, unless otherwise instructed. The Clerk's Office offers a hot line where you can call us for referral to law enforcement, if you believe you have been victimized at 609-989-6466.

#### Reporting Mortgage-Related Fraud:

Victims of mortgage-related fraud are encouraged to report incidents to the NJ Division of Consumer Affairs by calling the toll-free hotline at 1-800-242-5846 or visiting New Jersey Division of Consumer Affairs (njconsumeraffairs.gov). Legal Services of New Jersey also offers representation at no cost to low-income homeowners who have been misled or taken advantage of by lenders.

# **County Clerk Advises Residents on Home Title Scam, Property Alert**

Mercer County Clerk Paula Sollami Covello reminds County residents about home title theft that can occur when someone forges the deed to your property so that the title is no longer listed under your name. This kind of theft usually coincides with identity fraud. Con artists often use a falsified or stolen identity to hide their involvement in the theft. Then, they create a fake document that transfers ownership of the property to their own name instead of the name of the valid owner. Some property owners are much more likely to fall victim to deed theft such as seniors, individuals with second homes, or identity-theft victims.

To ensure that one's property is protected, Sollami Covello reminds residents to register for the County Clerk's Property Alert Service to provide property owners with important alerts concerning their properties. The Property Alert Service is completely free and alerts Mercer County property owners when the Mercer County Clerk's Office records a document affecting a specific property. Residents can sign up for the alert system by clicking here and registering for more assistance please call the County Clerk's Recording Department at 609-989-6466.

It should be noted that the Property Alert Service does not prevent fraudulent activity from occurring; it helps monitor activity and transactions on properties. Anyone who suspects fraudulent activity should contact local law enforcement authorities.

# County Clerk Offers Free Photo ID Cards For Veterans During Upcoming Holidays

Mercer County Clerk Paula Sollami Covello reminds Mercer County residents that Veteran ID cards are free at the County Clerk's Office in honor of the following holidays:

#### VETERANS DAY- 11/4/24 to 11/15/24

#### PEARL HARBOR REMEMBERANCE DAY - 12/2/24 to 12/13/24

ID cards that indicate a Veteran's status have become very useful as many stores and home improvement retailers offer discounts to veterans. Veterans can receive their photo ID card by visiting the Mercer County Clerk's Office located on the 2nd Floor of the Old Courthouse at 209 South Broad Street in Trenton. The Clerk's ID department is open Monday to Friday from 8:30 a.m. to 4:30 p.m.

#### Requirements for a Mercer County ID card:

- Must be a Mercer County resident for at least 6 months.
  - Must produce the following:
- A valid birth certificate with a raised seal or a naturalization certificate.
- A valid NJ Motor Vehicle License or voter registration card or, lease agreement..
- Voting Profile, which can be obtained at the County Clerk's Election Office located on the 2nd floor as well.

In order to have US military veteran status designated on the ID card, veterans must also produce or register their DD-214 honorable discharge papers with the County Clerk's Office.

#### **RECORDING OF DD-214**

A Certificate of Release - Discharge from Active Duty, or DD-214 Form for short, is generally issued when a service member is honorably discharged from active military duty. The document contains information normally needed to verify military service for benefits, retirement, employment, and membership in veterans' organizations. Additionally, Mercer County Veterans can record their DD-214 Form free of charge at the Clerk's office.

"Because military papers can get damaged or lost, veterans should take advantage of the opportunity to file copies of their DD-214 discharge papers with the Clerk's Office," said Sollami Covello, whose office maintains and preserves official documents and records for Mercer County. "If a copy of discharge papers is needed in the future, a veteran, an immediate family member, or a legally recognized representative of their estate may obtain a copy with proper identification." noted Sollami Covello.

### Notary Night Schedule

Mercer County Clerk Paula Sollami Covello has announced the monthly Notary Night schedule for 2024. Notary Nights will continue to be held on the first Thursday of each month, from 3:00pm to 7:30pm. Notary Nights are held at the Mercer County Connection satellite office in Hamilton. The remaining dates for 2024 are as follows:

September 5th October 3rd

November 7th December 5th

To be sworn in by Mercer County Clerk's Office staff as a new notary, prospective notaries must apply and have their applications signed by a legislator. If you file your application online it will be sent to your legislator electronically. After the State of New Jersey processes your application, you will be sent your commission by mail. You must take your oath of office. The fee is \$15; checks and money order are accepted. Prospective notaries will also need a photo ID and their certificate on hand to be sworn in.
