AMEND RESOLUTION TO MODIFY SALARIES AND 2024 SALARY GUIDE (AMENDMENT NO.1)

WHEREAS, the County of Mercer entered into a Contract with CWA 1036 (Assistant Prosecutors) for a six-year period of January 1, 2019 through December 31, 2024, as per Resolution No. 2022-656, adopted September 27, 2022; and,

WHEREAS, an Amendment (Amendment No. 1) to said Resolution is now required to amend the language in Article 28, Section 1; and,

WHEREAS, an Amendment No. 1 to said Resolution has been ratified by the Union; now, therefore,

- 1. On July 21, 2024 the salary guide for all AP's and Senior AP titles shall be increased by \$10,000 to the base salary in effect for each step and position in the guide as of July 21, 2024. All AP's and Senior AP's shall be placed at the higher salaries effective July 21, 2024. Salary adjustments for the July 21, 2024 increase shall be implemented no later than October 5, 2024.
- 2. The salary step for unit employees hired in 2022 and 2023 whose current salary is below that of employees hired in 2024 at Step 2 --shall be increased as follows:
 - a. AP hired in CY 2023 at Step 1 moves to Step 2 retroactive to January 1, 2024;
 - b. AP hired in CY 2022 with a Clerkship or year of experience prior to hiring moves to Step 2 retroactive to January 1, 2024, and 12 months thereafter to Step 3.
