# Notice of Grant Opportunity (NGO) - Virgen Velez

- Replaces WLL (Workforce Learning Link) funding
- Few people interested in literacy skills and a few, not many for ESL
- For the Adult Literacy Innovations Initiative, the WDB's are the ones eligible to apply for \$500,000 max for 23 months. They expect to start November 1<sup>st</sup> thru September 30, 2026.
- The Purpose is to provide adult, digital, & family literacy; building partnerships, provide the skills, training & work experience to assist individuals obtain/retain employment.
- We have a short window for Proposals, that are due: September 30 at 3:00 p.m.
- Everything that is in the WLL will be removed by the State and will have to be included in the NGO.
