Approved: The original project was approved through application #16-800 for nine (9) one-story buildings totaling 62,873(sf). The amended application proposes to, (a) remove two (2) recreational vehicle storage type buildings and replace with traditional storage units type buildings. (b) add a 2nd story to building 'B' which will increase the total square footage of the building by 10,800 (sf) without changing the original building footprint. The total square footage of the amended site for the same nine (9) buildings is 76,268 (sf).
